There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

- 3. On 08/01/23 at 7:24p.m., Milwaukee Police were dispatched to an Armed Robbery at 1400 E. Brady. Investigation revealed a suspect entered the store and took items without paying, then fled. A security guard followed the suspect outside where an altercation occurred before the subject got into a vehicle and fled. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 4. On 03/15/24 at 10:30a.m., Milwaukee Police were conducting a License Premise Check at 1400 E. Brady. While on scene officers were advised a subject was detained by an employee for placing items in a backpack and intentionally concealing them. The subject agreed to return the items, however, was arrested for retail theft and advised they could not return to the store.
- 5. On 04/07/24 at 2:40a.m. Milwaukee Police were dispatched to an Armed Robbery at 1400 E. Brady. Investigation revealed a subject entered the store and became disorderly. When security asked the subject to leave, the suspect produced a knife and stated "nobody gone touch me". A customer gave the suspect \$5 and they fled the scene. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

LICENSED PREMISE REPORT

This report is written by PO Jeremy KENNER, assigned to District One, Late Power Shift. On Tuesday, August 1st, 2023, I was assigned to Squad 1431 with PO Kara PLACZEK. PO KENNER and I were dressed in our full Milwaukee Police Department issued uniforms with our nameplates and badges affixed to our outermost garments. PO PLACZEK and I were wearing our Milwaukee Police Department issued Body Worn Cameras (BWC) at the time of this investigation. At approximately 9:13 PM, Squad 1431 was dispatched to an Armed Robbery complaint at the address of 1400 E. Brady St., which is the Walgreens.

Upon arrival, I spoke with the manager, Shanice M. WARREN (b/f, 02-12-1992). WARREN stated she in the back of the store when the incident occurred, WARREN stated she did not observe the incident.

WARREN showed me the surveillance footage. I observed a subject, a b/f, medium complexion, thin build, with black hair in a ponytail, and wearing a black t-shirt, black shorts, pink Crocs, and a light blue baseball cap. The subject entered the store at approximately 9:00 PM. At approximately 9:04 PM, the subject was walking towards the exit and appeared to be holding multiple items in their hands. The subject then proceeded to run out the sliding doors while the security guard, Antonio T. JORDAN (b/m, 10-21-1969), chased after her. I then observed the subject and security guard get into an altercation in front of the store. There were no cameras that faced outside in front of the main entrance. The surveillance footage was uploaded to evidence.com.

I then spoke to a cashier, Brandon TERRES-SANCHEZ (w/m, 03-15-2001), TERRES-SANCHEZ stated he was working at Register 3 during the time of the incident. TERRES-SANCHEZ stated he did not know anyone was stealing until he observed JORDAN chasing after a b/f, approximately 5'6, wearing all black and a hat. TERRES-SANCHEZ stated it appeared the b/f was holding multiple Plan Bs, the pink Take Actions, and some other things. TERRES-SANCHEZ stated he then observed the b/f and JORDAN get into an altercation outside the store. TERRES-SANCHEZ stated he did not go outside and did not observe what happened after the altercation. TERRES-SANCHEZ stated he was not able to observe any vehicle outside because it was out of view.

I spoke to a worker, Yaneysha M. DIAZ (b/f, 02-24-2001). DIAZ stated she was in the back of the store when the incident started. DIAZ stated she heard someone come over the radio about JORDAN getting into an altercation. DIAZ stated she ran up front and by that time, the subject had already left. DIAZ stated JORDAN was yelling for someone to call the police. DIAZ stated she did not observe any vehicle driving away. JORDAN stated the items that the subject was attempting to take was multiple Plan Bs, the pink Take Actions, and some other things. DIAZ stated the items that the subject dropped during the altercation were behind the cash register.

I then spoke to security at Nomad to obtain surveillance footage. Preston F. BLANEY (w/m, 10-13-1994) supplied officers with surveillance footage of the incident. In the footage I observed a black minivan, unknown make or model, parked facing westbound on E. Brady St. in front of Walgreens. I then observed an altercation between JORDAN and the b/f in front of Walgreens. I then observed the b/f get into the black minivan. The black minivan then fled westbound on E. Brady St. The surveillance footage was uploaded to evidence.com.

All of the Walgreens' staff was cooperative during the investigation of this incident,

This report was written by P.O. ROBERT MATHEUS assigned to District 1, Day Shift.

On Friday, March 15th, 2024, at 10:30 AM, at Walgreens, located at 1400 East Brady Street, I, P.O. MATHEUS, was conducting a business check when Walgreens employee ALEXANDRA G. FRIEDLAND, W/F, 11-05-1997, and Walgreens employee PAULARA M. DAVIS, B/F, 12-28-1990, approached NICK JOSEPH JOHNSON, W/M, 08-05-2005, regarding merchandise that he had concealed in his backpack. JOHNSON told FRIEDLAND and DAVIS that he was willing to return the merchandise that he had taken. I heard FRIEDLAND state that she had had observed JOHNSON put merchandise inside his backpack. I activated my body camera and took JOHNSON into custody for Retail Theft, Intentionally Concealing Merchandise, JOHNSON'S backpack contained three bottles of Listerine and two containers of Pre-work out supplement powder for a total value of \$97.06. JOHNSON did not have any money or other means to pay for the merchandise that he concealed in his backpack. JOHNSON was conveyed to Central Booking by Squad 1132, P.O. JORDAN EMMONS.

Interview of ALEXANDRA G. FRIEDLAND

Linterviewed Walgreens employee ALEXANDRA G. FRIEDLAND, W/F, 11-05-1997 and FRIEDLAND stated that she observed JOHNSON in the store and that she recognized JOHNSON from last Friday (March 8th, 2024) when she observed him in the store and suspected him of taking merchandise. FRIEDLAND stated that today (March 15th, 2024) she observed JOHNSON take two containers of Pre-work Out Enhancement Supplement off of the shelf. FRIEDLAND stated that JOHNSON went to the paper aisle were she momentarily lost sight of JOHNSON. FRIEDLAND stated that when she gained a line of sight to JOHNSON, she did not see the supplements he had picked up. FRIEDLAND stated that she did observe

JOHNSON place a bottle in his backpack and then zip up the backpack. FRIEDLAND stated that JOHNSON took a water from the cooler, walked to the front of the store and then back to the cooler where he returned the bottle of water. FRIEDLAND and PAULARA M. DAVIS then confronted JOHNSON regarding the concealed merchandise.

FRIEDLAND gave me a receipt for the merchandise that was taken, and I placed the receipt on Milwaukee Police Department Inventory 24007499.

Interview of PAULARA M. DAVIS

I interviewed Walgreens employee PAULARA M. DAVIS, B/F, 12-28-1990 who stated that FRIEDLAND had informed her that JOHNSON had merchandise in his backpack. DAVIS stated that she also told JOHNSON that he cannot come into Walgreens in the future. DAVIS stated that JOHNSON did not have permission to take and conceal merchandise and that Walgreens is willing to prosecute.

Follow-up

The concealment of the merchandise by JOHNSON was not recorded by the video surveillance system since the cameras do not cover the location where JOHNSON took and concealed the merchandise.

JOHNSON was booked at Central Booking and questioned regarding the Retail Theft. JOHNSON was released with a future order in date at the District Attorney's Office on Wednesday, March 20th, 2024, at 8:30 AM.

Upon arrival I observed Walgreens security guard identified as Willie COLEMAN (b/m, 08-06-91), standing by the door, the unknown suspect was no longer on scene. The store manager identified as Noel MPOZENZI (B/M, 12-25-87) was also at the front of the store.

Interview with security, COLEMAN

I spoke to COLEMAN who stated he observed the suspect come into the store and has seen him many times before. COLEMAN stated the suspect became disorderly and was asked to leave. COLEMAN stated the suspect began to knock store items around the store. COLEMAN stated he continued to try and get the suspect to leave the store. COLEMAN stated the suspect pulled out a knife and stated, "Nobody gone touch me." COLEMAN stated he had his oun out but did not point it. COLEMAN stated an unknown customer gave the suspect \$5 then he left the store.

Interview with store manager MPOZENZI

MPOZENZI stated he called for police for a suspect with a weapon.

MPOZENZI stated the suspect is a regular customer. MPOZENZI stated a lot of times the suspect gets loud, and he asked him to leave the store. MPOZENZI stated he usually leaves the store without issue. MPOZENZI stated the suspect began to knock items around the store. MPOZENZI stated he tried to calm him down but did not succeed. MPOZENZI stated he

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 6/18/2024 at 11:00 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
