Dear Council Members:

On August 10, 2006, by Common Council File No. 060162, the Common Council authorized the City Attorney to request proposals for the collection contract for City receivables. The current contract expires on December 31, 2006.

The City Attorney's office advertised for proposals in three newspapers, twice in each, and arranged for an e-notify message that reached over 500 contacts.

We received a large number of inquiries and requests for the RFP. Six firms submitted proposals, most of which met the basic requirements of the RFP. Five years ago, when the contract was last advertised, there were four proposals, but only one met the RFP's requirements.

A team of evaluators – including representatives of this office, the Treasurer's office, the Department of Neighborhood Services, the Department of Public Works, and the Purchasing Director – reviewed all the proposals and conducted oral interviews with each proposer. The highest ranked proposer is the Kohn Law Firm based on: fees; expertise; experience; the extent to which the proposer can accommodate the City's methodology, need for access to information and EBE capabilities; and service delivery capabilities.
