Dear Council Members:

Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.

Claimant, Randy Paszkiewicz, 5366 South 9th Street, Milwaukee, WI 53221, alleges on his own behalf, that sometime on July 30, 2007 and August 6, 2007, the Support Services repair facility located at 2142 West Canal Street was burglarized causing the loss of his personal tools and equipment. He claims damages in the amount of \$11,015.14.

Our investigation reveals that it is a requirement that this employee furnish his own tools and equipment which are necessary for the performance of his duties for the City and, therefore, the City agrees to reimburse the employee for his loss.

The City has paid similar claims like this one, including one to this employee, in the recent past. For this reason we are recommending added conditions to this payment and emphasis will be added to these conditions. The conditions will be as follows:

- 1. The employee will provide the City Attorney's Office with a receipt or other suitable proof of purchase for each tool purchased within 60 days of receiving the settlement check from our office.
- 2. The Department of Public Works will also compare the receipts or other suitable proofs of purchase of the replacement tools bought by the employee with what is in the employee's work area.
- 3. If the cost of the tools is less than the settlement check from the City, the employee must reimburse the difference to the City.
