#### To Whom It May Concern:

I'm writing this letter to appeal the decision that was made regarding my claim #1029-2023-503.

Earlier this year (February 28, 2023), I struck a large pothole near North 21st -North 24th Street and W. Fond Du Lac Ave. My vehicle was damaged due to the incident. My vehicle was taken Lexus of Milwaukee to replace my tire and repair my alignment. I was instructed by them about the underlying damages that the pothole caused. I explained to them that I was going to get another quote from Lexus of New Orleans once I made it back home. I reached out to the City of Milwaukee on March 1, 2023, and was instructed to print an instruction form to file my claim.

On March 10, 2023, I went to the dealership for my vehicle, Lexus of New Orleans, to inspect the damages.

I followed the instructions for filing a claim against the City of Milwaukee.

After filing the claim, I never received a response. After one month passed, I followed up requesting an update regarding my claim. I was informed by Ms. Gloria Ware that my claim was passed over to the City Attorney. I then asked for a number for the City Attorney and was given a number to contact Ms. Michelle Thompson Gray, who was titled as an Investigator Adjuster.

I reached out to Ms. Thompson-Gray three times but received no response. I spoke to Ms. Shy, the representative who answered my phone call and she then transferred the call to Ms. Thompson-Gray's voicemail. After multiple times of Ms. Thompson-Gray not responding to my messages, I asked to speak to her supervisor.

Ms. Thompson-Gray then finally contacted me about my concerns at the end of April. She explained to me that my claim was still under review and she will contact me as soon as she receives an update.

I contacted Ms. Thompson-Gray May 18, 2023, and she requested that I send photos of the pothole. On that same day, May 18, 2023, I sent the photos of the pothole. After that, I didn't hear from Ms. Thompson-Gray again until the beginning of July. She reached out to me about my claim stating that it was finally moving along and that I should know something in a few weeks.

On August 16, 2023, I received a call from Ms. Michelle Thompson-Gray stating that the City of Milwaukee denied my claim due to no one reporting a pothole between the dates of December 28, 2022-February 28, 2023.

I reported the incident on March 1, 2023, and filed my claim on March 10, 2023, after receiving the damages report from Lexus of New Orleans on March 8,2023.

On March 30, 2023, The Department of Public Works reported they were notified of a hazard on this segment and repairs were completed on April 5, 2023.

Ms. Thompson-Gray stated to me that The Infrastructure Services Division did not have knowledge of a hazard in the roadway on this segment. How is that possible when I have documentation of me filing a claim March 10, 2023? If indeed that was the situation, that the pothole wasn't reported until March 30, 2023, why did it take her until the evening of August 16, 2023, to notify me about this?

I am asking the City of Milwaukee to please pay for the damages that I incurred to my vehicle due to pothole in the road.

Dear Mr. LeBlanc:

We are in receipt of your claim regarding damages sustained to your vehicle on February 28, 2023, when you struck a pothole at or near, North 21st - 24th Street and W. Fond Du Lac Avenue.

Based on 2011 Wisconsin Act 132, Wisconsin municipalities are immune from liability for any damage that occurs on or after April 5, 2012 due to a defect in a sidewalk or street.

Our investigation revealed that the Infrastructure Services Division searched call center records between the 2100-2400 blocks of West Fond Du Lac Avenue, from December 28, 2022 through February 28, 2023, and there were no calls received regarding this segment. On March 30, 2023, the Department of Public Works reported they were notified of a hazard on this segment and repairs were completed on April 5, 2023.

The Infrastructure Services Division did not have knowledge of a hazard in the roadway on this segment. Accordingly, we cannot accept liability for your damages, and we are denying your claim.



To file a claim against the City a claimant must comply with Section 893.80(1), Wis. Stats., a copy of which is printed at the bottom of this instruction sheet. Generally the statute requires the claimant to submit to the City Clerk:

- A document stating the circumstances of the claim which must be signed by the claimant, or his/her agent or attorney. This document should be filed within 120 days of the event.
- A document stating the address of the claimant and a statement of the relief sought. If money damages are sought, a specific sum must be stated.

(The above information may be combined in a single document.)

The following information should also be submitted to allow the City to promptly act on your claim:

- 1. Proof of the amount of the claim by means of either itemized receipts or two itemized estimates.
- A phone number where the claimant can be reached during business hours as well as the claimant's e-mail address, if any.
- 3. As detailed a description of the incident as possible, including the date, time and place.

#### ADDITIONAL INFORMATION

Before you can file a lawsuit against the City of Milwaukee for reimbursement, State law requires that you first follow the claim procedures established by the City Clerk.

Filing a claim against the City does not automatically guarantee reimbursement from the City. However, the City examines each claim on an individual basis in determining if reimbursement is legally required.

In order to obtain reimbursement for a claim against the City, you must prove that the City or its employees acted unlawfully or negligently.

Only the City Attorney or the Common Council and the Mayor can authorize payment of a claim against the City. Any other representations made by City employees are not legally binding on the City.

893.80 Claims against governmental bodies or officers, agents or employees; notice of injury; limitation of damages and suits. (1) Except as provided in subs. (1g), (1m), (1p) and (8), no action may be brought or maintained against any volunteer fire company organized under ch. 213, political corporation, governmental subdivision or agency thereof nor against any officer, official, agent or employee of the corporation, subdivision or agency for acts done in their official capacity or in the course of their agency or employment upon a claim or cause of action unless:

- (a) Within 120 days after the happening of the event giving rise to the claim, written notice of the circumstances of the claim signed by the party, agent or attorney is served on the volunteer fire company, political corporation, governmental subdivision or agency and on the officer, official, agent or employee under s. 801.11. Failure to give the requisite notice shall not bar action on the claim if the fire company, corporation, subdivision or agency had actual notice of the claim and the claimant shows to the satisfaction of the court that the delay or failure to give the requisite notice has not been prejudicial to the defendant fire company, corporation, subdivision or agency or to the defendant officer, official, agent or employee; and
- (b) A claim containing the address of the claimant and an itemized statement of the relief sought is presented to the appropriate clerk or person who performs the duties of a clerk or secretary for the defendant fire company, corporation, subdivision or agency and the claim is disallowed.

We are in receipt of your claim regarding damages sustained to your vehicle on February 28, 2023, when you struck a pothole at or near, North 21st - 24th Street and W. Fond Du Lac Avenue.

Based on 2011 Wisconsin Act 132, Wisconsin municipalities are immune from liability for any damage that occurs on or after April 5, 2012 due to a defect in a sidewalk or street.

Our investigation revealed that the Infrastructure Services Division searched call center records between the 2100-2400 blocks of West Fond Du Lac Avenue, from December 28, 2022 through February 28, 2023, and there were no calls received regarding this segment. On March 30, 2023, the Department of Public Works reported they were notified of a hazard on this segment and repairs were completed on April 5, 2023.

The Infrastructure Services Division did not have knowledge of a hazard in the roadway on this segment. Accordingly, we cannot accept liability for your damages, and we are denying your claim.
