On March 8, 2006, at around 10:00pm we noticed water coming up from our basement drain. Due to the excessive amount of water coming in we decided to call a Plummer. Once the Plummer from Tuffy's Sewer & Drain, LLC came out to the house, he attempted to try and snake out the sewer several times. With these attempts the water was still remaining to come up through our drain. With the help and recommendation of the Plummer we call the City of Milwaukee, Water Department. They stated the problem was the drain outside on 91st Street. Once the City came out and worked on the sewer drain outside on 91st Street, the water in our basement cleared up. Tuffy's Sewer & Drain, LLC charged me \$476.72. The description of the work that was done is written on the enclosed bill, the results of his job was listed as job not complete do to the fact that it was not our personal sewer drain and he could not stop the water from coming up through our basement.
