I, James G. Schneider, Professional Land Surveyor, do hereby certify:

THAT I have surveyed, divided and mapped the following parcel of land:

A Redivision of Lots 10, 11 & 12, Block 205, in "MURRAY'S ADDITION", being a part of the Southwest 1/4 of the Southwest 1/4 of Section 15, in Township 7 North, Range 22 East, in the City of Milwaukee, County of Milwaukee, State of Wisconsin, bounded and described as follows:

Commencing at the Southwest corner of said Southwest 1/4 Section; thence N88°51'30"E along the South line of said 1/4 Section, 365.71 feet to the southerly extension of the east right of way line of N. Cramer Street; thence N0°47'46"W along said east right of way line, 479.81 feet to the intersection of the east right of way line of N. Cramer Street and the north right of way of E.
