Dear Mr. Frederick:

We have received your claim in the amount of \$451.97, relating to damage sustained to your vehicle on May 3, 2005 when it was allegedly struck by a City sweeper at 2124 West Middlemass Street.

Our investigation reveals that the Fleet Division records indicate that the City sweeper, number 41001, was not in this area on May 3, 2005 the day of the alleged loss. The sweeper was in this area on May 10, 2005 and May 17, 2005. Since there is no evidence to support your belief that a City sweeper caused the damage, the City cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
