- a. The goal is to increase and improve influenza and pneumonia vaccination rates for adults 65 years of age and older in African American and Hispanic communities.
- b. The project will organize partnerships of public health professionals and medical providers to develop a community based plan.
- c. Groups will include for example: insurers, health plans, minority health organizations, churches, professional organizations, local community groups and civic leaders
- d. The program will conduct tracking & recall activities for adults age 65 years of age and older via telephone and/or mailings from patient lists at private provider offices, clinics, etc.

2. Relationship to City-wide Strategic Goals and Departmental Objectives:

- The objective of this project is to improve the health of adults within our community.

- a. In 2000, influenza vaccination coverage among adults age 65 years of age and older was 67% whites, 56% for Hispanics and 48% for African Americans.
- b. In 2000, pneumonia vaccination coverage among adults age 65 years of age and older was even wider, with 57% for whites, 30% for Hispanics and 31% for African Americans.

4. Results Measurement/Progress Report (Applies only to Programs):

- a. Plans for year 1 of this 2 year demonstration grant include: assessment of current local capacity to deliver increased vaccinations, participation in meetings and trainings and information sharing, community planning, development of partnerships, development of an action plan, production & distribution of materials.
