

Dear Sir or Madam:

Pro Rental Solution, LLC., alleges it sustained property damage from a broken sewer lateral that occurred after recent installation of a light pole at 5127 N. Hopkins Street. Pro Rental Solution, LLC., submitted a damage claim in the amount of \$11,900, for sewer lateral repairs, sanitation/cleanup, and hot water tank.

Our investigation reveals that Infrastructure Services Division reported that on April 2, 2023, they responded to a backwater call at the subject location. The main sewer was checked and found to be in good working condition and the homeowner was advised to contact a licensed plumber.


On April 3, 2023, the claimant hired ABC Sewer and Ramon Sewer to conduct a complete inspection and a collapsed sewer was discovered as result of a recently installed light pole. Further investigation revealed that the light pole was installed on March 8, 2023, because of a motor vehicle accident. Electrical Services confirmed a light pole was installed directly above the claimant's sewer lateral and caused damage. The light pole was removed and a new light pole was reinstalled two feet from its original position.

Accordingly, we recommend that the claim be approved for payment for \$11,900.
