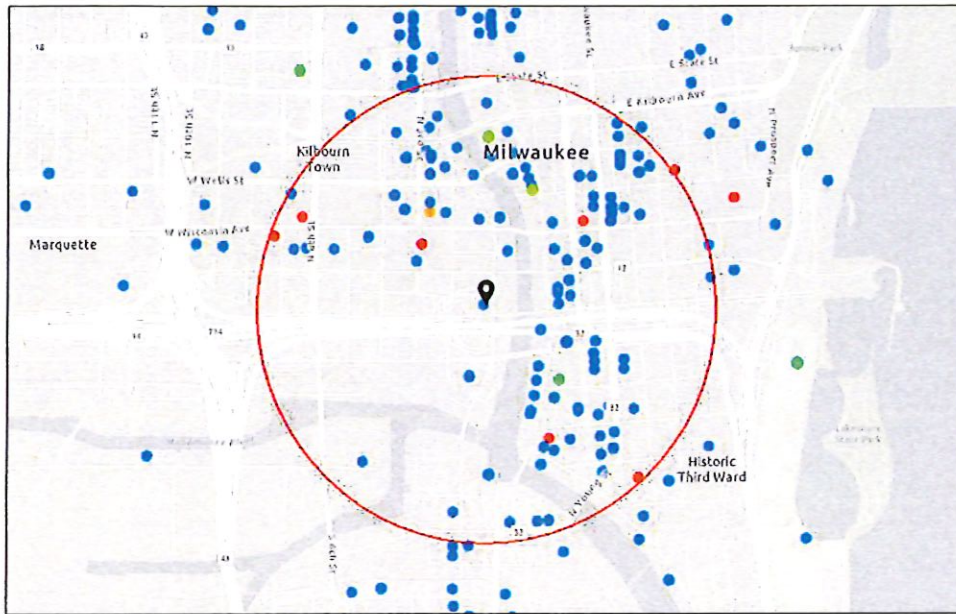


# Concentration Map for 503 N Plankinton Ave

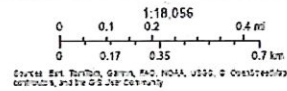
