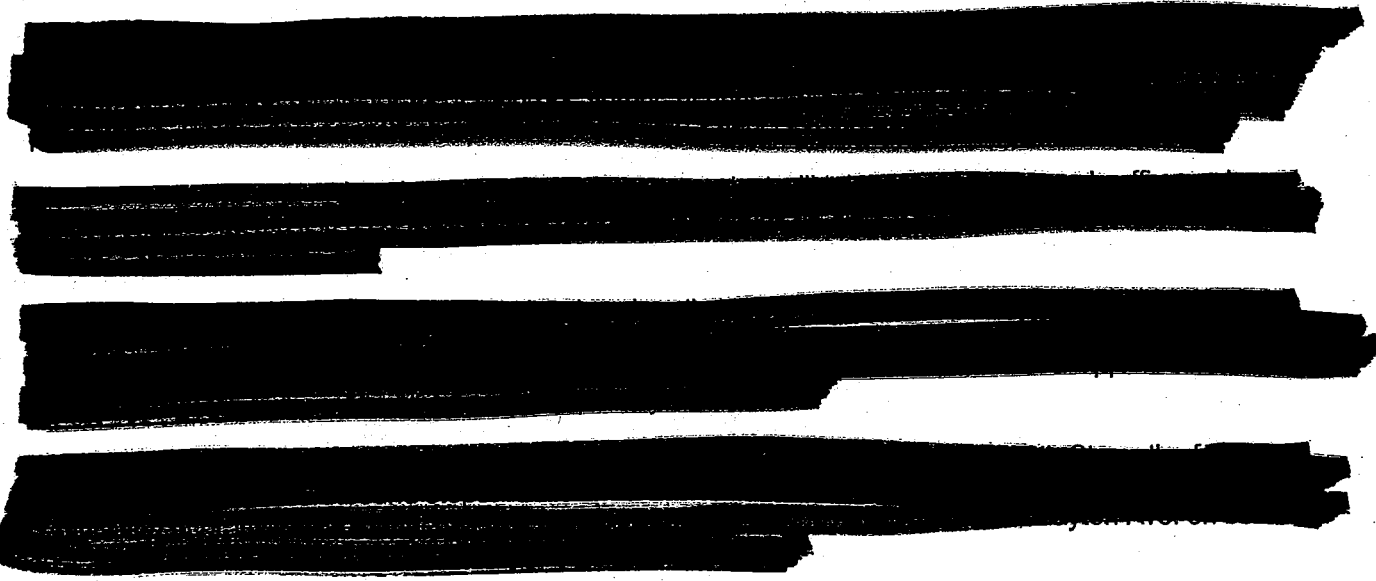

Alderman Pawlinski:

I'm afraid I will not be able to attend the license hearing tonight regarding Deniro's on Howell avenue. but as I live directly behind the bar, I wanted to let you know some of the issues and concerns I, and many of the other neighbors, have.

When my family and I bought our house a little over a year ago, we had concerns about being behind a bar. But we talked to people and drove by the place a couple of times and everything seemed pretty calm. It was a little corner bar with a few bowling lanes. After moving in, the only problem we had was the occasional dumping of bottles from the bar into the Dumpster late at night. A friendly reminder to Mike usually was enough until one of his crew forgot again. Overall it was okay. When he changed formats and took out the bowling alleys, we were actually excited for him. He seemed to be wanting an upscale swing joint and steak house. The initial clientele were a decent class of people; as the crowds increased so did the parking on the streets, but that was not really a problem as the folks going to and from the bar were well behaved. We supported Mike, signing his petition to have an outdoor beer garden (conditional upon the fact there was to be no music outside, which he agreed), and signed a petition for him to have a block party, which never materialized. Aside from a few problems with delivery trucks blocking our drive, (of which your office and the Mayor's office helped a great deal-thank you) we still were okay with everything.

Recently though, there seems to have been a change, a decline in the quality of the establishment. The bands now playing there are attracting a different crowd-loud and rowdy. Every Saturday and Sunday Morning I can count on finding in my yard at least 3-4 empty bottles and/or cans of beer, numerous plastic cups, and countless cigarette butts and packages, and other miscellaneous garbage. Also, to date, I've found in my yard wine glasses, cocktail glasses, a shirt and a bra. Also we've had my children's pumpkins stolen, our doorbell rang at 2 a.m., people loitering (loudly) outside our window at all hours, and numerous fights, as well as screeching tires and honking horns at bar time. I blame this on a lot on his choice of entertainment. I've seen the flyers littering my yard; he's got female Jell-O wrestling, male dancers, and bands such as the Love Monkeys (while I do enjoy that group, they are on the rowdy side-attracting a younger, rowdier male audience). When we've seen Mike, we've asked him about the bottles and cans; he claims they're from people bringing their own in the car and drinking before they go it. He claims he has people watching the doors and nobody gets out with glasses, bottles, etc. I took it with a grain of salt. But this is why you've seen an increase in complaints in the past few months, because of such changes.

Beyond that, the place is becoming more of a shambles: the increased crowds mean increased garbage and dumpsters, which happen to butt up against my drive way. There is garbage all over: the lids are not closed, broken glass all over the ally, old signs and other junk just laying out there. I fear the smell come summer. His beer garden areas has tables and chairs haphazardly piled all over-okay, people don't have to be neat freaks, but in addition to that he's got an old grill, a tarpless tent, a bunch of crumpled up banners jammed here and there-makes it look like a junk yard. All the landscaping he initially did is also falling to the wayside. There's litter all over the place, in the plants and shrubs and lawn. It is so bad I have seen people who collect aluminum cans for cash stop by to glean his yard on Saturday morning. The place, while still presentable, is quickly becoming a shambles.

Lastly, an aspect not under Deniro's control: police response. A couple of months ago a car with no muffler was park outside my bedroom window. At bartime some drunk came out, started the car and then left it. After running for 20 minutes, and waking me and my family up, we called the police. We told them what was going on, and that I had gone out to look but could not tell if anyone was in the car. They said they'd send somebody when they could. We waited 10more minutes, and called again. Same reply. After another 15 minutes are so we were rudely told that the police had too many fights, stabbings, and other serious matters to spare time looking at some running car. By this time the drunk appeared and drove off. Much of what goes on cannot be called in because it happens too quickly: screeching ✓

Dear Alderman Pawlinski:

I just wanted to send you a note keeping you updated on some of the things that happened over the Holidays at Dinero's restaurant on Howell and Plainfield:

**Garbage cans and dumpsters left uncovered:** As my house is right behind the alley where all the garbage is, I ended up picking a lot of it out of my yard. Additionally, when they've been emptying the hundreds of beer bottles into the recycle bins (an act they did at 7 a.m. on a Sunday several weeks ago--amazing how loud that is!) they've been missing--resulting in bottles and broken glass in my yard.

**Cars blocking my driveway.** Three times over the holidays I had cars parked that obstructed my drive. I called the police twice, but both times the cars were gone by the time the police dispatched anyone--so I called back to let them know they didn't have to come out. My faith in the police and parking matters is greatly diminished as we had a car parked in front of our house for over a week--it never moved--just stayed in the same spot. Earlier this week--Tuesday I finally called the 2nd district and reported it. My big concern was with the snow it would get plowed in, or the street would not get properly cleared. Sure enough, half the street is covered with snow because the plow had to go around the parked car. It sat there for 2 and a half days after I called--no police showed up. I could understand the first day, with the snow and all, if they didn't show, but nothing for 2 days! And we are to call them for Dinero's patrons that are there for a few hours?

**Patrons' Behavior.** As my ten year old son and I were pulling into our driveway around 10 p.m. one night, we were treated to the sight of three females leaving Dinero's and taking a detour to urinate behind the dumpsters. I quickly ushered my son to the house and came back out to get some packages. The giggling trio ran to a car parked in the street and took off. I didn't even bother to trouble the Police with that. Additionally we had a few isolated incidents of late night noise. But just a side note, we did not put garland with lights along our fence that runs along Plainfield Avenue, because last year we had problems with Dinero Patrons unscrewing the bulbs and smashing them on the sidewalk.

**Trash.** I have to admit the new policy of having Dinero's personnel out at band nights, directing traffic away from the neighborhood has had some impact. The amount of cars around my house has not decreased, nor has the trash. But I have noticed while walking to Sentry on Howell that the vacant Milwaukee Journal building next door, one of the "designated parking spots," has had a great increase in garbage--empty Corona bottles seem especially abundant. At least when they dumped in my and my neighbors' yards, we picked it up. It doesn't look as if anyone is doing it at that building.

Alderman, this is a continuing nuisance to our neighborhood. If Dinero's liquor license is not revoked, their Cabaret license, or whatever it is that allows them to have live bands, should be taken away. The building was a six lane bowling alley, that attracted at most 100 people on it's busiest nights in the past. The area cannot handle crowds of 300 to 400 people! And rumor has it the owner is looking at increasing his occupancy by remodeling some basement areas. It is out of hand as it is.

Seeing you at the town hall meetings and such I know you are a good

and competent Alderman with a bright and promising career. You've taken impressive stances with Lutz's and other establishments. We don't want to deny Mike a livelihood -- and he's taken some steps, but it's not enough. He pays you lip service and we continue to have the same problems--please help!

To the Committee:

Due to the short notice of the hearing, many of us in the neighborhood will be unable to attend. In lieu of a personal appearance I would ask that this e-mail be read to the committee.

When my family and I bought our house at 4178 South 1st Street, right behind Dinero's, we had concerns about being so close to a bar. We checked it out, asked around, even visited the establishment and found it to be a small 6 lane bowling alley with a bar and restaurant. When they wanted to remodel, we initially supported them, wanting a healthy business along Howell Avenue. We even signed a petition to allow an outside patio. They started off as an upscale "swing club" and steak house. Though traffic increased it was still manageable. But soon after the troubles began.

Dinero's switched their format. Soon we saw fliers advertising young "club" bands and such events as Women's wrestling and male dancers. The clientele changed, Dinero's began targeting younger and more disruptive crowds to the point where their current radio ads advertise Dinero's as being "The place where the Party Animals run wild." For the last year we dread the approaching weekends when bands play at Dinero's.

Every weekend we must endure music so loud we can hear it through the walls. Large amounts of cars parked along the streets, often blocking our driveway and the fire hydrant across the street. Crowds filing past our house at all hours—yelling and making noise. They've climbed the trees in our house, stolen my children's pumpkins at Halloween, broken outside Christmas Lights, tried to steal a Christmas decoration I'd secured to a fence (breaking the fence in the process) and ringing our doorbell after bar time. There are fights nearly every weekend. Most are short-lived so I don't even bother calling the police. Also, we have to pick up large amounts of litter from our yard every weekend. Beer bottles, cups, and various other trash, including a bra. Dinero's has told us it's people drinking before they enter the bar, but we've found wine and plastic glasses, along with beer bottles of the brands Dinero's serves, in our yard. I have also seen people leaving Dinero's with such items in their hands.

Further disruptive behavior includes urinating on our lawn and trees—I've seen both men and women doing that. In fact several weekends ago I came home with my 11 year old son at 10pm and we saw 3 women leaving Dinero's, walk to the behind the dumpsters in the alley separating my house from Dinero's, and they proceeded to urinate. Our Alderman has told us to call the Police, but such behavior is quick and the Police cannot respond in time, or they have higher priorities. One night a car with no muffler was parked in front of our house and was running for over 30 minutes at 2 am. It woke my entire family up. We tried calling Dinero's but they do not have a direct line, all we could get is a recording. We called the Police several times, but they had other calls they needed to resolve. Every weekend we have problems the

disrupt the lives of my wife, my children and me. We attribute this to the clientele of Dinero's, the very type they seek to attract, and the Failure of Dinero's to supervise and control the activities of their clients as they leave their establishment.

Beyond the activities of the patrons, we have had other problems with Dinero's. Their employees will not park in their lot, instead they park next to Dinero's on the north side of Plainfield Avenue during the day. As delivery trucks come they must pull ahead to make their deliveries. They often block our drive and the entire street. My wife has been unable to leave for work and to pick up my daughter from school several times due to this. My son's school bus has not been able to get through the street on several occasions. Additionally, Dinero's clean up crew will empty large containers of empty bottles into bins in the alley at all hours. Sometimes after closing, other times at 7 am on Sundays—the noise from hundreds of glass bottles wakes even the soundest sleeper and scares the hell out of my kids. They also do not keep their garbage and dumpsters secured. There has been open barrels of uncovered grease or some substance sitting in the alley for weeks on end. They often do not cover their garbage—last summer we could not sit in our back yard because of the odor of beer and the amount of flies. When the garbage gets picked up, it often flies out and ends up in my yard. My children have cut themselves on shards of glass from empty beer bottles from Dinero's that have ended up in my yard. They are not good neighbors.

While Dinero's has tried to placate the neighborhood recently with their parking patrols, it has done no good. I have seen patrons laugh and curse at the patrols when they try to direct them to park away, and there is nobody out at closing time to keep an eye of what's going on. The bottom line is that Dinero's is not in an environment that can handle the large crowds it attracts—there is not adequate parking nor adequate security. And while Dinero's cannot be held responsible for the acts of their patrons once they leave their establishment, they can be held responsible for the type of clientele they actively attract—and they can be held responsible for allowing them to leave the premises in violation of City ordinances.

Help us return our neighborhood to the way it should be. Deny the renewal of Dinero's Liquor license, or deny his ability to have entertainment or severely decrease his occupancy level. There are hard working families that have to suffer nightmares every weekend due to this place—help us stop that.

Mike:

Regarding the letter you sent on recently, I just wanted to take a minute to respond. To save time I thought I'd copy Alderman Pawlinski.

I think your drive to improve your establishment and get your cabaret license back can best be summarized by your actions last week. On Thursday, March 8th at 3:00 a.m. my wife and I were awoken by a driving bass beat. I looked out the window to see the guy that does your Wednesday night Karaoke loading his van. His stereo was so loud it woke us up from a sound sleep. Lights went on across the street, indicating others had been woken up as well. All the time you were right there by his side. That is typical of your disregard for our neighborhood.

In your meeting last year, we neighbors said we'd give you chance to prove yourself. We agreed to keep an open mind until the hearing. As far as the neighborhood "block" party I don't know whom you talked to—because it wasn't a block party and the neighborhood wasn't there. That was an annual birthday party held by two houses on the corner of 1st and Plainfield...most of the neighbors were not there. Regardless, at your meeting we did offer you a chance. But instead of proving yourself...things have gotten worse in many respects.

Every weekend I have trash in my yard; beer bottles, liquor bottles, cups, cigarette butts, cigarette lighters and wrappers, and more. One neighbor reported a bong in your parking lot. I hung lights up along my fence this Christmas season after not doing it last year. Yet your patrons felt it okay to take my bulbs and smash them on the sidewalk. You've, or your employees, emptied beer bottles into the dumpsters late at night (though I will give you credit, very infrequently). You've had Lazer 103 and their giant boom-box blaring outside your establishment late at night. The crowds still yell, scream and fight at closing time (though it has been less frequent. But I attribute that to the cold and snow, and not to the "security" you have—they've only been in place the past few weeks).

Much of the problem is with your patrons, and I realize you cannot control them once they leave your establishment. But you can control the type of patron you attract, how many of them, and your actions regarding them. You now have to hang warning signs on your doors telling your patrons they can't wear long coats, hats or colors. Rookie's doesn't have that. The Blue Chipper doesn't have that. Packy's doesn't have that. I don't know of any other establishment on Howell Avenue with such a sign. These types come in response to your "Daddio's where anything goes" ads. Yes, Daddio's, your new name and according to your letter last fall, your attempt at bringing good family entertainment back to the neighborhood. How does family entertainment fit into your 10,000 watts of bass, or whatever ridiculous number you advertise? Bass so loud it shakes the house at times (Please, turn it down! You don't need that much bass!) All you care about it making a fast buck.

If you truly did care about the neighborhood, you'd have taken steps to improve way back when you had bands. You realized the neighbors were upset. You saw how often the Police were called to your establishment. You heard the complaints at Alderman Pawlinski's town hall meetings. Yet you did nothing but hire some kids to try to get cars to park away from houses (which never did work). You never offered to speak to the neighbors until after you lost your license. You never cut back the number of bands. You never changed your format away from the club bands and the young rowdies they bring in.

Now you've hired another security firm? You promised to do that after the meeting last year, yet they've only recently started. These crack security specialists park kitty-corner from my house. They never get out of the car. Last weekend the car that was parked in front of them left a Heineken bottle in the street. Also last weekend were three plastic drink cups from your establishment on the curb in front of your place. Trash that stayed there until Saturday afternoon when I picked it up. Something I've never seen you do.

Mike, we wish you would have kept is a bowling alley. Then we wished you would have kept it a steak and swing joint, but you didn't have the patience, or the personality, to develop the quality and reputation one needs to have a high-class establishment. Instead you went for the quick easy money...you created a dive and the neighborhood is paying for it.

Lastly, Alderman Pawlinski is doing a fine job contrary to what you say in your letter. It was him that got you into that establishment. It was him that held town hall meetings trying to work things out. He wants viable businesses on Howell as much as he wants decent neighborhoods and has worked hard to accommodate both. He has been responsive. If there is anyone who has not been responsive, it's been you. You're the one who lost your cabaret license, and if the neighborhood has their way, you'll lose your liquor license as well.

So we will see you at the hearing. We will have people who really do live close to your establishment, not the people you bring in that live a mile away. We will have specific incidents and dates. We will have Police Reports. What we will not have is live music back at your establishment.

He knows and I know that if there is any problem with the neighbors that night...he's done. PERIOD!

Would you rather have come down to City Hall, taken a day off of work, gone through a 2 hour public hearing and risked the possibility that the rest of my committee agreed to give him a live music permit for 365 days a year? I cannot control my committee and the rest of the Common Council. I am only one of 17. His lawyer could have made a good case to the other members of this body.

As it stands now, because I stood up for you and the rest of the neighbors, they dropped their request and are taking their chances on those 10 permits. Those 10 permit requests are the right of every bar owner in this city. You won Craig. Mike withdrew his request specifically because I and the neighborhood stuck together.

I guess I'm disappointed that after everything we have been through, you would think that I don't have the very best interest of you, and your neighbors in mind. I owe Mike nothing. And he knows he is at my whim on these temporary licenses. -Jeff

Jeff:

Just wanted to touch base with you regarding Daddio's hosting the Eddie Butts Band on Saturday, April 21st.

I have to admit, Mike pulled out all the stops--a large event staff and several uniform security guards were on hand--and very visible. They did an outstanding job of keeping people parking on Plainfield, unfortunately several of them decided to park onto 1st street, but more about that in a bit.

First, I just had to let you know the effort, and results produced by Mike were impressive, but still not enough for me to say that it was acceptable. Nor would it be enough for me to be okay with any further bands to play at Daddio's. The basic reason is that despite the large presences of security, the crowds still spill over into the residential area. Specific examples from Saturday night include:

11:50 Group of women yelling back and forth as they exited from Daddio's and walked to their cars in the lot.

12:05 A group of 4 Harleys (3 with chopped, or no, mufflers) went to park in front of our house. They sat revving their engines for close to 5 minutes as the Event Staff talked to them about parking elsewhere. When they finally left, they revved their engines loud enough to wake my children.

12:15 Two cars pulled up in front of our house. As they stopped they threw garbage onto my lawn and begin yelling back and forth from car to car. The Event Staff finally got them to move, but all they did was pull around to 1st street. The 2 Men and 2 Women then walked around my house, yelling all the way.

1:10 A group stood outside house-yelling to others in Parking Lot. Security Staff stood by smoking on the corner of 1st and Plainfield. They never approached them This went on for a good 5 minutes.

1:25 The 2 Men and 2 Women (Same group from 12:15) came out. The two guys came out running, one yelling "You Fucker" to another. Event staff and what appeared to be a bouncer promptly responded, and got them to settle down, then left. But then the group sat on their car hoods which were parked on 1st Street for next 10 to 15 minutes. One had what appeared to be a pint bottle--was glass and squarish in shape--and they were passing it. They were swaying, and were doubtful to drive. Event Staff approached a second time and they piled into one car and left.

1:45 A group of guys pulled into Daddio's lot, as they horsed around on their way in, they set off a car alarm. The alarms went off for over 2 minutes. Added bad timing, a motorcycle with no muffler parked in front of Daddio's left at same time. Again, children woken up.

2:35 Car alarm gets set off again. Again running for two minutes and waking people up.

3:00 Closing went relatively smoother--one small group yelling back and forth as they left. They stood by Daddio's Parking lot for awhile, talking loudly, but Security was there keeping an eye on them. So closing was a bright spot.

3:30 I had stayed up as I was actually working, and my concentration broken when I heard yelling on 1st Street. The 2 Men and 2 Women from 12:15 and 1:25 were back. Evidently they came back to get the one car they'd left. One guy was almost mauling one of the women--trying to take off her clothes--and she was so drunk she almost let him. The other guy decided to relieve himself during this by urinating in the street. Eventually, the one girl convinced the other to get in the car and go. The mauler, obviously heartbroken, was yelling something after them as they drove away. Then he and his buddy got in their car and squealed off into the night.

Also, as we saw Mike setting up his Event Staff with a Video camera before the big show, I borrowed his idea and had mine ready as well to verify the above. I can't vouch for the image quality due to darkness, but I'm pretty sure the loudness will come out.

Overall, the night was not nearly as bad as some others. In fact the worse garbage problem was all the cigarette butts thrown onto my lawn by the security guards as they stood around. And I have to applaud Mike on his efforts. But it was still unacceptable--my family couldn't sleep and that is a benchmark that should not be allowed to be broken. Additionally, I cannot envision Mike keeping up this level of security for events. He has shown himself to be primarily concerned with the money and not to follow through with promises with the neighborhood (examples: promising to post signs that never up, claiming his change to "Daddio's" was an effort to bring family entertainment to the neighborhood--when he actually expanded his target market to the young rowdy crowd, and more.)

I am doubtful you will get many others letting you know what they think. Two of the neighbors across the street were gone for the weekend, and the third across the street do not like to make waves. So, with my limited voice, all I can do is to ask that you do not allow further bands at Daddio's. It was better, but not by much.

This last weekend was one of the worst regarding Daddio's. Both Friday and Saturday nights my family and I were woken up numerous times with closing time being the worst.

Friday night had a drunken group taking turns on small motorcycles/motorbikes racing up and down Plainfield Avenue. Saturday night had a group of 4 drunks males yelling and arguing with several drunk females. It got to the point I called the police because the males began to threaten the females. Fortunately the women left before anything happened. The males stuck around and drank beers around their cars--the police never showed.

Add to this the urination I saw on a neighbor's lawn and the large amount of trash I picked up both Saturday and Sunday mornings--8 beer cans, 4 plastic cups that patrons brought out of Daddio's and other assorted garbage.

I bring this all up for two reasons:

1. Over the past month there has been no private security that Mike has had in the past--this had made a difference in the past but he's discontinued it--most likely because it was eating into his profit. But it highlights the fact he is not committed to working with the neighborhood. This is the third time he's said he'd do things to improve with the neighborhood, takes one or two token steps, and then stops. Please remember this next time he asks for a permit for a live band. He continues to fail to execute his promises.

2. Can you please contact the 6th Police Precinct and ask for patrols around bar time? I know there are Police Shortages, especially on the south side, and that bartime is extremely busy, but some Police presence, or at least a timely response, would help. It would not only help with the noise, but if things continue the way they are, there will be an incident happening soon--an assault, drunken driving, an accident, etc. I also suspect drug dealing as there is an increase of cars driving through the street around bartime and pedestrian's stopping them to stick their heads in. I don't see anything going on, but with the crowd that comes out of Daddio's it would not surprise me.

It had been tolerable over the past few months. But he is now showing his true colors again and letting things go downhill. Help this neighborhood--make sure he doesn't escalate the pain by bringing in any bands again. And please ask the Police to show more of a presence.

Alderman Pawlinski:

This all seems a bit ironic. But if you remember at the neighborhood meeting, somebody expressed concern about Mike building a motorcycle parking area in the front of his building--basically a concrete extension of the sidewalk. You told us that he'd have to have a permit for such use, and that he had not filed a request for such a permit.

Last night as I came home from work around 9:30 p.m., I saw motorcycles parked in that area. There was also a FM106 radio van parked on the street right in front of the bus stop...in violation of the NO PARKING sign. Several months ago when Mike had a FM103 radio van, the Police told us Mike needed a permit to have such a van (but the FM103 van had music blaring out of it, the FM106 van last night did not have any music coming from it).

So we called the 2nd District to let them know what was going on. They told us to call the Parking Police. We asked about the issue of the permits--for the motorcycles and for the radio van--and they told us that it was a parking matter and to call that department. We called the Parking Police and they told us that they could investigate the radio van being illegally parked in the Bus Stop, but not the motorcycles. They told us they couldn't look into whether there were proper permits. A call back to the second district had the officer telling us it was a parking matter and not under their control.

So we took some pictures and let it in the hands of the Parking Police. We're not sure of the final outcome.

Could you help us out regarding who we need to contract regarding the motorcycle parking issue?

Thanks for all your help with all of this. The neighborhood really appreciates it.

Alderman Pawlinski:

Just a quick e-mail to put some matters on the record.

Tonight Daddio's people had a video camera out, likely in response to the neighborhood's taping effort. I have no problem with that, and in fact think it's great as their tapes can back up ours. But in one instance they are crossing over the line of privacy, and bordering on harassment and intimidation.

Shortly after 10:00 p.m., a car and a truck were going to park in front of our house. Daddio's security came up and told them they couldn't park there, that they should go across the street. The truck did a Y turn and left, the car went up to the corner, turned around and zoomed down Plainfield at a high rate of speed. Add to the fact the car didn't have a muffler, and it woke my kids up. So I called the Police, the dispatch number, and reported a car at high speeds, perhaps as high as 50, now as I've calmed, it was probably closer to 35-40 mph, but well over 25, and very noisy to boot. So they dispatched a squad.

When the Squad arrived, they came to my door. As I talked to the Officer, I noticed a Daddio's Employee with their video camera in the intersection of the streets filming my conversation with the officer. Now if they want to film the general environment, the patrons, the street, that's fine—but targeting specific people is not right. Even then I really could have cared less, but some things in the past, coupled with this act, have made me uneasy.

Last fall at a neighborhood meeting Mike held at his place, he mentioned he'd hired a private detective to find out who filed an underage drinking complaint. In a letter to me last fall in response to an e-mail of mine, he made specific reference to the fact he knew many powerful people, including the CEO of GE Medical Systems, my employer. After Mike lost his cabaret license we had a red paint ball shot at our door, and neighbor who'd testified at the hearing had her car scratched up.

I do not expect anything to be done, there are no explicit threats here. But I wanted somebody like you to know, and for it to be on the record in the unlikely event there are any incidents after any future hearings—regardless of the outcomes.

I'd also like to add a comment about the Police in the Second District and their responses. Lately they've been terrific, showing up more on calls, and patrolling the streets. But the Officer who responded to the call tonight, had a real attitude. Officer Romalund rang my doorbell sometime after 10:30 and asked about the complaint. I explained the car had already left, and apologized for calling, knowing that the offending car would be gone before police responded, but we were told to call in everything to ensure it was recorded. She proceeded to tell me how she didn't see any skid marks on the road, and that she'd been around for about 10 minutes and hadn't seen a thing. I told her the car turned around in the intersection and picked up speed that way, not from a dead stop where marks would be left. She then asked if we were trying to shut down Daddio's and I said yes, we were planning on filing for a hearing, that this had been going on for 3 years. She huffed and said she'd stick around a bit longer, but it looked pretty dead around here.

Perhaps I didn't make myself clear on my call, that a response wasn't

needed, and I still feel like I'm bothering the Police when I make such calls. When I call in a public urination complaint, or a loud radio, and see they'll be gone even before I'm dialing the phone, I try to make it a point to tell the dispatcher that no response is needed. As it is, we're calling in probably only a third of the things we could--and who knows how much stuff we're missing. A large part is that we don't want to burden the police further.

So if you get a chance, please let the Captain of the 2nd district, and his staff, know we're not trying to be a bother, we're just trying to document everything as we were told. And let them know how much we've appreciated all they've done and are continuing to do.

Sorry to have rambled so much, thank you as well for all of your help, the neighborhood really appreciates it.

About 45 minutes ago I called the Police: I was awoken by several patrons yelling as they left Daddio's--they were carrying drinks in plastic cups from the bar which they threw onto my lawn. Now that I'm up, I've seen 3 people urinating on my lawn, two of which I've got some video of.

When I called Non-emergency Dispatch, I was told a squad would be dispatched. I told them it would be of little use, as the people left--but they told me that no report would be filed unless a squad responded. As it's near bar time, I doubt they will respond--so does that mean no report? We were told to call into to dispatch, and that log would be recorded to bolster our case. Does this mean the call I made last night about the 3 guys I watched smoking pot in their car for half an hour will go unrecorded? Or the complaint I made about Daddio's music being so loud last night it woke us up?

Could you please get a us definitive answer. We've actually almost stopped calling in because it seems the Police are sick of us, and rarely respond. And we understand there are a lot of higher priority calls, but we felt at least there was documentation to help us down the road.

Thanks for any help with this, and for all the help so far.

Dear Jeff/Sara:

Enclosed you will find another letter from Mike De Sautel in his on-going efforts to continually lobby the entire neighborhood regarding his band license. I see that Mike is now going to offer rides to the hearing, what a novel idea. My understanding in talking to neighbors who have lived in the neighborhood for many years, is that the Blue Jay Lanes was a rather sedate, quiet business, contrary to Mike's picture.

It is my understanding that his contracting with the private security company is a very recent occurrence. Security is one car with a security guard parked on the corner of 1<sup>st</sup> and Plainfield on Friday and Saturday evenings. Actually, I didn't see the service on Saturday, March 10<sup>th</sup>. Again, there has been no security service until very recently. This appears to be typical of Mike's past behavior in that just prior to asking for a hearing he institutes some minor neighborhood efforts in order to increase his credibility.

In regards to the issue of picking up litter (or maybe that's a liter as he states in his letter) which Mike feels is such a grand gesture, I have personally never observed him picking up litter with the exception of within 20 feet of his front entrance to Daddios. His parking lot in the past has typically had broken bottles, litter, etc, and I recall that frequently he has not bothered to shovel the walk adjoining his parking lot. At least one call was placed to your office requesting that he be notified of city regulations regarding property owners and the shoveling of public walks.

I do not plan on attending Mike's "open door neighborhood meeting", as I am not supportive of his license being returned for live music. He continues to lobby, lobby, lobby. I also don't plan on accepting his ride "to and from" the hearing, I am confident he will pack the license hearing with patrons. Do these people live directly in the neighborhood, within 2 blocks, not likely?

Each Saturday night, starting about 9:00 p.m., cars race up and down 1<sup>st</sup> St, 1<sup>st</sup> Place, W. Plainfield Ave, looking for the nearest parking space. The noise and trash that is generated in a typically quiet neighborhood is deplorable. Patrons of the bar are typically disrespectful of the tax paying neighbors of Dinero's Bar. Often patrons of Dinero's Bar are seen urinating, vomiting in neighborhood yards. They also bring drinks out of the bar in bottles, cans, and plastic cups which are typically found strewn up and down the streets they park on as well as the yards of the neighborhood. The noise at closing of bartime is intolerable, as patrons will fight, yell and scream on their inebriated way to their vehicles. They set off car alarms, along with squealing tires, honking their horns etc.

As the owner of Dinero's Bar (EDWARD A VAHRADIAN of the City of South Milwaukee per city of Milwaukee tax records) so eloquently stated in his meeting with Alderman Pawlinski and concerned neighbors in the Fall of 1998, "I pay \$10,000 dollars in property taxes". In reality, Mr. Vahradian's tax bill for 1998 reflects that he paid \$6,020.00 in property taxes. As a nearby homeowner, I paid \$3,800 in property taxes and I do not believe that entitles me to alter the quality of life in my neighborhood. I believe as a homeowner and taxpayer, that I also have a right to a decent, quiet neighborhood.

Since our meeting in the Fall of 1998 with the owner of Dinero's Bar and Alderman Pawlinski there has been no change. The neighborhood continues to bear the brunt of his profit making from Dinero's Bar without regard to the neighborhood. Alcohol continues to come out the front door in the form of plastic cups, bottles, cans that are strewn over the yards and streets. Noise continues to be a major problem at 2:00 a.m., along with cars speeding up and down the streets looking for the best parking spot.
