Dear Council Members:

Attorney Monique Lopez, of Alexander Shunnarah Trial Attorneys, allege that on March 20, 2023 their client sustained injuries as a result of a collision with a Milwaukee Police Department(MPD) squad while he was traveling at/near North 27th Street and West Medford Avenue. They have submitted a demand for \$250,000.00.

Our investigation into the matter reveals that the MPD squad noted above was engaged in assisting another squad in vehicle pursuit traveling northbound on North 27TH Street with lights and sirens activated. Because their pursuit turned into a foot pursuit, the officers slowed the squad to approximately 5 MPH, turning the sirens off but keeping the lights activated. While still operating in emergency mode they attempted to turn left to go westbound when your client failed to yield the right of way and collided with the MPD squad.

It is our view that your client is the at fault driver in this case. Accordingly, the City cannot accept liability and we recommend that this claim be denied.
