Dear Council Members:

Returned herewith is a document filed by Attorney Laurie A. Eggert for attorney's fees for representing Police Officers Staci Steen and Claude Osburn. The claim is in the amount of \$418.00 for 3.80 hours of service billed at the rate of \$110 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. A criminal investigation was initiated against the police officers on whose behalf this claim was filed, but they were ultimately not charged.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Wis. Stat. § 895.35, *Bablitch and Bablitch v. Lincoln County*, 82 Wis. 2d 574 (1978).

On January 28, 2004, City of Milwaukee Police Officers Staci Steen and Claude Osbourn undertook to arrest Burrell C. Biando, as Mr. Biando sat in his vehicle in a parking lot at 2701 W. National Avenue, City of Milwaukee, for a shooting in which Mr. Biando had earlier been involved. Before the officers were able to take him into custody, Mr. Biando withdrew a firearm from a right pocket and discharged a bullet into his own head.

The conduct of the officers involved was at all times professional.

In <u>State v. Burrell C. Biando</u>, 2004CF000573, Mr. Biando was convicted of First Degree Reckless Injury for the initial shooting for which officers Steen and Osbourn were attempting to arrest him when Biando shot himself.
