Mr. Duncan testified in objection due to a high concentration of alcohol establishments in the area, high crime between the 3800 through 4000 block of Vliet Street, illegal electrical connection at the store, illegal repairs done without the proper licensed contractors, property being placarded on two occasions, and work stoppage at the store due to the building being placarded.

Ms. Mueller testified in objection due to the lack of improvements and progress made at the store regarding its exterior condition despite recent repairs.

Mr. Painbaker testified that he agrees with the testimonies of Mr. Duncan and Ms. Mueller.

Mr. Melendez testified that improvements were not all fulfilled from an agreement made between Mr. Singh and Washington Park Partners, signage was not properly done, and windows are not large enough according to a city facade grant program guideline and expectations from WPP. He added that repairs, such as siding, was done just very recently.

Ald. Michael Murphy, aldermanic district 10, appeared in opposition. He testified that he represents the area west of the store. Constituents have communicated to his office concerns over the the exterior condition, exterior appearance, public drunkenness, public urination, litter, broken bottles, and trash at the store.

Officer Melissa Jones, Milwaukee Police Department, appeared and testified to personal observance of code violations at the store recently. In addition, there is continuing police investigation regarding untaxed tobacco sales and tobacco not being bought from the proper dealers.

Atty. Bobot said that Mr. Singh intends to lengthen the store windows.

Mr. Stanley, on behalf of Ald. Hines, was present in opposition due to the number of code violations and unwanted police presence at the store. He added objections also are due to the looks of the building and how the store is being ran.

Atty. Stephens said that the committee should not consider the code violations, police testimony regarding the tobacco investigation, and testimony that is not firsthand testimony.
