INITIAL OBSERVATIONS AND SCENE DESCRIPTION:

I did not observe anyone on scene causing problems at the location. I observed customers come in and purchase Items and the business was running as usual.

Upon my/our arrival I spoke with the caller, SP SINGH (A/M 12/20/1992), who stated he observed an unidentified B/M who parked his black, Chevrolet SUV at one of the pumps. SINGH stated he called because the unidentified subject was being loud with him and created a disturbance at the location. SINGH stated the subject had left the location and wanted a restraining order against the subject. I informed SINGH to call back if the subject returns so officers can identify him if he is still on scene when officers arrive and make contact.

I did not reviewed video surveillance footage. I viewed a digital photograph of the subject (B/M) dark complexion, medium length black hair, wearing a black, white and tan sweater.

While on scene, I observed the licenses posted and they were up to date. I did not observe any violations while I was on scene.

The subject appeared to be a B/M, brown-complexion, full black beard, wearing a black/blue cap, floral-colored hooded sweatshirt, white/black North Face down coat, black jeans, and black/blue Adidas 350 shoes.

SINGH stated that he never observed an actual weapon, but the subject's hand was in his pocket and he did not know if the subject was armed or not.
