- Whereas, It is proposed that the east side of South Barclay Street and north of East Washington Street be vacated pursuant to the provisions of Section 62.73, Wisconsin Statutes; and
- Whereas, The Department of Public Works has been directed to prepare a coordinated report estimating all costs and benefit assessments that will be incurred with said vacation; and

5. [241702](#) Resolution authorizing City entry into Green Solutions Funding Agreements and Conservation Easements with MMSD and MPS for MPS properties, in the 6th, 7th, 11th, 12th, and 14th Aldermanic Districts.

Whereas, The City of Milwaukee is the owner of record of the following Milwaukee Public Schools (MPS) sites concerning which the MPS Board has the duty of care, control and management under Wis. Stat. 119.16 (1m) and (3)(b) and Wis. Stat. 119.60 (2):

- Riverwest School - 2765 North Fratney Street - G98005P166
- Whitman School - 4200 South 54th Street - G98005P167
- Samuel Clemens School - 3600 West Hope Avenue - G98005P168
- Humboldt Park School - 3230 South Adams Avenue - G98005P169
- Kagel School - 1210 West Mineral Street - G98005P170; and

Whereas, The Metropolitan Milwaukee Sewerage District (MMSD) has, in the past, provided grant funding to MPS to reimburse MPS for green infrastructure improvements to MPS school sites, including at some of the schools referenced above; and

Whereas, MMSD is willing to use additional funds available to it to reimburse MPS for additional green infrastructure improvements at these and additional MPS school sites as listed above; and

Whereas, Green infrastructure improvements through this funding source will help divert storm water from local sewerage systems; and

Whereas, MMSD requires MPS, and the City as the record title holder of the MPS sites: to enter into funding agreements for each parcel; and to enter, after the infrastructure has been installed at each of these school sites, a conservation easement for each parcel; and

Whereas, The Green Solutions Funding Agreements now needed for these particular MPS school sites have been submitted to this file; and

Whereas, The template conservation easement to be used post-installation, for each school site, will be in substantially the same form and substance as the template conservation easement that was approved by the Common Council in Resolution File No. 191139; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Green Solutions Funding Agreements that were submitted to this file are hereby approved, and City personnel, including the DPW Commissioner, are authorized: (i) to cause the City to enter those funding agreement documents in the same form, or in substantially

Sherman Boulevard to North 38th Street.

Whereas, Common Council File No 221219 authorized the City to enter into an agreement (PPII Funding Agreement M10005MI07) with the Milwaukee Metropolitan Sewerage District (MMSD) to accept and fund a PPII grant for a project in an area bounded by West Capitol Drive to West Concordia Avenue from North Sherman Boulevard to North 38th Street.; and

Whereas, Said File authorized expenditures of \$1,037,000 in grantor share; and

Whereas, The total estimated cost of the said project is revised from \$1,037,000 to \$1,124,00 with \$1,124,000 to be funded by grantor share; and

Whereas, MMSD has prepared a change order amending said agreement that it will provide a total of \$1,124,000 in grantor funds; and

Whereas, Said change order will provide additional \$87,000 in grantor funds; now, therefore, be it

Resolved, That the Commissioner of Public Works is authorized to accept and execute a change order to the MMSD PPII grant agreement in accordance with Milwaukee Code of Ordinances 304-81, and to execute the change order in the form submitted to this file, or in substantial conformity thereto; and, be it

Further Resolved, That upon approval of the change order to said Agreement, the City Comptroller is authorized to create within the Capital Grant and Aid Projects Fund the appropriate Project/Grant Chartfield Value for this project, and transfer to these accounts the amount required under the agreement and City accounting policy, but not to exceed a ten percent increase of the total amounts reserved for the grantor’s share and local share or \$5,000, whichever is greater, as follows:

Whereas, Section 86.32(1), Wisconsin Statutes enables the State to designate or rescind the designation of certain marked routes of the state trunk highway system over the streets or highways in any municipality for which the municipality will be responsible for maintenance and traffic control; and

Whereas, The Wisconsin Department of Transportation (WisDOT) has requested the transfer of jurisdiction for six signalized intersections from the City of Milwaukee to the WisDOT along the IH 94 corridor; and,

Whereas, The six signalized intersections that have been requested for transfer from the City of Milwaukee to the WisDOT are IH 94 WB On Ramp & North Hawley Road, IH 94 EB Off Ramp & South Hawley Road, IH 94 WB Off Ramp/West O'Connor Street & South 68th Street, IH 94 EB On Ramp/West Kearney Street & South 68th Street, IH 94 WB On Ramp/West O'Connor Street & South 70th Street, and IH 94 EB Off Ramp/West Kearney Street & South 70th Street; and

Whereas; The jurisdiction of the six signalized intersections would be transferred from the City of Milwaukee to the WisDOT upon completion of a staged paving and construction project that is currently scheduled to begin in 2025-2026; and

Whereas, Section 86.32(1), Wisconsin Statutes requires written approval from WisDOT for traffic control devices maintained on the connecting and state trunk highway systems; now, therefore, be it

Alley between W. Atkinson Av., W. Finn Pl (Extended), N. 10th St., N. 11th St. (southerly 50' +/-) (ST21200101) File Number 041565: Concrete alley pavement reconstruction, and grading. (Nonassessable Alley Paving Fund -- \$30,000). The total estimated cost for this project including the requested amount is \$34,000. This project is anticipated to be completed during the 2025 construction season.

Whereas, Taxpayers spend over \$2 million every hour of every day to maintain the U.S. nuclear arsenal; and

Whereas, Milwaukee residents (based on their per capita income) paid \$108 million in federal income tax dollars for the US nuclear weapon programs in fiscal year 2024 (tax year 2023); and

Whereas, Federal funds are desperately needed in Milwaukee for health care, affordable housing, education, food security and development of sustainable energy sources; and

Whereas, The United States, as well as Britain, China, France and Russia, are obligated under the Nuclear Non-Proliferation Treaty (NPT) to take concrete steps toward eliminating their nuclear arsenals; and
