Dear Mr. Leonhardt:


This office represented a number of officers in connection with the above-referenced proceeding. Because of the secrecy of the proceedings, attached statement of legal services does not identify the officers by name. However, to provide you with the assurance needed in order to provide payment for such services, I have obtained written verification from Judge Hansher that I represented the officers, that the investigation concerned the performance of their official duties, and that no charges will be filed against any of these officers.

Consistent with its policy, the City Attorney's Office has refused to represent them, and as they were performing the duties of their office at the time of the events giving rise to the investigation, the claim is hereby made on their behalf for the indicated legal fees.
