

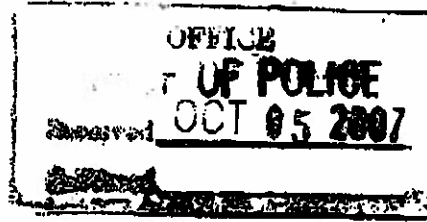

Re: Law Enforcement Special Assignment Grant Agreement with UWM

Dear Chief Hegerty:

In June of 2007, I wrote to you requesting an extension in the Law Enforcement Special Assignment Grant Agreement between UWM and the Milwaukee Police Department, to provide MPD patrols for the UWM neighborhood from August 23 to October 27, 2007 and from April 3 to May 17, 2008. In my June 2007 letter, UWM committed to paying for these services in an amount not to exceed \$24,000 for the period through May 17, 2008.

To date, UWM has expended all of its resources for the additional patrols, thus our prior commitment of \$24,000 is not sufficient to cover the remainder of the Fall semester as well as the Spring semester patrols. Therefore, at this time, I am increasing our commitment of funds to a maximum of \$29,000 for the period from August 23, 2007 to May 17, 2008.

I understand that no further Common Council action is necessary on this matter and that you may effectuate the change in terms through a letter response.

I reviewed your letter of July 2, 2007, requesting an additional extension in the Law Enforcement Special Assignment Grant Agreement between UWM and the Milwaukee Police Department. With this letter, the Milwaukee Police Department agrees to provide additional law enforcement services in areas adjacent to the University from August 23 to October 27, 2007 and from April 3 to May 17, 2008, between the hours of 5:00 p.m. and 4:00 a.m. on Thursday, Friday and Saturday nights. It is understood the University of Wisconsin-Milwaukee shall commit payment in an amount not to exceed \$24,000 for the period through May 17, 2008.

As requested, supervisors assigned to the Fifth District will notify the University Police Department to inform them of the officers assigned to this duty. We look forward to continuing this partnership to address issues of mutual concern.

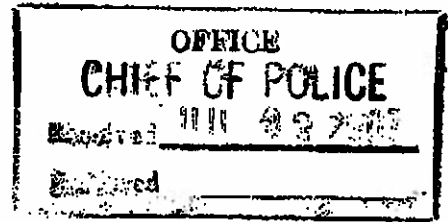

Re: Law Enforcement Special Assignment Grant Agreement with UWM

Dear Chief Hegerty:

By this letter, UWM requests an additional extension in the Law Enforcement Special Assignment Grant Agreement, similar to the extensions granted in 2005 and 2006. The specific periods for the extension would be from August 23 to October 27, 2007 and from April 3 to May 17, 2008, with the services of up to two sets of two officers each to be provided for a four-hour period (to be determined on a daily basis by MPD) between the hours of 5:00 p.m. and 4:00 a.m. Thursday, Friday, and Saturday nights. UWM will commit to pay for these services per the agreement, in an amount not to exceed \$24,000 for the period through May 17, 2008. I understand that no further Common Council action is necessary on this matter and that you may effectuate the agreement through a letter response.


As we agreed last year, we appreciate your willingness to have MPD officers assigned to the services contact the University Police Department at the start of each shift so that the University can confirm that the additional patrols are being provided and establish radio contact. The University Police Department will also be in communication with MPD as to whether one or two sets of officers are recommended.

If there are no concerns with this request, you may simply send your letter response effectuating the agreement. I thank you for your attention to this matter and appreciate all of the efforts of the Milwaukee Police Department in the neighborhoods surrounding UWM.
