Dear Ms. Anderson:


This office is in receipt of your claim in the amount of \$350.00, relating to damages sustained to your lawn mower when it struck a piece of metal that was protruding out of the ground at 2012 North 51<sup>st</sup> Street.

The Infrastructure Service Division records indicated they investigated this claim and found a piece of metal protruding above the ground. They had no record of a sign at this location. The division removed the metal socket upon notification of your claim. Prior to this complaint, the City had no notice of this condition and because we had no prior notice we cannot accept liability for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
