## **MEMORANDUM**

To: Chair Dimitrijevic and Members of the Finance and Personnel Committee

From: Andrea Fowler, American Rescue Plan Act Director

**Subject**: CCFN 231868 "Communication relating to the current status of funds allocated from the American Rescue Plan Act."

This memorandum provides the Finance and Personnel Committee with an update on the status of unspent and unencumbered funds within programs funded by the American Rescue Plan Act "State and Local Fiscal Recovery Fund" grant to the City of Milwaukee. At this time, program staff are in engaged in our quarterly data collection; therefore, project status updates will not be available until that process is complete and the results analyzed. We expect this process to be complete sometime in May, 2024. Based on the requirements of Common Council File Number 231182, which places unused or unencumbered funds under the reallocation direction of the Common Council in June, 2024, program staff are also beginning a second in-depth analysis of each ongoing program and requesting budget forecasts from each program. The results of those program analyses will be provided to the Common Council in June, in conjunction with CCFN 231182.

Because program statuses are not available at this time, the "unspent and unencumbered funds" numbers should be regarded as only one data point in the analysis of a program. Certain programs may be well under way, but such progress may not be reflected by encumbrances and expenditures due to project design, contracting timelines, and/or allocation to salaries (which are budgeted, but not "encumbered.")

I am happy to provide the Committee with as much context as I can at the April 5, 2024 meeting, and will be happy to follow up with the results of our ongoing analyses at the appropriate time. Please find a chart of all programs below.
