
We have received your claim in the amount of \$588.08, relating to damage to your instrument panel gauges, radio and rear back up light allegedly sustained to your vehicle when it was towed to the City of Milwaukee Tow Lot.

Our investigation reveals that there was extensive damage to your vehicle, including a cracked windshield, when it was towed in. The alleged damage to your vehicle would not be caused by typical towing, storage or release of a vehicle. As such, the City cannot accept liability. Therefore, we are denying your claim.
