The Milwaukee Police Department's investigation regarding this application revealed the following:

The doors were propped open by pieces of wood, stuck under the door. Employees of this premises have been warned previously about leaving doors open after 10:00PM. Michael Cerekwicki was on the premises, and represented himself to the officer as the manager of the premises. He told the officer he recalled being warned previously about the door being kept closed after 10:00PM. The manager was convicted for Door Open After 10:00 PM

- 5. On 06/27/09 at 9:42 pm, Milwaukee police were dispatched to 142 W Wisconsin for a Battery complaint. Investigation revealed the victim was a patron at Mo's Irish Pub and was hit in the face and head with a beer mug causing several lacerations. The suspect was charged with misdemeanor battery.
- 6. On 02/28/10 at 3:00 am, Milwaukee police were dispatched to 333 W Wisconsin for a Theft complaint. Investigation found the victim was a patron at Mo's Irish Pub and while she was at the tavern, she placed her purse on top of the bar and didn't realize it was missing until around 2:15 am. A report was filed.

7.	On 09/16/2013 Milwaukee police received a complaint from Alderman Murphy's office
	regarding the bar Mcot (240 East Pittsburgh Avenue). The complaint indicated the business
	was selling beer on a shuttle to Miller Park. Mcot closed several months prior to the complaint
	and had since re-opened as Prodigal. An employee at Prodigal told police that the business
	does not run a shuttle to Miller Park. The officer then contacted Alderman Murphy's office and
	was told the complaint was regarding Mo's Irish Pub at 142 West Wisconsin Avenue. On
	09/20/2013, the officer spoke to the Manager at Mo's Irish Pub and advised him that they could
	not sell beer on shuttles

8. On 10/28/2016 at 1:00am officers conducted a tavern check on Mo's Irish Pub, 142 W. Wisconsin Av. The officer observed 300-400 patrons inside, many who didn't appear to be of legal drinking age. The officers began to clear the tavern and located 18 patrons under 21. The large crowd then began forcing their way out the doors. Someone grabbed a table and used it to push through the door causing 10-15 patrons to be trapped under the table. The crowd forced their way out of the building and the officers allowed them to exit the building because it was a safety hazard to continue to block the exits. The applicant was cited for Disorderly Premise and Allow Underage on Premise.

9. On 11/17/2016 at meeting was held at District 1 regarding the above incident at Mo's Irish Pub. The applicant was present and stated he took responsibility for the incident and will work with MPD to make sure it doesn't happen again. He requested training for his staff in identifying fake ID's and was thinking about putting an ID scanner at the door.

10. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Mo's Irish Pub, 142 W. Wisconsin Av. There was no security at the door and the Police Aid was able to enter. She was able to order and was served a Miller Lite beer for \$3.75.

11. On 04/16/2018 officers conducted a licensed premise check at Mo's Irish Pub, 142 W. Wisconsin Av. The bartender was Grant OLSON, and he did not have a Class D Operator's license. The manager, Justin WAGNER, stated there are no other bartenders on scene but his next bartender comes in at 9:00pm and he knows she has a license. WAGNER was advised to not serve anymore alcohol until he had a licensed bartender. OLSON was issued a citation for Class D Operator's license required and the applicant was cited for Responsible Person on Premise.

12. On 11/29/2018 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Mo's Irish Pub, 142 W. Wisconsin Av. The Police Aid was allowed entry and was served a Miller Lite beer for \$4.00. The bartender was issued a citation for the violation.

- 13. On 11/22/19 at 12:04am, Milwaukee Police were sent to a noise nuisance at 142 W. Wisconsin Avenue. Upon arrival, officers could hear that the outside speakers were on and playing music which could be heard from a block away. Officer's also observed a group of subjects that left the tavern which appeared to be underage and upon stopping one subject, found that she was under the legal drinking age. The subject had 3 IDs on her, one fake, another belonging to someone else and her actual ID The manager of the tavern was told that he needs to do a better job at checking for fraudulent underage identification and they would drop off some identification booklets for his security to look at.
- 14. On 12/05/19 at 11:53pm, Milwaukee Police, while on patrol, observed a large group of patrons who appeared to be under the age of 21 entering the address of 142 W. Wisconsin Avenue. Police conducted a tavern check at the location and found 11 patrons to be under the age of 21 who stated that they used fake identification or that security never asked the subjects for identification. While conducting their investigation, large numbers of patrons, who appeared to be underage, began leaving the tavern quickly and officers were unable to check them for proper identification. Police interviewed the manager who stated that they use private security at the front door and some underage patrons entered through a side door that "friends" might have opened up for them. Officers informed the manager that his staff should undergo some fraudulent identification training and that they could set up a time and date for them, but the manager did not seem to be interested in the training. He was also told that he should have enough security to staff all the door to the establishment and the applicant will be issued a citation.

15. On 01/30/20 at 11:49pm, Milwaukee Police conducted a license premise check at 142 W. Wisconsin Avenue. Officers did a walkthrough and began asking people who did not appear to be 21 years of age for identification. As they discovered people who were not 21 years of age, they escorted them outside to another officer who could verify their real identification. While walking through the tavern, they were stopped by the general manager, who appeared upset, and was concerned about the police conducting a "raid" of the tavern. The general manager was explained the meaning of "licensed premise" and that police were allowed to enter the establishment and conduct these checks. The general manager said that he took pre-cautions from the last time the police were there and had hired new security. Police interviewed the security supervisor who discovered that underage persons were entering through an unlocked back door and that he told the general manager he was concerned about the amount of security officers he had on duty. Police were approached by another manager who stated that she was interested in identification training and that there was a lack of communication between her and the general manager because she did not know about the training. The applicant was contacted and told he would be issued a citation.

This report was written by PO Eric NORTHWOOD assigned to District 1 Late Power shift. On Friday, November 22, 2019 at 12:04 AM, my partner and I PO Brian WUNDER (squad 1442), responded to meet Sergeant (SGT) Timothy GAUERKE (squad 1410) at Mo's Irish Pub Located at 142 W. Wisconsin Av. for loud music playing from the exterior speakers. Sgt. Gauerke could hear the music from 2nd and Wisconsin Avenue and it was echoing off buildings in the area.

Upon our arrival numerous individuals who appeared to be under the age of 21 immediately left the bar. We were able to stop a group of people attempting to get into an Uber.

An individual later identified as Bri M. SUCHY (04-05-99) initially refused to provide any information identifying her. She was given multiple opportunities to provide information to police which she refused. PO WUNDER and I placed handcuffs on her and escorted her to our squad car. I removed her phone from her hand, and in a pocket on the back of her phone were 3 ID's. A fake one with her information on it from New York, a real ID belonging to Emily M. FLYNN (W/F 08-03-95) and SUCHY's real ID from Illinois.

SUCHY stated she received an underage citation from Marquette Police previously, which is why she was not telling us her real information. She stated Marquette PD was not honest with her when they issued her a citation. We informed SUCHY that had she been honest with us that we would have let her get in her Uber and leave, and that we were doing ID checks on underage patrons inside the bar.

I spoke with the Manager Brian J. ADAMS (B/M 03-09-77) and we stated the original reason we responded to the bar due to the music playing outside. Once we arrived we stated that multiple underage individual's left the bar, and while we were standing there, multiple other individuals were walking towards the bar and when the saw Police they walking away.

We informed ADAMS that we would be filing a report, and that his Security needs to do a better job checking for underage and fake ID's. We also stated that we would drop off some ID books for his Security to look at.

This report is written by PO Molly PLUMLEY, assigned to District One, Late Power shift.

On 12/5/2019 while assigned to squad #1442 with PO Eric NORTHWOOD, we were on patrol near W. Wisconsin Av. and E. Plankinton Av. While on patrol we observed large groups of patrons who appeared to be under the legal drinking age of 21 entering the tavern (Mo's Irish Pub). We, along with Squad #1441 (PO WUNDER and PO THURMAN) Squad #1410 (SGT GAUERKE) Squad #1430 (PO SARDINA and PO MATTSON) and Squad #1420 (PO DUERR and PO CONNELL) conducted a tavern check, and began checking identification of patrons inside of the tavern.

We were able to identify approximately 11 patrons who were in the tavern, and under the legal drinking age of 21. The patrons either had a fake identification cards or drivers license that they presented to security at the front door, or stated they were never asked for identification while entering the tavern. As we were attempting to verify the identification of the subjects large groups of what appeared to be underage patrons began to exit the tavern very quickly, and we were not able to verify their age.

One of the underage subjects was identified as GOLDEN, Kevin P. (W/M 12/16/1999) and was given citation #J980GX4FKB for misrepresenting age to receive alcohol (90-18-3) with a future court date.

After our investigation was complete I spoke with the manager working who identified himself as WILLIAMS, Kyle A. (W/M 5/17/1989). I informed Kyle of the amount of patrons that we were able to verify were under the legal drinking age of 21 on the premises of the tavern. I also informed Kyle that the majority of them entered the tavern with either a fake identification card or were not asked for any identification at all.

Kyle stated the security at the door was from a private security company and received fake ID training from his company. Kyle also insisted that some of the underage patrons could have entered a side door if their friends opened it for them from the inside. I informed Kyle that it would be a good idea for his bartenders and other staff to have some fake ID training to help prevent these issues in the future, and provided my contact information if he would like to set some training up. Kyle did not seem to be

interested in any extra training for his employees. I also informed Kyle that it would be a good idea to have enough security on staff to watch all of the doors that someone could use to sneak underage patrons into the tavern. I informed Kyle that the agent would be receiving a citation and a tavern report would be done regarding this incident.

I issued citation #J98027W197 for Allow underage on premises (90-19-2-A-1) to VASSALLO, James A (W/M 1/29/1970) with a future court date.

On Thursday, January 30, 2020 while assigned to squad #1442 with PO Eric NORTHWOOD, we conducted a tavern check at Mo's Irish Pub (142 W. Wisconsin Av.). As we parked our squad car outside of the main entrance, we observed large groups of young adults that did not appear to be of legal drinking age leaving the tavern. I along with Sq# 1441 (PO WUNDER and PO CHADWICK) did a walk through of the tavern and began asking people who did not appear to be 21 and had what appeared to be an alcoholic beverage in their hand for identification.

As we discovered which individuals were not 21 we escorted them out of the bar and handed them off to Sq#1420 (PO DOERING and PO RODRIGUEZ) and Sq#1430 (PO MATTSON and PO SARDINA) who confirmed that the subjects were not 21 by running them in DOT, and issued them citations. As I was conducting my walk through of the tavern I was flagged down by the General Manager WILLIAMS, Kyle A. (W/M 5/17/1989) who was concerned about why we were conducting a "raid" of the tavern. I explained to Kyle that because this was a licensed premises and the patrons needed to be 21 to consume alcoholic beverages that we were simply allowed to come into the business and ask anyone who did not appear to be 21 for identification. Kyle appeared to be upset that we were conducting this license premises check. Kyle was also trying to explain to me that he took precautions from the last incident that they had and hired a new security team to check ID's at the door. Kyle then handed me a stack of approximately 15 ID's that were confiscated before our arrival. I explained that he should not hold onto the ID's as they could be used against him during an inspection. I then explained to Kyle that we use some of the ID's that we confiscate for our fake ID training that we put on for the bars and as a training tool. I also explained that the individuals that would be receiving citations would have their fake ID placed on inventory in the event that they take their citation to court.

I spoke with security on scene who was working the front door and identified as WILLIAMS, Steven (W/M 5/8/1990) who has been through the MPD fake ID training and thought that he had a good handle on what was a fake ID. I also spoke with the security supervisor on scene who was identified as PORTER,

Adam M. (W/M 12/23/1988) who reviewed security footage after we began to do a walk through of the bar. Adam discovered that there were a lot of underage persons that entered the tavern through an unlocked back door. Adam stated it appeared that a male gained entry through the front door after his ID was checked, then went and opened the back door for other people to get in. Adam stated he was concerned with the amount of security that Kyle wanted to have on staff for the night and did not think it would be enough to cover the whole bar.

After we were done conducting our investigation another manager walked up to me and identified herself as JEFFERSON, Erin S. (W/F 6/10/1989) and stated she is the manager of the bar service and Kyle is the General Manager for daily operations. Erin informed me that she would like to set up a date for fake ID training to help prevent this in the future. Erin also stated she wants to make sure that her bartenders have the correct training to use during the day when there is not a security person at the front door. Erin stated there was a lack of communication between her and Kyle and she was not aware of any training that that MPD could help with until the new security team informed her. I provided Erin with my contact information and she said she would get a date in the near future that works for her staff to conduct fake ID training.

The following citations were issued:

DUNLAP, Caroline A. (W/F 6/28/1999) was using a real California DL that did not belong to her and had the name ABEL, Sarah E (W/F 11/2/1996) she was given citation #J9801713HS and placed on MPD inventory #20003769. Caroline stated she was let in the front door with the California DL after security checked it.

MCFADDEN, Michael F. (W/M 5/25/1999) was using a fake Missouri DL which stated he was 21 years of age and he used to gain entry through the front door. MCFADDEN was given Citation #J980GX4FKF for Obstructing and Citation #J980GX4FKG for misrepresentation of age to receive alcohol. The fake Missouri ID was placed on MPD inventory# 20003660.

We also identified the following people who were not 21 but released without a citation.

JACK, Henry R. (W/M 3/22/1999)

SHIELDS, James M. (W/M 11/12/1999)

LANIGNE, Stephen F. (W/M 10/3/1999)

All of the individuals who were identified were students of Marquette university.

On Friday, January 31, 2020 I spoke with VASSALLO, James A. (W/M 1/29/1970 who is the listed agent of the tavern. I notified him of the incident that occurred the night before and informed him that he would be receiving a citation. James informed me that he is the listed agent but he does not have much to do with the tavern and his brother is the one who usually handles it. James agreed to meet with me on Monday, February 3, 2020 to receive his citation and talk about what will prevent this in the future.


