1. Description of Grant Project/Program (Include Target Locations and Populations):

The Urban Partnership's focus is Tobacco Prevention and Education for youth-of-color, ages 8-18. The Milwaukee Health Department's (MHD) community youth serving agency partners in this initiative will help to enhance this tobacco prevention youth-focused program. These youth serving agency partners are:

Boys and Girls Clubs
The Hmong American Friendship Association, Inc.
Girl Scouts of Milwaukee Area, Inc

The shared common goal of this multiple collaboration is to help reduce the youth prevalence smoking rates of 38% (1999 Wisconsin Youth Risk Behavior Survey) to well below the national average of 34% (Youth Tobacco Surveillance, 1998-1999). 80% of tobacco users initiate use before the age of 18 years. If the trend in early initiation of cigarette smoking continues, approximately 5 million children aged < 18 years who are living today will die prematurely as adults because they began to smoke cigarette during adolescence (Abstract: Youth Tobacco Surveillance 1998-1999). Therefore, it is in our community's best interest to support and enhance citywide partnerships in and around tobacco prevention initiatives for our youth.

2. Relationship to City-wide Strategic Goals and Departmental Objectives:

It is within the scope of MHD's mission to assure that services are available to enhance the health of individuals and families, promote healthy neighborhoods, and safeguard the health of the Milwaukee community. Therefore, there is a direct relationship between this urban partnership and the MHD's commitment to provide assessment, monitoring, and assurance that community prevention services are being promoted and implemented through partnerships and collaborations for our City's youth.
