Dear Ms. Buie:

This office is in receipt of your claim in the amount of \$240.00, relating to damage sustained to your garage when a collection crew allegedly hit it with the garbage carts during pick-up at 5529 North 32nd Street.

The Sanitation Division records indicate the collection crew denies causing any damage to your garage. In addition, the height of the garbage cart does not line-up with the height of the damaged area of the garage. Since there is no evidence to support your belief that the Sanitation collection crew caused the damage, the City cannot accept liability. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
