We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.


Claimant, F. John Burbridge, 7100 West Forest Home Avenue, Greenfield, WI 53220-2929 alleges that due to reconstruction work on North 35<sup>th</sup> Street he sustained damages to his building located at 2440 North 34<sup>th</sup> Street. He claims damages in the amount of \$20,400.00.

Our investigation reveals that the North 35<sup>th</sup> Street Reconstruction Project from West North Avenue to West Townsend Street is a State of Wisconsin Project. Because this is


