Dear Mr. Walls:

This office is in receipt of your claim in the amount of \$1,362.82, relating to damage sustained to your vehicle when a snowplow/salt truck allegedly struck it on December 22, 2000 at 4168 North 51<sup>st</sup> Boulevard.

The Fleet Accident Report completed as a result of this alleged incident notes you never saw the actual collision. The police officer that responded to the accident scene noted your vehicle would have had much more damage than noted if it had been hit by a City snowplow. In addition, your vehicle had blue paint transfer, not yellow or orange, which are the colors used on City equipment. Since there is no evidence that this damage was caused by the City we cannot accept liability. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
