To implement the rates of pay provided in the Base Salary provision of the 2003 and 2004-2006 labor agreements between the City of Milwaukee and Public Employees' Union Local #61, LIUNA, AFL-CIO, we are requesting your approval of the attached amendments to the Salary Ordinance.

The agreement specifies a 3% across-the-board wage increase effective Pay Period 1 of each year for 2003-2006. The costs of these amendments to the Salary Ordinance are included in the fiscal note attached to the resolution approving the labor agreement.

In view of the foregoing, we recommend adoption of the attached amendments to the Salary Ordinance. The salary increases for 2003 and 2004 are attached. The 2005 and 2006 rates will be included in the 2005 and 2006 Salary Ordinances.
