CHAIRMAN PAWLINSKI: We're going to skip ahead. We're going to skip to Mike De Sautel, who is the agent for M.R. Entertainment, Incorporated, Class "B" tavern and cabaret renewal for Daddios at 4177 South Howell Avenue. Mr. Arena is here representing Mr. De Sautel?

MR. ARENA: That's correct.

CHAIRMAN PAWLINSKI: What would you like to

MR. ARENA: As soon as I was informed of this matter being scheduled today, I contacted the alderman's office and discussed the notion of adjourning the matter because there is a pending sale.

A contract -- contingency in that contract is that the new owner obtain appropriate license for the sale of liquor, and as I've been made aware, that should be occurring -- on April 29th it should be before the committee, so we're asking that this matter be moved to April 29th.

At that time the new applicant's application will be considered, hopefully granted, and would render the necessity of any further hearing for

Mr. De Sautel not necessary.

CHAIRMAN PAWLINSKI: For the record,

Mr. De Sautel has entered into a contract with another individual who is looking to purchase the property.

This individual's name is Mike Marshall. He's meeting with me tonight, in fact, at six p.m., and the neighbors of the residential neighborhood surrounding Daddios -- three of the neighbors are here this afternoon to watch and monitor the events of this committee, so I'll be conducting a meeting tonight, introducing them to the prospective new owner, and all those matters will be taken care of, and the sale should commence at the --

ALDERMAN BOHL: Should I move to adjourn?

CHAIRMAN PAWLINSKI: The motion by Alderman

Bohl is to adjourn the matter for Michael De Sautel.

ALDERWOMAN CAMERON: To when?

CHAIRMAN PAWLINSKI: Potentially never.

MR. ARENA: To April 29th, so it remains on the calendar, so to speak.

MR. COPELAND: For clarification, are we adjourning the application before us to the 29th or just adjourning?

CHAIRMAN PAWLINSKI: We're adjourning it today. It's possible that Mr. De Sautel will not be

appearing before the committee at any period, as long as the standards of the neighborhood as well as the application meets the criteria of the licensing.

Mr. Marshall will be before us at the next cycle, so the motion would be simply to adjourn.

ALDERWOMAN CAMERON: Mr. Chair, would the motion -- I'm not questioning your ability in how you conduct your business, but I'm just saying wouldn't it be proper to hold this until April 29th of this month and place this particular item on file?

CHAIRMAN PAWLINSKI: I think it's a horse apiece.

MR. ARENA: It's the same thing.

ALDERWOMAN CAMERON: I never heard the word adjourned, so --

MR. COPELAND: Correction. That would be April 30th.

CHAIRMAN PAWLINSKI: April 30th, which is -You're asking for an adjournment, which -- We didn't
