

Detective Leo CARTER, 008169, assigned to the South investigations division, early power shift submits this report on Monday. December 5, 2016 at 5:33 PM.

At 12:30 PM, squad 9115, I, Detective Leo CARTER, was dispatched to meet squads at 4855 N. 72nd St., Milwaukee, WI for a strong-armed robbery.

Upon my arrival I spoke with squad 7121, P.O. Gary INMAN, who advised me they were dispatched at 10:35 AM to a battery DV and 4855 N. 72nd St., Milwaukee, WI. He said upon his arrival they were advised by the victim, Kiana RUSSELL, that her ex-boyfriend had come over and beat her and taking property from her. She further advised officers that she shot at him once. Squad 7121 will be filing a supplemental report regarding their part in this investigation to include a campus of the area for witnesses.

I conducted an interview of RUSSELL who stated the following at approximately 7:20 AM on this date she was leaving to take her children to school. As she walked out her front door of her residence which is located in the 4800 block of N. 72nd St. and the front door faces east onto N. 72nd St. she was accosted by her ex-boyfriend Willie HOPKINS.

She stated HOPKINS approached her and he stated "bitch you think I'm playing with you." She said after he made this comment he immediately struck her on the left side of her face in her mouth with his fist. (You can see visible swelling and a laceration to the inside of her job and lip area)

She stated he punched her several times and she began to fight back. He grabbed her by the neck and forced her to the ground and began to kick and stomp her about the back and arms. (You could see visible swelling to the back of her head as well as to her left arm and a right arm)

She stated while she was on the ground he began to take her while it and her phone from her pockets. He removed her black bi-fold zipper wallet from her left rear pocket. And he removed her cell phone from her front right pocket. He took these items and took them with him when he fled the scene.

She stated she told her daughter, Shawntenna RUSSELL (from henceforth referred to as Shawn) to grab her brother and take him in the house as Sean has a key to the house.

She ultimately was able to get off the ground and make her way back into her residence. HOPKINS followed her into her house as she began to run toward her bedroom he ran after her. She stated she grabbed her firearm which is a High Point model C-99 mm Luger and turned pointing it at him and he turned to run and at which time she followed.

She stated she followed him to make sure that he was outside of the house as she feared for the safety of herself and her children. She stated she fired one time at him missing him and the bullet did penetrate the residence at 4854 N. 73rd St.

RUSSELL advised me she and HOPKINS broke up in July 2016. She stated at that time she moved in with her mother. She finally found her somewhere to live with her two children and did not tell HOPKINS her new address. She stated she has no idea how he found out where she was living.

RUSSELL refused medical attention and stated she would go to the hospital after Police leaves.

I conducted a brief interview of RUSSELL'S daughter, Shawntenna RUSSEL, who stated when she, her mother and her little brother were leaving to get dropped off at school her dad, referring to HOPKINS, was standing next to the trash cans at the rear of the house. He walked up to her mother and hit her. He told her

mother that he was going to kill her. Shawntenna stated RUSSELL told her to put her hands over her mother's mouth, because the mother was screaming. Shawntenna stated her mother told her to go in the house. She took her little brother in the house. She stated she did witness HOPKINS punch, kick and stump on her mother several times before she was told to go in the house.

Shawntenna stated her mother came running in the house and her dad was chasing her. Her mother ran into her room and "I think that's when she got her gun." She states her dad came running from the bedroom and her mother was behind him and they ran outside.

Shawntenna did not see her mom shoot the gun. She just heard the shot.

It should be noted we requested the assistance of Milwaukee fire Dept. to gain entry to the precedent set 44 N. 73rd St. We notice that the bullet did penetrate on the east side of that residence. Once we gain entry through the side door and was found that the bullet did enter the residence and penetrated the rear of the refrigerator. CARTER was able to get in contact with the owner, Dorothy DYSON, and she responded to the residence to secure the property after we documented the damage to her house.

Detective CARTER recovered a 9 mm fired Blazer brand shell casing off the kitchen counter. DYSON advised me she recovered her shell casing and carried it into the house prior to the police arriving.

Carter found her gun lying on her mattress in her bedroom. There were five unfired shell casings in the magazine and nine in the barrel.

A temporary felony warrant has been entered for HOPKINS. This case will be reviewed and the Dist. Atty.'s office on Tuesday, December 6, 2016.

The scene of this incident was the front yard of the victim's residence. The area is primarily a residential area surrounded by single-family homes. It occurred during morning hours (7:20 AM). Victim in case she would like to press charges against the suspect. Victim also advises she did not consent to being battered and robbed by the suspect.
