
I have received notification of the denial of my claim for damages to my 2015 Nissan Sentra in the amount of \$5,599.04.

To whom it may concern:

As you may know, on February 13, 2019, my vehicle sustained significant damages (figure 1) when your insured, Christopher W Elser, attempted a right hand turn from the left lane, causing my vehicle traveling straight in the right lane to collide with his police patrol unit.


I did not sustain any substantial personal injury as a result of this collision, beside some shoulder pain from my seat belt, which subsided after a day; further rehabilitation was not needed. In an effort to amicably settle my claim I have prepared the following for your review. I have also attached supporting documentation (police report, personal photos of the incident (figures 1-7), and an estimation of repairs and damages to my vehicle).

Background: On February 13, 2019, at about 12:16 p.m., I was driving my 2015 Nissan Sentra westbound on State Street heading to my place of employment at the Medical College of Wisconsin. At all times I was paying attention to the road, traffic signals, and other vehicles in my line of sight. There was a clear division of lanes in my direction of travel. I was also wearing my seatbelt.

As I was traveling westbound in the right lane approaching the t-intersection of State Street and Hawley Road, I did not see an indication light (right turn signal) from your insured when suddenly and without adequate warning your client attempted a right hand turn from the left lane, towards my lane of travel causing my vehicle to impact his as I applied my breaks and sounded my car horn. I'm not sure if your insured saw my vehicle in the right lane going straight as he attempted to turn. At the time of the collision my vehicle was immediately spun right in the northbound direction of Hawley Road and was inoperable (figure 2). Your insured after about 15-20 seconds came down to my car to check to see if I was okay. It was at this point your insured acknowledge that he made a "wide turn" to avoid snow that

was occupying part of the road going northbound on Hawley Road (see figures 5-7). According to your insured he was on his way to the funeral of a fellow officer in Oak Creek, WI and was permitted to leave the scene when fellow officers arrived to take his statement and photograph the scene. It was only after your insured left was I able to get the contact information in an incident report from responding crash scene officer Ted Zielinski. As a result of the collision my vehicle incurred significant damage and your insured sustained minor damage near the rear fuselage (figures 3 & 4).

For my part, I was issued no traffic citation and the collision was unavoidable on my part per the police report. I applied my breaks and sounded my horn to avoid a collision. This incident would have been avoided if your insured turned from the appropriate lane and made use of proper lane signaling resulting in damages to both vehicles.

As a result of the collision I have incurred the following damages:

Damage to Vehicle Repair Cost \$5,599.04

Tow Truck Cost from Ray Auto \$77.72

Total Damages: \$5,676.76




