If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Good evening, Infinity Lounge was placed in Nuisance status on January 17, 2024, due to the shooting on January 17, 2024, and the battery cutting on June 7, 2023. Infinity Lounge had another shooting on Saturday, April 20, 2024. There has been a tremendous number of issues with this lounge from

- · Having strippers
- Having a large swimming pool in the parking lot
- · Cooking food and selling to citizens and making someone ill (Health department was involved)
- · Large brawls during closing time Fights,
- Shots fired
- Vandalism to vehicles
- · Citizen's parking vehicles on the sidewalk

The shooting that happened on January 17, 2024, Mario Spencer the owner was very cooperative with the officers and detectives and provided his video surveillance interior and exterior and his security staff information. The most recent shooting this Saturday, April 20, 2024, Mario stated that he didn't know what happen. Mario stated that he didn't know how to operate his surveillance cameras.

The summer isn't here, and we are already having multiple problems with Infinity Lounge. I understand that Infinity Lounge is under a TRO from the last incidents with strippers and not having the correct license last year. We were informed that we are waiting on the judge to figure out if Infinity Lounge will be suspended for 30 days or not. They had their license hearing in February, and everything was put on hold. Now the new incidents that occurred, nothing can be done until 2023 incidents are closed. I would like to know, what is the next step to get the TRO completed?

Since Infinity Lounge is in nuisance status, I will be billing him for a big fight inside the establishment on March 19, 2024, and the video is on Facebook; some vehicles were vandalized, shots were being fired and today the shooting on April 20, 2024. The City Attorney Theresa Montag, Mario Spencer and I created an abatement plan that Mario must follow and he has not kept his end of the bargain. Mario has not attended any of our monthly Crime and Safety meeting. We need to see if Mario conducted a background check on his new security staff. We are unaware if he hired a new security company with CCW and insurance. We need to schedule a meeting with Mario to see if all surveillance cameras are working. Today Mario was not cooperating and didn't want to comply with criminal investigation.



Investigation revealed that there was an altercation between a few females but security promptly kick them out. A walkthrough of the tavern revealed no injured subjects or people needing assistance. The call for service was ruled baseless and the applicant was cooperative during the investigation.
- 7. On 05/10/23 at 2:00a.m., Milwaukee Police were dispatched to a Battery at 4001 W. Fond du Lac. Investigation revealed there had been an argument in the parking lot between a security guard and the caller, who was an off-duty bartender for the establishment. The caller stated they made a comment the security guard didn't like, and the security guard "muffed" their face, so they spit at them. The agent stated the argument took place between the two employees and the caller threw a drink at the security guard. The security guard then declined to allow the caller to enter and the bartender spat at the security guard. The agent stated the security guard was contracted by a security agency, however, when officers contacted the agency to get the security guard's information, they were advised they have not been involved with the establishment for a long time, and that particular security guard was directly employed by the establishment.
- 8. On 06/07/23 at 1:32a.m., Milwaukee Police were dispatched to a local hospital for a Battery Cutting that occurred at 4001 W. Fond du Lac. Officers interviewed stab wound victims who stated they were at the bar when a fight broke out and they were stabbed. Investigation revealed security attempted to break up the fight. An employee was injured during the fight and conveyed to a hospital. The agent was on scene and stated they were in the back and went to the front to see why the music was turned off and they observed "chaos" and multiple fights going on. The agent stated they do have video surveillance but there was no mouse hooked up to the system to operate the system. The agent stated they would get the necessary equipment to retrieve the video. It should be noted two of the subjects that were involved and injured were under the age of 21 (16 and 18) at the time of the incident.
- 9. On 06/24/23 at 1:34a.m., Milwaukee Police conducted a License Premise Check at 4001 W. Fond du Lac. This was in regards to a citizen complaint regarding parking, overcapacity, underage patrons and smoking marijuana in the establishment. On arrival officers observed numerous vehicles parked on W. Fond du Lac Ave., and patrons going into and out of the establishment. The officers also observed patrons leaving the bar and walking to a neighboring bar. The officers entered the bar and observed approximately 50 patrons. The agent was on scene and advised to be vigilant regarding capacity and parking. The agent was cooperative. Concluding the check officers observed multiple patrons moving vehicles due to Milwaukee Parking Enforcement arriving on scene and issuing citations.
- 10. On 06/24/23 at 11:49p.m., Milwaukee Police were dispatched to a Battery at 4001 W. Fond du Lac. On arrival officers interviewed the agent who stated a couple were arguing in front of the

establishment, attempting to gain entry to the bar. The agent refused them entry and the drove away. The agent was cooperative.

- 11. On 07/01/23 at 2:19am, Milwaukee Police were dispatched to a subject with a gun complaint at 4001 W. Fond du Lac. Officers spoke with the victim who stated that the known suspect struck her several times in the face, soon after she entered the business. After the fight the suspect was observed with his group in a vehicle. While in the vehicle someone with the suspect fired a gun shot in the air. The shot fired was in the vicinity of the victim. The victim stated that she has an active restraining order against the suspect. Officers spoke with the agent who stated that no gun shots were fired, after the fight. Officers did not locate any casings in the area, video was not available to officers from the business agent.
- 12. On 07/14/23 at 1:26am, Milwaukee Police were dispatched to a noise nuisance complaint at 4001 W. Fond du Lac. Per the Computer Aided Dispatch (CAD) the caller stated that loud music and loud people were outside the bar. Officers arrived at the location and did not observe any people or any loud music. The lights to the business appeared to be off and there was no answer at the door.
- 13. On 07/16/23 at 12:27am, Milwaukee Police were dispatched to a noise nuisance complaint at 4001 W. Fond du Lac. Officers attempted twice to contact the caller, but were unable to make contact. Officers observed the business operating and open for normal hours. Officers drove outside the perimeter and found no issues with noise levels, therefore, no contact was made with in the business.
- 14. On 07/17/23 at 8:17p.m., Milwaukee Police were dispatched to a Battery at 4037 W. Fond du Lac. Officers observed multiple subjects arguing in the parking lot including the caller of the battery complaint and the applicant. The applicant was the suspect for the battery and a threat complaint called in by the caller. The caller's son arrived after the police were on scene to confront the applicant. While conducting the investigation at 4037 W Fond du Lac Av the officers were advised by an employee and patrons of 4001 W. Fond du Lac., that a subject flashed a gun and threatened them. That subject was identified as the caller's son and he was arrested for Disorderly Conduct-Use of a Weapon. The agent was cooperative and allowed officers to view video surveillance. Due to the observations made on video, the agent was also cited for Disorderly Conduct. (unable to locate citation)
- 15. On 07/20/23 at 3:30p.m., Milwaukee Police received a Property Damage complaint that occurred at 4001 W. Fond du Lac. The officer interviewed the victim who stated on 07/16/23 at 12:30a.m., a patron from the neighboring bar wandered into their yard and couldn't find their way out, eventually climbing their newly installed fence, damaging it. The victim showed the officer the video depicting the incident, where several patrons could be seen attempting to fix the fence.
- 16.On 07/31/23 at 2:30a.m., Milwaukee Police were flagged down for a Subject Wanted that was in a vehicle in the parking lot of 4001 W. Fond du Lac. A field interview was conducted and it was determined the subject was not wanted.
- 17. On 08/20/23 at 7:21pm, Milwaukee Police were dispatched to a Subject with Gun complaint at 4001 W. Fond du Lac. Officers were dispatched to the location per the caller, for a fight in progress and subjects armed with guns. Upon police arrival no fight was in progress or any subjects outside the location. Officer entered the business and did not locate any subjects armed or fighting. The officers attempted to get a hold of the caller but there was no answer on

the attempted call back. Officers spoke with the agent who was at the business and was cooperative with officers.

- 18.On 09/10/23 at 4:11a.m., Milwaukee Police were dispatched to a Tavern Violation at 4001 W. Fond du Lac. The caller stated they believed the establishment was past business hours and still serving alcohol. On arrival officers observed the business to be closed, however, there was a hot dog stand nearby, playing music with patrons surrounding it.
- 19. On 09/16/23 at 7:07p.m., Milwaukee Police were assigned to monitor an event at 4001 W. Fond du Lac. This was considered to be a high-profile event due to a special musical guest at the establishment. The officers spoke to the agent and advised they would be monitoring the event. The agent was cooperative and was thankful they would be in the area. The officers only observed minor parking violations.
- 20. On 10/03/23 at 830p.m., Milwaukee Police were dispatched to a Subject Wanted at 4001 W. Fond du Lac. On arrival officers interviewed an employee who stated the wanted subject no longer works at the bar. While on scene officers observed a partially rolled blunt along with a clear plastic bag which later tested positive for THC. It was not determined who it belonged to, however, was located on the top of the bar near an employee. All licenses were valid, however, were not posted but kept in a binder.
- 21. On 10/26/23 at 2:01am, Milwaukee Police were dispatched to a fight complaint at 4001 W. Fond du Lac. Upon arrival officers observed a small group of subjects near the address of 3928 W. Fond du Lac, which quickly dispersed. Officers were unable to determine if the group attended the business Infinity Lounge. Officers attempted to call the caller for clarity but there was no answer on call back.
- 22. On 10/26/23 at 3:33pm, a meeting was conducted at Infinity Lounge located at 4001 W. Fond du Lac. Present at the meeting were officers of District 7, City Health Inspector, and the business agent. The meeting was regarding a complaint of a citizen getting sick from food sold at the business. The agent was informed that he is not allowed to sell food prepared, cooked at another location. The business is only allowed to sell packaged products. The health inspector stated that follow up may be conducted later regarding the matter.
- 23.On 10/27/23 at 1:58am, Milwaukee Police were dispatched to a Battery at 4001 W. Fond du Lac. Officers spoke with the victim who had a laceration to her head and was bleeding. The victim stated that her boyfriend struck her head with an object in front of the business. The victim stated that the suspect left the location after the incident. Officers spoke with the business agent who stated that he is acquainted with both the victim and suspect but did not witness the incident. The victim received medical attention but refused to go to the hospital.
- 24. On 11/28/23 at 10:21pm, Milwaukee Police were dispatched to a noise nuisance complaint at 4001 W. Fond du Lac. Officers arrived at the location and spoke with business agent regarding the noise complaint. The agent stated that he will turn down the music and stated that the caller is the next door neighbor.
- 25.On 12/22/23 at 12:52a.m., Milwaukee Police were dispatched to a Battery at 4001 W. Fond du Lac. Investigation revealed a patron was dancing too close to another patron and was punched in the face. Both patrons were escorted out of the bar, however, the caller was upset and causing a disturbance because they wanted their cover charge returned to them. The employees were cooperative with the investigation.

- 26. On 12/26/23 at 12:01am, Milwaukee Police were dispatched to a Subject with Gun complaint at 4001 W. Fond du Lac. The computer aided dispatch (CAD) stated that males were arguing outside the location and a subject went to get a gun from their vehicle. The subject circled the block in his vehicle. Officers checked the area and did not locate any subjects arguing or the vehicle described in the CAD. Officers spoke with the agent of the business who indicated that he and his staff did not call the police and were clearing patrons for bar time. Officers were unable to make contact with the caller.
- 27. On 01/17/24 Milwaukee Police were dispatched to a Shooting complaint at 4001 W. Fond du Lac. Officers received multiple shotspotter pings. The shotspotter pings were coming outside the northern entrance of the location. Officers arrived and observed patrons leaving the bar stating nothing happened. Officers attempted to speak with an employee, who was standing outside. The employee intentionally ignored officers and stated that he would be back. Officers then entered the location and located the agent. Officers requested to review video surveillance, the agent then seemed to intentionally pull the incorrect video footage. The agent then took a break from reviewing video with officers to pay his employees for the night, so they could leave. After the employees left the agent appeared to be more cooperative of the video footage request. The officers observed from the video that one the business security guards was firing a handgun. Officers noted that it appeared that the agent was partially obstructing the investigation. The agent allowed employees to leave even though one of the employee was a possible suspect to the shooting complaint. The agent then initially stated that he did not know the security guards. The agent eventually provided employee names and a copy of the video requested. Officers were made aware of the shooting from shopspotter pings and a victim that was admitted to the hospital. Additional security was observed on video with firearms. One of the security guards was eventually arrested regarding the incident.
 - 28. On 01/18/24 at 9:15am, officers of District 7 mailed a certified nuisance letter, to the business agent of 4001 W. Fond du Lac. The nuisance letter was regarding the aggravated battery that occurred on 06/07/23 and the shooting that took place on 01/17/24.
 - 29.On 01/19/24 Milwaukee Police were dispatched to a threat complaint at 4001 W. Fond du Lac. The computer aided dispatch (CAD) indicated that someone made threats to shoot up the tavern. Officers entered the location and spoke with agent who stated that no one called regarding a threat. There was no answer on call back, from the caller.

On Wednesday May 10, 2023, at 02: 00a.m, PO Marshall JONES and I of squad 7441 were dispatched to a battery complaint at Infinity Lounge Nightclub at 4001 W Fond Du Lac Ave which is located in the City and County of Milwaukee.

Upon our arrival we spoke with the caller, Shalleeah N GOODMAN (B/F, 11/03/97) who stated that she works as a bartender at the Infinity Lounge but was off work that day. GOODMAN states that she came to the Infinity Lounge to drink. GOODMAN states that she was outside in the parking lot, at approximately 01: 55a.m on today, Wednesday May 10, 2023, speaking to the owner Mario A SPENCER (B/M, 08/08/80), and a security guard while they were inspecting another employee's vehicle which had been broken into. GOODMAN stated that she did not know the security guard's name. GOODMAN stated that she made a joke about the vehicle being broken into and that the security guard told her "It's not a joke". GOODMAN stated that the security guard then "muffed her in the face", striking her on the left side of her face. GOODMAN stated that she could not get to the security guard and so she spit on him.

Next, we spoke with the owner, SPENCER who stated that the security guard did not work for Infinity Lounge but was contracted out through Perry Security. SPENCER stated the security guard involved in the incident had left for the day. SPENCER stated the security guard's name was Myron. SPENCER did not have any further information for the security guard. SPENCER provided a phone number for Perry Security of 414-933-6804. SPENCER was cooperative and provided his Food license, Class B Tavern license, and the bartender's license for the three Bartender's working Wednesday. SPENCER showed us the 12-exterior cameras, and 8 interior cameras, however SPENCER stated that the cameras were currently being upgraded, and that he could not access footage from the cameras, and he didn't think the ones that were operational would be in view of the incident. SPENCER stated that Infinity Lounge had closed for the day at 01:45 a.m.

SPENCER stated that he witnessed the incident. SPENCER stated that an unrelated employee's vehicle was broken into in the parking lot. SPENCER stated that himself, GOODMAN and Myron were standing near the car, in the parking lot when GOODMAN made a joke about the car being broken into. SPENCER stated that Myron seemed to take offense to GOODMAN making a joke about the car being broken into. SPENCER stated that GOODMAN became upset and threw her drink into Myron's face. SPENCER stated that Myron advised GOODMAN she wasn't coming back into the club, and that Myron physically blocked the entrance pushing GOODMAN away from entering. SPENCER stated that GOODMAN then spit on Myron.

I contacted James PERRY, Owner of PERRY security at 414-933-6804 by phone. PERRY stated that Myron had previously worked for him, but PERRY did not have any personal details such as last name or address. PERRY did give me the phone number 414-391-5310 that he believed had been a phone number for Myron. PERRY stated that Infinity Lounge had decided to directly employee Myron. Perry stated that Myron hadn't worked for PERRY for approximately the last year. PERRY stated that he hasn't been "involved with Infinity in a very long time".

SPENCER stated that the three bartenders working that evening were:

On Wednesday June 7, 2023, at 1:32 am, Milwaukee Police officers were dispatched to St. Joseph's Hospital for a battery cutting.

CALL INFORMATION: Comment: CLLR STS THERE MULTIPLE PEOPLE SHOWED UP STABBED TO LOC, Comment: OCC 20 MINS AGO// OCCURRED SOMEWHERE ON FOND

On Wednesday June 7, 2023, at 1:52 am, P.O. Juliana NAILEN and P.O. Rafael VILLAGOMEZ responded to 4001 W. Fond Du Lac (Infinity Lounge) which was determined to be the scene of the battery cutting.

While on scene, P.O. VILLAGOMEZ spoke to the listed owner who was identified as Mario A. SPENCER (b/m 8-8-80) who was not on scene but stated he would cooperate with anything the police needed. SPENCER stated there should be camera footage of the incident, but it would not be available till the morning. LEWIS and CAMPBELL witnessed the incident occur. SPENCER, CAMPBELL, and LEWIS were all cooperative during the investigation and led to the possible identification of the suspect.

From Incident Notification:

On Wednesday June 7, 2023, squads were dispatched to St Joseph Hospital (5000 W. Chambers) for multiple stabbing victims. Upon arrival, I spoke to a victim who was later identified as A. L. L. (b/f 3-5-01) who stated she stated she was at Infinity Lounge (4001 W. Fond Du Lac) when she ran into a female known at this time only as "Kayla" who she had issues with at the bar. A. L. L. stated Kayla stated she wanted her "rounds" (fight) with her and then she preceded to bump her causing a fight to break out inside of the bar. A. L. L. stated Kayla's friend jumped in and the fight continued outside and that is when bar staff attempted to break up the fight. A. L. L. stated she then noticed her sister who was identified as A. M. L. (b/f 11-20-07) was on the ground bleeding from her head and arm. A. L. L. stated she then noticed she was bleeding from her hand as well.

Victim 1- deep tissue stab womb to the left shoulder (down to shoulder tendon) and approximately 2.5-inch stab womb to forehead (requiring numerous stiches) (serious condition) transported to Children's Hospital

Victim 2- stab womb to left hand (requiring stiches) (RM 2)

Victim 3- stab womb to left hand and wrist (requiring 3-4 stiches)

Detective interview of bar manager:

CAMPBELL stated that he is the bar manager at Infinity Lounge. CAMPBELL stated that he started work at approximately 8:30PM and he was scheduled to work until bar close. CAMPBELL was tending bar that evening at approximately 1:26AM, he looked at his phone and decided to turn the music off for last call. I asked him why he decided to do it then and he stated that he wanted to get out of work earlier. CAMPBELL stated that it was a decent size crowd and they had approximately 35-40 patrons in the bar.

He stated that shortly after he turned the music off, he observed a B/F wearing a white shirt with a Nike logo and white pants strike a female that he could not describe because of the crowd. CAMPBELL stated that he knew the striking female as "Kayla" and she has been to the establishment approximately 10 times that he was working.

CAMPBELL immediately went around the bar to break up the fight. He stated that he got in the middle of the altercation. He stated that he grabbed a female and escorted her out of the establishment. CAMPBELL believes that it was "Kayla," but he could not be sure because of the commotion. While CAMPBELL broke up the one fight, he stated that two more fights started between females.

After CAMPBELL escorted the female out of the establishment, he observed what he describes as multiple altercations outside as establishment was escorting the individuals who were fighting outside. CAMPBELL then back inside to close the bar down.

Detective Interview Business Agent:

SPENCER stated that he is the current owner of Infinity and stated that he has owned the establishment for approximately 3 years.

He stated that he was working that evening at the time of the incident, he was in the back room. SPENCER stated that he heard the music to the establishment turn off at approximately 1:15AM. At that time, he went up front to see why the music was turned off because it was not last call yet.

SPENCER stated that he did not know how long it took him to go to the front by the bar. He stated that it could have been a couple minutes, but he did not rush up front. When he got to front bar, he observed what he had described as "chaos". He stated that he saw multiple fights between females going on inside the establishment and that they were being escorted outside of the establishment.

SPENCER then went outside of the establishment and observed multiple fights between females continuing to break out. He observed security escorting individuals off of the property. In the midst of the chaos, he observed his employee was injured and stated that she went to St. Joseph's hospital due to her injuries.

I asked SPENCER about if his security cameras and if they were operational. SPENCER stated that the camera system was brand new in the establishment and that he didn't have a mouse hooked up to the system to operate them. SPENCER stated that the cameras were recording to the best of his knowledge. He also stated that were the incident occurred outside, is a blind spot and says there is not any coverage. SPENCER stated that he does not know how long that the

Synopsis

On Saturday June 24th, 2023, at approximately 1:12am The next-door neighbor of Infinity Lounge identified as Lydia D. MELTON B/F 01-03-73 phone number 414-888-1987, called and requested a tavern check on Infinity Lounge. MELTON stated that Infinity Lounge was over capacity, and many vehicles were parked illegally on W. Fond Du Lac Av.

On July 2nd, 2023, I conducted follow up by calling MELTON on the phone to gather more information on MELTON'S complaints. MELTON indicated that she has constant problems with Infinity Lounge, and she has gone to the alderman regarding her concerns. MELTON mostly complained about the loud noise coming from Infinity Lounge, and the illegal parking by the patrons of Infinity Lounge. MELTON indicated that she believed that Infinity Lounge was selling tobacco for a profit, and the patrons from Infinity Lounge were underaged, and smoking marijuana.

Officer Observations on June 24th, 2023

At approximately 1:34am, P.O. KRUEGER and I parked our vehicle in the median that is on W. Fond Du Lac Av. just northwest of Infinity Lounge. While monitoring the area, I observed patrons going into and leaving out of Infinity Lounge and the bar across the street called Geno's Bar and Grill located at 3910 W. Fond Du Lac Av. Due to the complaint that the tavern was over capacity and the large number of vehicles parked on W. Fond Du Lav Av. P.O. KRUEGER and I entered Infinity Lounge to count the number the number of patrons inside the establishment.

While inside the tavern, I estimated that there were approximately 50 people inside the tavern, some were drinking, and some were dancing. I did not observe any illegal activity inside the tavern. I spoke to the owner of the tavern Mario A. SPENCER 08-08-80 and informed him that we were receiving complaints regarding the Infinity lounge's Operation. SPENCER stated that he believed it was MELTON who complained on him because she complained on him to the alderman all the time. I informed SPENCER about making sure he knows his capacity limit and told him to make sure his patrons were legally parking. Spencer was very cooperative during this investigation.

While outside of Infinity Lounge, I observed many patrons began to move the vehicles due to City of Milwaukee Parking Enforcement arriving on scene to issue parking citations.

Upon arrival we spoke with the victim, who stated that she was out with her friend, celebrating her friend's birthday. The victim stated that they entered the business, Infinity Lounge, at the above address around the time of 2 AM. The victim stated that suspect was at the location and immediately after she entered the business, the suspect began punching her in the face causing pain intentionally and without consent. The victim stated that the suspect punched her about 5 times. The victim stated that she has an active restraining order against the suspect and that it has been served, which was confirmed through CCAP, as well as MCSO. The citizen then stated that she observed BROWN enter a gold Hyundai that was parked in the parking lot of Infinity Lounge.

A wanted check revealed that BROWN had multiple full extradition felony warrants and active Suspect Alerts through the Milwaukee Police Department.

P.O. MOTTIFF and I approached Infinity Lounge, and I observed a gold four door Hyundai Sonata parked in front of Infinity Lounge. As I approached the vehicle, I observed a black male wearing a white T-shirt and a red hat sitting in the front driver's seat of the vehicle. Due to the subject matching the description of BROWN, I conducted a field interview with the male. After briefly talking to the male, the male showed me an Illinois Driver's license, and he was identified as Quentin L. THOMAS B/M 09-21-94. THOMAS was released and issued a community contact card.

We were unable to determine ownership of the marijuana, however, it was located on the top of the bar closest to Jarvis, who was acting as an employee of the bar.

On Friday, December 22nd, 2023, I was assigned to Squad 7441 with P.O. Tyler STEFFEN. We were wearing a full Milwaukee Police Officer uniform, which included our department-issued badges and body-worn cameras.

At 12:52 a.m., we responded to the address of 4001 W. Fond Du Lac Avenue for a Battery Complaint. This location is Infinity Lounge, a licensed Bar/Tavern in the City and County of Milwaukee, WI.

Upon arrival, we spoke to the caller on-scene, who identified herself as Veronica C. NICHOLSON (B/F, 03/16/04). NICHOLSON stated that her friend was randomly punched in the face while inside the bar by an unknown male.

I spoke with her friend Ladavion M. WESTON (B/M, 12/09/03), who was crying and screaming hysterically. WESTON stated that he was dancing with his friend inside the bar when he was punched in the face randomly by an unknown male. I did not observe any injuries on WESTON, and when asked, he denied medical attention. WESTON went on to state that he and the unknown male were both escorted out of the bar, and he felt that it was not fair because he was randomly punched in the face. WESTON stated that he wanted the fifty dollars he and his friend paid for the cover charge returned to them.

After speaking with WESTON, I talked to the bar manager, Javonni D. CAMPBELL (B/M, 05/11/94). CAMPBELL stated that WESTON was dancing with his friend provocatively and got too close to another male subject, who got upset and punched him. CAMPBELL stated the male subject was removed from the premises immediately.

CAMPBELL stated that after being punched, WESTON remained inside the bar but began to cause a scene because of the incident, which led to security removing him. CAMPBELL stated that WESTON kept asking for a refund, which he could not give him, which upset WESTON.

While speaking with CAMPBELL, WESTON and NICHOLSON left the scene.

I did not observe any tavern violations.

A check revealed that the tavern's licenses were current and the tavern was operating within the allotted hours.

On Wednesday, January 17th, 2024, we were dispatched to a shooting complaint that had occurred just outside the bar/club known as "Infinity Lounge" at the address of 4001 West Fond Du Lac Avenue.

Iocated in the City and County of Milwaukee, Wisconsin.

We received multiple Shotspotter pings related to this shooting complaint of which was placed directly outside the Northern entrance to the "Infinity Lounge". We arrived on scene and observed many people leaving the bar. We asked multiple people in passing where the gunfire came from and if everyone was okay. Everyone walked past us stating nothing happened in the bar and that nothing happened. Knowing that one of the Shotspotter pings occurred right outside the door, we needed to gain entry into the "Infinity Lounge" to both check the welfare of the individuals inside and check for camera footage. We flagged down an employee who was standing outside the door. I attempted to speak with him and informed him that we need access to the video footage. The employee, who was later identified as Harley H. LEWIS (B/M, 03-05-1999). intentionally ignored me and stated he would be right back. LEWIS went inside the bar and did not return after a few moments.

We then let ourselves into the bar. We then made contact with the owner/manager Mario A. SPENCER (B/M, 08-08-1980). I requested SPENCER provide me with the Video surveillance footage of the areas in which we had Shotspotter reports. I asked SPENCER multiple times. SPENCER initially seemed to ignore me. I then requested specific camera locations and times. SPENCER seemed to deliberately continue selecting the wrong cameras and times after having to be corrected multiple times. SPENCER then took it upon himself to stop looking for footage and then pay his employees so they could leave. It was only after these employees had left that SPENCER seemed to better understand what footage we were requesting. SPENCER then looked through the footage from the times and cameras requested and stated he did not see anything. P.O. AGUILAR and I then observed muzzle flash on the screen that SPENCER appeared to be covering with his thumb. It should be noted that the only way SPENCER was willing to access the footage was via his cell phone. P.O. AGUILAR and I both pointed out the muzzle flash we observed on the footage. SPENCER stated he did not see it. We requested to review the footage again and observed that the muzzle flash was coming from a handgun that was being fired by one of the security guards from the bar.

It should be noted that although SPENCER had complete and instant access to all of the many video cameras, he did not immediately cooperate with police. It should be noted that SPENCER did not start fully cooperating until his staff had left the scene. It should be noted that it seemed to officers on scene

that SPENCER did all of this intentionally in an attempt to delay police to allow possible suspects to flee the scene.

After the footage was actually found, SPENCER eventually allowed officers and detectives into his upper unit in which the main system was housed. SPENCER allowed police to gather footage from his system.

Spencer stated he did not know the security guards were but later in the investigation Spencer admitted that he knew who the guards were and identified the guards who were involved in the shooting, by name.

Spencer intentionally attempted to obstruct our investigation.

IT SHOULD BE NOTED THAT NO ONE FROM INFINITY LOUNGE CONTACTED THE POLICE OF THE SHOOTING INCIDENT OR SHOTS FIRED INCIDENT. LAW ENFORCEMENT OFFICERS WERE MADE AWARE OF THE SHOOTING AFTER THE VICTIM'S ARRIVED AT ST. JUSEPH'S HOSPITAL AND THE STAFF CONTACTED POLICE. THERE WERE THREE RELATED SHOTSPOTTER CALLS ONE STATED THERE WERE 25 ROUNDS, THE SECOND STATED 16 ROUNDS, AND THE THIRD STATED THERE WERE 5 ROUNDS WERE FIRED.

AT THE TIME OF THIS REPORT AT LEAST ONE OF THE HIRED SECURITY OFFICERS WAS ARRESTED FOR THE SHOOTING INCIDENT. ADDITIONAL SECURITY OFFICERS WERE OBSERVED ON SURVEILLANCE VIDEO WITH FIREARMS.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/21/22 at 2:10pm, Milwaukee Police were dispatched to 4001 W. Fond Du Lac Avenue for a trouble with subject complaint. Upon arrival, officers interviewed the caller/applicant who stated that the neighbor has cameras pointed at his business making patrons uncomfortable. The applicant was advised, no citations were issued, and no license violations were observed.
- 2. On 04/10/22 at 1:30am, Milwaukee Police conducted follow-up on an armed robbery/carjacking which occurred outside the address of 4001 W. Fond Du Lac Avenue. The applicant told officers that the victim was inside the establishment and they stopped serving her because of her intoxication level. He also reviewed the surveillance footage and said the incident did not happen in front of the tavern. The establishment has six-armed security guards (two of which are always outside) and 16 cameras that capture the entire perimeter.
- 3. On 05/25/22 at 1:00am, a subject parked his vehicle within close proximity to the tavern located at 4001 W. Fond Du Lac Avenue and went inside aforementioned location. When he returned to his vehicle he found his firearm was stolen from underneath his drivers' seat. The incident was reported to police.
- 4. On 05/25/22, the Seventh District Desk Sergeant obtain information from a victim who is a bartender at 4001 W. Fond Du Lac Avenue. The bartender stated that on 05/25/22 a subject

was removed from the tavern. When she finished her shift, she walked outside and was confronted by the subject who pointed a firearm at her. She was able to flee the location and drove to the Fourth District to report the incident.

- 5. On 09/26/22 at 12:08am, Milwaukee Police were dispatched to 4001 W. Fond Du Lac Avenue for a noise complaint. Upon arrival, officers interviewed a security guard/door man who stated they turned down the music before police arrival and would keep the music down until the end of normal business hours. The caller was advised of the situation.
- 6. On 02/07/23 at 11:24pm, Milwaukee Police were dispatched to 4001 W. Fond Du Lac Avenue for a subject with gun complaint. Investigation revealed that there was an altercation between a few females but security promptly kick them out. A walkthrough of the tavern revealed no injured subjects or people needing assistance. The call for service was ruled baseless and the applicant was cooperative during the investigation.

- 7. On 05/10/23 at 2:00a.m., Milwaukee Police were dispatched to a Battery at 4001 W. Fond du Lac. Investigation revealed there had been an argument in the parking lot between a security guard and the caller an off-duty bartender for the establishment. The caller stated they made a comment the security guard didn't like, and the security guard "muffed" their face, so they spit at them. The agent stated the argument took place between the two employees and the caller threw a drink at the security guard. The security guard then declined to allow the caller to enter and the bartender spat at the security guard. The agent stated the security guard was contracted by a security agency, however, when officers contacted the agency to get the security guard's information, they were advised they have not been involved with the establishment for a long time.
- 8. On 06/07/23 at 1:32a.m., Milwaukee Police were dispatched to a local hospital for a Battery Cutting that occurred at 4001 W. Fond du Lac. Officers interviewed stab wound victims who stated they were at the bar when a fight broke out and they were stabbed. Investigation revealed security attempted to break up the fight. An employee was injured during the fight and conveyed to a hospital. The agent was on scene and stated they were in the back and went to the front to see why the music was turned off and they observed "chaos" and multiple fights going on. The agent stated they have video surveillance but there was no mouse hooked up to the system to operate the system. The agent stated they would get the necessary equipment to retrieve the video. It should be noted two of the subjects that were involved and injured were under the age of 21 (16 and 18) at the time of the incident.
- 9. On 06/24/23 at 1:34a.m., Milwaukee Police conducted a License Premise Check at 4001 W. Fond du Lac. This was in regards to a citizen complaint regarding parking, overcapacity, underage patrons and smoking marijuana in the establishment. On arrival officers observed numerous vehicles parked on W. Fond du Lac Ave., and patrons going into and out of the establishment. The officers entered the bar and observed approximately 50 patrons. The agent was on scene and advised to be vigilant regarding capacity and parking. The agent was cooperative. Concluding the check officers observed multiple patrons moving vehicles due to Milwaukee Parking Enforcement arriving on scene and issuing citations.
- 10. On 06/24/23 at 11:49p.m., Milwaukee Police were dispatched to a Battery at 4001 W. Fond du Lac. On arrival officers interviewed the agent who stated a couple were arguing in front of the establishment, attempting to gain entry to the bar. The agent refused them entry and the drove away. The agent was cooperative.

- 11. On 07/01/23 at 2:19am, Milwaukee Police were dispatched to a subject with a gun complaint at 4001 W. Fond du Lac. Officers spoke with the victim who stated that the known suspect struck her several times in the face, soon after she entered the business. After the fight the suspect was observed with his group in a vehicle. While in the vehicle someone with the suspect fired a gun shot in the air. The shot fired was in the vicinity of the victim. The victim stated that she has an active restraining order against the suspect. Officers spoke with the agent who stated that no gun shots were fired, after the fight. Officers did not locate any casings in the area, video was not available to officers from the business agent.
- 12. On 07/14/23 at 1:26am, Milwaukee Police were dispatched to a noise nuisance complaint at 4001 W. Fond du Lac. Per the Computer Aided Dispatch (CAD) the caller stated that loud music and loud people were outside the bar. Officers arrived at the location and did not observe any people or any loud music. The lights to the business appeared to be off and there was no answer at the door.
- 13. On 07/16/23 at 12:27am, Milwaukee Police were dispatched to a noise nuisance complaint at 4001 W. Fond du Lac. Officers were unable to contact the caller. Officers observed the business operating and open for normal hours. Officers drove outside the perimeter and found no issues with noise levels, therefore, no contact was made with in the business.
- 14. On 07/17/23 at 8:17p.m., Milwaukee Police were dispatched to a Battery at 4037 W. Fond du Lac. Officers observed multiple subjects arguing in the parking lot including the caller of the battery complaint and the applicant. The applicant was the suspect for the battery and a threat complaint called in by the caller. The caller's son arrived after the police were on scene to confront the applicant. While conducting the investigation at 4037 W Fond du Lac Av the officers were advised by an employee and patrons of 4001 W. Fond du Lac., that a subject flashed a gun and threatened them. That subject was identified as the caller's son and he was arrested for Disorderly Conduct-Use of a Weapon. The agent was cooperative and allowed officers to view video surveillance. Due to the observations made on video, the agent was also cited for Disorderly Conduct. (unable to locate citation)
- 15. On 07/20/23 at 3:30p.m., Milwaukee Police received a Property Damage complaint that occurred at 4001 W. Fond du Lac. The officer interviewed the victim who stated on 07/16/23 at 12:30a.m., a patron from the neighboring bar wandered into their yard and couldn't find their way out, eventually climbing their newly installed fence, damaging it. The victim showed the officer the video depicting the incident, where several patrons could be seen attempting to fix the fence.
- 16. On 07/31/23 at 2:30a.m., Milwaukee Police were flagged down for a Subject Wanted that was in a vehicle in the parking lot of 4001 W. Fond du Lac. A field interview was conducted and it was determined the subject was not wanted.
- 17. On 08/20/23 at 7:21pm, Milwaukee Police were dispatched to a Subject with Gun complaint at 4001 W. Fond du Lac. Officers were dispatched to the location per the caller, for a fight in progress and subjects armed with guns. Upon police arrival no fight was in progress or any subjects outside the location. Officer entered the business and did not locate any subjects armed or fighting. The officers attempted to get a hold of the caller but there was no answer. Officers spoke with the agent who was at the business and was cooperative with officers.

- 18. On 09/10/23 at 4:11a.m., Milwaukee Police were dispatched to a Tavern Violation at 4001 W. Fond du Lac. The caller stated they believed the establishment was past business hours and still serving alcohol. On arrival officers observed the business to be closed.
- 19. On 09/16/23 at 7:07p.m., Milwaukee Police were assigned to monitor an event at 4001 W. Fond du Lac. This was considered to be a high-profile event due to a special musical guest at the establishment. The officers spoke to the agent and advised they would be monitoring the event. The agent was cooperative and was thankful they would be in the area. The officers observed minor parking violations.
- 20. On 10/03/23 at 830p.m., Milwaukee Police were dispatched to a Subject Wanted at 4001 W. Fond du Lac. On arrival officers interviewed an employee who stated the wanted subject no longer works at the bar. While on scene officers observed a partially rolled blunt along with a clear plastic bag which later tested positive for THC. It was not determined who it belonged to, however, was located on the top of the bar near an employee. All licenses were valid, however, were not posted but kept in a binder.
- 21.On 10/26/23 at 2:01am, Milwaukee Police were dispatched to a fight complaint at 4001 W. Fond du Lac. Upon arrival officers observed a small group of subjects near the address of 3928 W. Fond du Lac, which quickly dispersed. Officers were unable to determine if the group attended the business Infinity Lounge. Officers attempted to call the caller for clarity but there was no answer.
- 22. On 10/26/23 at 3:33pm, a meeting was conducted at Infinity Lounge located at 4001 W. Fond du Lac. Present at the meeting were officers of District 7, City Health Inspector, and the business agent. The meeting was regarding a complaint of a citizen getting sick from food sold at the business. The agent was informed that he is not allowed to sell food prepared, cooked at another location. The business is only allowed to sell packaged products. The health inspector stated that follow up may be conducted later regarding the matter.
- 23. On 10/27/23 at 1:58am, Milwaukee Police were dispatched to a Battery at 4001 W. Fond du Lac. Officers spoke with the victim who had a laceration to her head and was bleeding. The victim stated that her boyfriend struck her head with an object in front of the business. The victim stated that the suspect left the location after the incident. Officers spoke with the business agent who stated that he is acquainted with both the victim and suspect but did not witness the incident. The victim received medical attention but refused to go to the hospital.
- 24. On 11/28/23 at 10:21pm, Milwaukee Police were dispatched to a noise nuisance complaint at 4001 W. Fond du Lac. Officers arrived at the location and spoke with business agent regarding the noise complaint. The agent stated that he will turn down the music.
- 25. On 12/22/23 at 12:52a.m., Milwaukee Police were dispatched to a Battery at 4001 W. Fond du Lac. Investigation revealed a patron was dancing too close to another patron and was punched in the face. Both patrons were escorted out of the bar, however, the caller was upset and causing a disturbance because they wanted their cover charge returned to them. The employees were cooperative with the investigation.
- 26. On 12/26/23 at 12:01am, Milwaukee Police were dispatched to a Subject with Gun complaint at 4001 W. Fond du Lac. The computer aided dispatch (CAD) stated that males were arguing outside the location and a subject went to get a gun from their vehicle. The subject circled the block in his vehicle. Officers checked the area and did not locate any subjects arguing or the vehicle described in the CAD. Officers spoke with the agent of the business who indicated that

he and his staff did not call the police and were clearing patrons for bar time. Officers were unable to contact the caller.

- 27. On 01/17/24 at 1:56am, Milwaukee Police were dispatched to a Shooting complaint at 4001 W. Fond du Lac. Officers received multiple shotspotter pings. Officers arrived and observed patrons leaving stating nothing happened. Officers attempted to speak with an employee who intentionally ignored officers. Officers entered the location and located the agent. Officers requested to review video surveillance, the agent then seemed to intentionally pull the incorrect video footage. The agent then took a break from reviewing video with officers to pay his employees for the night. After the employees left the agent appeared to be more cooperative of the video footage request. The officers observed from the video that one of the security guards was firing a handgun. Officers noted that it appeared that the agent was partially obstructing the investigation. The agent allowed employees to leave even though one of the employee was a possible suspect to the shooting complaint. The agent initially stated that he did not know the security guards but eventually provided employee names and a copy of the video requested. Officers were made aware of the shooting from shopspotter pings and a victim that was admitted to the hospital. Additional security was observed on video with firearms. One of the security guards was eventually arrested regarding the incident.
- 28. On 01/18/24 at 9:15am, officers of District 7 mailed a certified nuisance letter, to the business agent of 4001 W. Fond du Lac. The nuisance letter was regarding Item #8 and #27.
- 29. On 01/19/24 at 1:35am, Milwaukee Police were dispatched to a threat complaint at 4001 W. Fond du Lac. The computer aided dispatch (CAD) indicated that someone made threats to shoot up the tavern. Officers entered the location and spoke with agent who stated that no one called regarding a threat. There was no answer on call back, from the caller.
- 30. On 01/20/24 at 1:31a.m., Milwaukee Police were dispatched to an Accident at 4001 W. Fond du Lac. On arrival the officers did not locate a vehicle and it was determined this had nothing to do with the establishment.
- 31. On 02/03/24 at 1:42a.m., Milwaukee Police were dispatched to a Fight at 4001 W. Fond du Lac. Prior to arrival officers were advised there were 20 people fighting outside. On arrival the officers did not observe anyone fighting and were approached by the manager who stated they did not know why people were fighting but did observe a fight outside. The manager stated they called the police due to the number of people fighting in the street.
- 32. On 02/07/24 at 1:19p.m., Milwaukee Police were dispatched to a Fight at 40001 W. Fond du Lac. On arrival officers observed people getting into and standing outside of vehicles, however, did not observe anyone fighting. The officer spoke to security who stated the fight was down the block in the intersection. The establishment had 4 armed security officers on scene, who were cooperative.
- 33.On 03/16/24 at 8:24p.m., Milwaukee Police conducted a License Premise Check at 4001 W. Fond du Lac. This was in regards to complaints of parking issues and fights. After midnight traffic began to pick up and officers observed numerous cars parking in the street and security attempting to get people to move their vehicles. As the night progressed officers observed multiple parking violations and issued 6 citations and towed one vehicle. The following day officers observed a Facebook video which depicted a fight inside the bar during the time officers were patrolling outside. It appeared the fight was contained inside the tavern and broken up prior to patrons exiting. The officers spoke to the agent regarding the issues and

- the agent stated they would be deploying roving security to address the parking concerns. The agent further requested one or two marked squads to assist with clearing out the area.
- 34. On 04/08/23 at 12:22a.m., Milwaukee Police were dispatched to a report of an underage at 4001 W. Fond du Lac. Multiple attempts were made to contact the caller with negative results. The officers entered the establishment to check for underage patrons, however, found none. The complaint was deemed baseless.
- 35. On 04/12/24 at 1:05a.m., Milwaukee Police were dispatched to a Subject Wanted at 4001 W. Fond du Lac. Prior to arrival officers were advised the subject was across the street from the establishment. The officers located the subject and arrested them.
- 36. On 04/20/24 at 2:12a.m., Milwaukee Police were dispatched to a Spotshotter at 3934 W. Fond du Lac. On arrival officers spoke to the manager at 4001 W. Fond du Lac, who stated a subject became angry when they were denied entry due to having a firearm. The subject left and returned with another subject and began firing at the establishment, which a security guard began to fire back to defend themselves. The subjects then fled in a vehicle east on W. Fond du Lac. Officers recovered multiple casings in front of 4001 W. Fond du Lac and recovered the security guard's firearm. Video surveillance is pending. This incident was upgraded to a shooting due to two subjects arriving at the hospital and the security guard was arrested.
- 37. On 05/06/24 at 1:10a.m., Milwaukee Police were dispatched to a shooting at 4001 W. Fond du Lac. On arrival officers observed a scene full of vehicles and people entering and exiting the establishment. A manager and patrons were interviewed and stated they were not aware of anything happening. An employee inside of the establishment denied knowledge of the incident, or names of security employees, as well as having access to video surveillance. Officers spoke to the agent via telephone who stated they were out of town and would attempt to retrieve video of the incident on their phone and provide it to officers.
 - Officers were further dispatched to a local hospital to meet a shooting victim. Investigation revealed the victim was at 4001 W. Fond du Lac Ave., when a fight broke out. The victim stated security intervened and were pushing people outside. The victim stated they heard gunshots and began to run away when they realized they were shot. A second victim stated their friend was involved in a physical fight with another patron, when security intervened and they fled the bar. The 2nd victim stated they saw muzzle flashes coming from near the bar.
- 38. On 05/12/24 at 11:43p.m., Milwaukee Police were dispatched to a SpotShotter at 3291 N. 40th St. There were 4 SpotShotter calls related to the same incident, one of them being 4001 W. Fond du Lac. A caller stated they were at Infinity Lounge when a fight broke out during a search of a patron at the entrance. The caller stated the subject then ran out and was being chased by the other subjects, when they began to open fire at one another. The caller further stated the group of subjects then ran back into the lounge after shots were fired toward them.
 - The agent was not on scene, but was sent a link to upload the video. The agent did send video; however, it was not the requested video. The video depicts people running east from the location, then west on W. Fond du Lac. The video further depicts a subject run near the front door of the business and discharge a firearm toward the east, then disappeared from camera view. Another camera view shows a subject running westbound then extend their arm as they discharge a firearm.

Casings were located at the following locations: 4 near the south parking lot entrance of 4037 W. Fond du Lac. 4 near the intersection of N. 40^{th} and W. Concordia. 9 and 1 cartridge in front of 4001 W. Fond du Lac., and 3 in front of 3315 N. 40^{th} St.

On Monday, May 6, 2024, at 1:10 AM, while assigned to Squad 7322, my partner Milwaukee Police Officer Christopher AREVALO and I were dispatched to a Shooting Complaint at St. Joseph Hospital at the address of 5000 W. Chamber St. which is located in the City and County of Milwaukee, WI.

Upon our arrival we met Squad 7342 (Milwaukee Police Officer Issac LORETO and Joshua AGUILAR) at St. Joseph Hospital for the shooting. Squad 7342 relayed information stating that the shooting occurred at Infinity Lounge located at 4001 W. Fond du Lac Av, located in the County and City of Milwaukee, Wisconsin. 7342 stated that the victim stated that she was involved in a fight inside the place and had got kicked out. The victim stated that she left outside the side door of Infinity Lounge and then, while she was waiting the shooting occurred, which struck the victim.

PO AREVALO and I then left St. Joseph to try and find a scene at Infinity Lounge.

Upon our arrival, my partner and I observed the scene full of vehicles and people roaming around entering and exiting the establishment. PO AREVALO and I walked East and West bound on W. Fond du Lac Av, to locate a scene for the walk in shooting. While I continued to walk down the W. Fond du Lac Ave, PO AREVALO spoke to supervisor on scene outside Infinity Lounge who was later identified as Marlana M. MOORE (B/F, 01-12-1984). PO AREVALO I asked MOORE if she seen or heard anything, and she stated, "No." I then asked if there had been a commotion in the last 30 minutes and she stated no. I explained the reason why we are there and stated nothing happened because they would have been alerted by other staff and people.

I observed most of the people were coming and going from this establishment and I asked patrons that were around at the time if anything happened, such like a fight. Multiple people stated that they did not hear or see anything.

PO AREVALO stated that he spoke with the employees inside Infinity Lounge to obtain any video footage. PO AREVALO and I spoke to the owner's mother, verbally identified as Cynthia M. I also asked GLESFINNIE if she knew the names of the security employees that were present, she stated she does not have their information. I then asked if she knew their phone number and she just shook her head and did not know their numbers.

The Infinity lounge employees were first being uncooperative, due to the fact that employees wanted to go home, and it was past the hours of operation. The employees were also acting because they did not know what had happen and stated they were unaware of any shooting at this establishment.

Once the employees were informed of why they would need to stay so the police can conduct an investigation regarding the shooting, they became cooperative.

During my initial investigation I observed one male security guard which stated that he had no idea what was going on because he came late. I was unable to obtain his information because he had left the bar when people were leaving the bar. The security guard was unarmed and was just wearing a security t-shirt.

While on scene, I looked past the bar on the wall and I did not observe any licenses posted and did not know if they were up to date. During my investigation of this shooting, I did not observe any violations in the licensed premise.

Per the district community partnership unit this location is a designated nuisance premise.

PO AREVALO submitted a supplemental report regarding his investigation. PO AREVALO spoke to the majority of the people inside the establishment. I was there to hold down the establishment for the shooting.

UPDATE.

Detective Janay PATTERSON of the Violent Crimes Division was tasked with interviewing the victim of the shooting. The victim stated that she arrived at Infinity Lounge (4001 W Fond Du Lac Av) around 12:15 AM. The victim stated that she was dancing near the front door when they heard an argument escalating, leading to a crowd pushing. The victim stated that security intervened and physically removed patrons. While waiting outside the victim heard gun shots, ran away from the location and then realized they were shot.

Detective Stephen OSMANSKI spoke to another victim of the shooting. This victim stated that one of their friends saw a person that she had trouble with and was going to punch that person. This victim stated a short time later that the girl her friend had a problem with walked past and that is when her friend punches the girl. This victim stated that a fight broke out inside and security intervened. This victim stated that she then left the bar and while doing that observed muzzle flashes coming from near the bar. This victim then fled the location.

From additional reports submitted by detectives a fight occurred inside and when the parties were pushed outside an additional fight occurred outside and shots were fired resulting in injuries to one patron.

At the time of this report video from one camera angle was provided by Mario Spencer but no details available for the pending case.

Upon arrival we located four (4) casings near the south parking lot entrance of 4037 W Fond Du Lac Ave. We located four (4) casings in the intersection of N 40th St and W Concordia Ave. We located nine (9) casings and one (1) cartridge in front of 4001 W Fond Du Lac Ave. We located three (3) casings in the street in front of 3315 N 40th St.

We did not locate any persons, buildings, or vehicles struck.

On Monday, May 13, 2024, at approximately 1:30 AM, an unknown caller (restricted number) contacted District 7 via phone regarding the shots fired. The female caller stated she was at Infinity Lounge when she observed a B/M walking into the location. She stated the male subject was being searched by security when approximately 4 other males began to physically assault the subject. The caller stated the male that was being assaulted ran out of Infinity Lounge and the 4 subjects chased him and began to open fire. She stated the male made his way to a red Monte Carlo and began to open fire back toward the four subjects. She stated the 4 subjects

then ran back into Infinity Lounge after shots were fired toward them. The caller stated the 4 subjects are part of the Burleigh Bullies group.

P.O. ROBY spoke to the owner, Mario A SPENCER, who was not present at the time of the incident. SPENCER was given a link at 1:44 AM to upload video that P.O. ROBY reviewed. At the time of 10:16 PM on Monday, May 13, 2024, SPENCER had not sent the requested video. SPENCER did send video, but not the video requested showing the incident. SPENCER had two security officers on scene that were not armed.

P.O. ROBY viewed video showing people running eastbound on W Fond Du Lac Ave at 11:36 PM from the first Shotspotter location. At 11:38 PM you see people running west on W Fond Du Lac Ave from the second Shotspotter location. You then see a B/M wearing a black shirt with a white design on the back and black pants run near the front door of Infinity Lounge and start discharging a firearm towards the east. That subject then ran out of camera view. Another camera shows a B/M medium build running westbound on W Fond Du Lac Ave that falls behind a vehicle then runs to the sidewalk. The subject then extends his arm behind him as he's running and discharges a firearm eastbound.

Per the district community partnership unit this location is a designated nuisance premise.


