

This report is written by Police Officer Gilbert Gwinn, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

In April 2011, the applicant submitted fingerprints to the Milwaukee Police Department as required for the Public Passenger Vehicle Driver's License application. On May 23, 2011, I was notified that the AFIS computer system identified these fingerprints as the same prints of a person previously fingerprinted by the Milwaukee Police Department for a Public Passenger Vehicle Driver's License on 01/02/97. The name of the person from 1997 is Samuel SAMUEL, dob 06/27/67.

On 05/29/11, I contacted the applicant by telephone regarding his fingerprints. I advised him of the fingerprint match and he admitted that he lied about his name back in 1997 because he didn't have a green card and needed a job. I asked him to provide documentation as to his true identity for an accurate background investigation.

On 06/14/11 the applicant appeared the Police Administration Building with the identification. He provided a copy of his birth certificate from India and a Permanent Resident card issued by the Department of Homeland Security.

The background investigation into both identities revealed two arrests by the Cudahy Police Department under the name of Samuel SAMUEL. The applicant admitted that both arrests were his not Samuel's. One of the arrests was for Operating While Intoxicated, which is

reflected on the driving record of Samuel. Samuel's driving record also has a remark that facial recognition finds that Modan SINGH fraudulently obtained this driver's license and it was canceled, however Modan SINGH does not admit to obtaining this record. I explained to the applicant that this Operating While Intoxicated incident belongs on his driver's license and he needs to contact the Wisconsin Department of Transportation. He needs to admit to them that this was his arrest and that he obtained a driver's license in the name of Samuel SAMUEL.

As of 07/06/11 the applicant has not notified the Wisconsin Department of Transportation of his actions.

The information about this person's two identities was given to the Immigration and Customs Enforcement Agency and the Wisconsin Department of Transportation.

1. On 10/22/00 Samuel was cited by the Cudahy Police Department for Contribute to Delinquency.

4. On 03/10/2014 at 12:35pm an officer was checking taxicabs for compliance at 509 W. Wisconsin Ave. The officer observed the applicant in the taxi stand and requested to see his Public Passenger Vehicle License, Daily Safety Checklist and Trip Record. The applicant stated he just started his shift and did not have a Daily Safety Checklist or Trip Record filled out yet. The officer also observed that there was no front plate on the cab. The applicant stated that he had the plate but no screws. The applicant was advised on all violations. On 03/20/2015 the applicant was observed operating the same cab and still did not have the front plate attached. A citation was issued to the permit holder, Inderjit AHUJA.

5. On 06/03/2017 the applicant was cited in the city of Milwaukee for Operating While Intoxicated. The applicants Wisconsin driver's license was suspended for 6 months beginning 07/03/2017 for Blood Alcohol Content (his driver's license is currently suspended). During the period of suspension the applicant failed to return his Public Passenger license to the city clerk as required by ordinance.
