This report is written by Police Officer MONREAL, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/12/2021 at 1:20pm officers conducted a license premise check at Sentry Foods, 9210 W. Lisbon Av. The officers observed the liquor department gate was open and beer was displayed for sale. The officers spoke with Timothy HOGAN, who stated he is the current agent of the business and would remain with the business until the business was sold to the new owner on 04/18/2021. The officers advised the applicant the new liquor license has not been issued yet and they could not sell alcohol until the new license was issued. The applicant stated he would not sell alcohol until the license was granted.
2. On 08/01/2021 at 6:00pm an officer investigated a Trouble with Subject at Sentry 9200 W. Lisbon Av. The officer spoke with the caller by phone. The caller stated he was at the Sentry at 9200 W. Lisbon Av. and was disturbed the security officers were open carrying firearms. The caller admitted he was also open carrying a firearm and felt harassed by security. He stated no threats were made. The caller was advised both parties likely felt uncomfortable due to the other party open carrying.

3. On 06/22/23 at 1:12p.m., Milwaukee Police were dispatched to a Shoplifter at 9200 W. Lisbon Av. Officers were met by the manager, who stated two subjects entered the premise and took items without paying, then fled the store. The employee was cooperative and allowed officers to video surveillance of the incident.

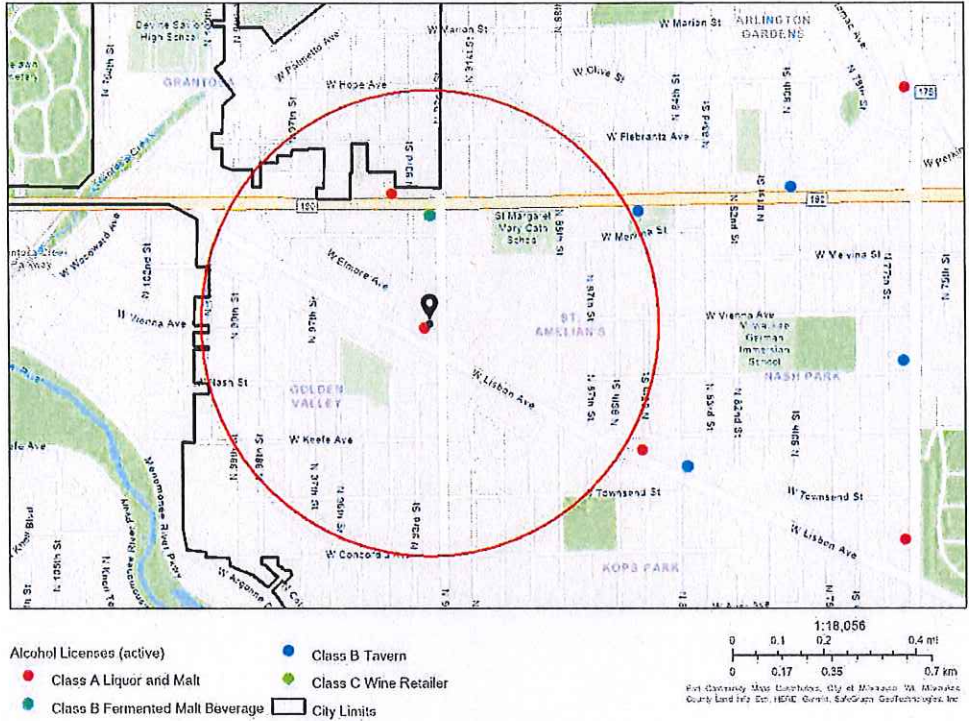

4. Persons opposed to the license Applications are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

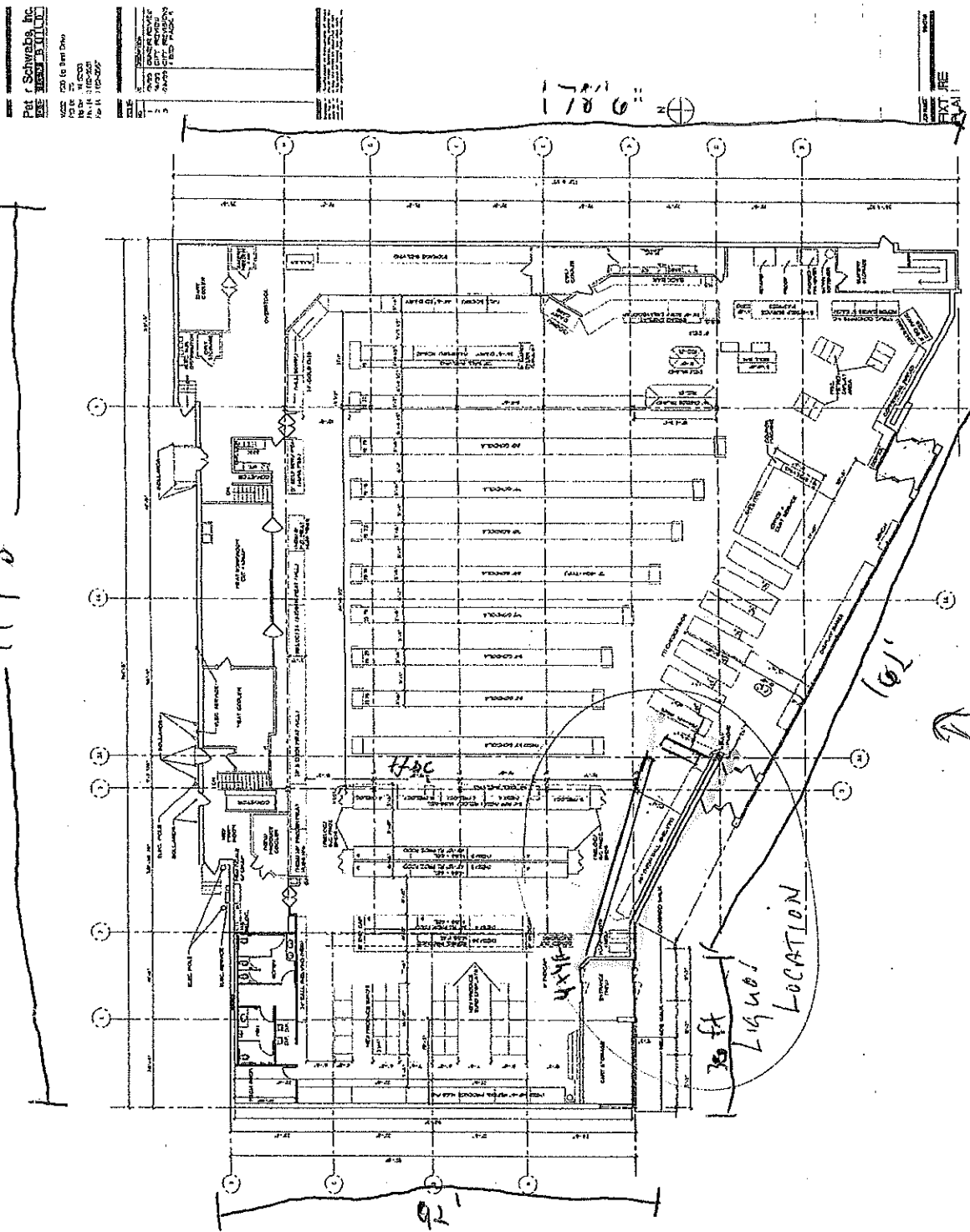

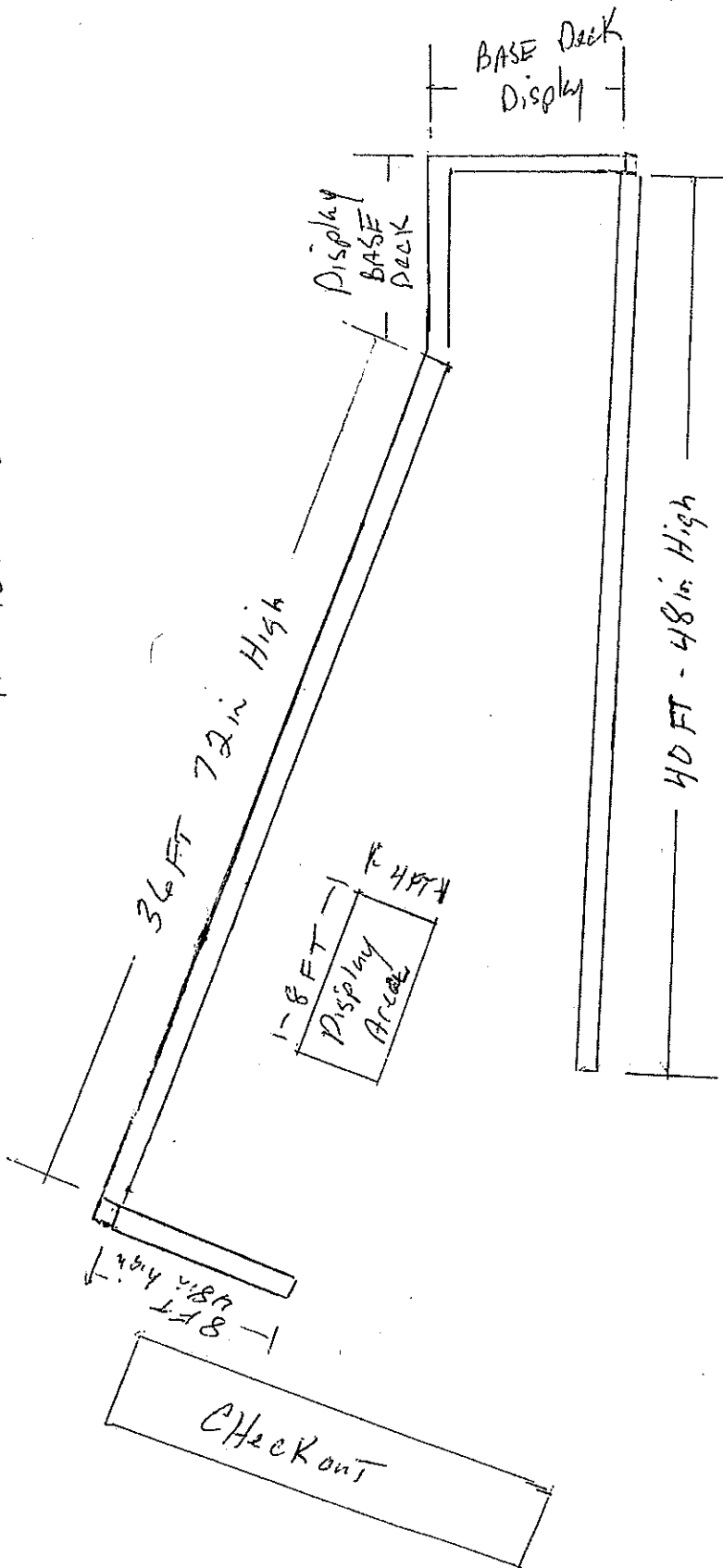

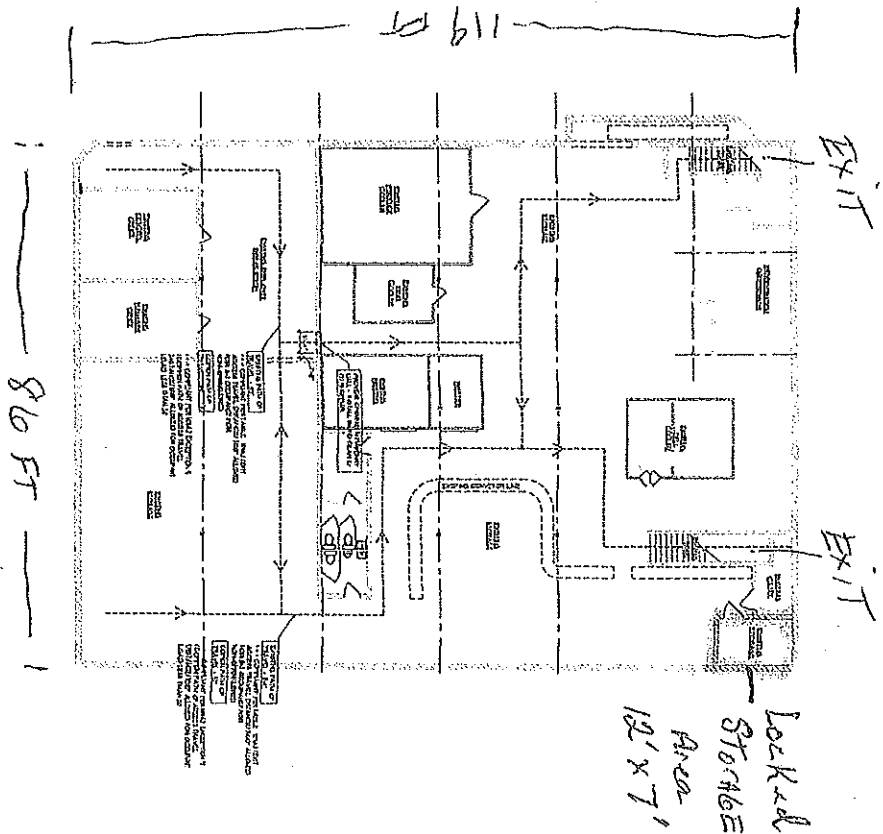
