Dear Inderject DHILLON (RA) and PGI Properties LLC:

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has not timely received a proposed course of action for abatement of nuisance activities occurring at the premises located at 551 W Becher St ("the premises"), nor have you timely filed an appeal, in response to our April 7, 2025 Notice of Nuisance Premises, which directed you to provide a proposed course of action, or appeal, within 10 days of receipt of the notice, pursuant to Milwaukee Code of Ordinances ("MCO") § 80-10, Chronic Nuisance Premises.

Accordingly, as provided at MCO § 80-10-3-d-1, the premises is subject to placement of a special charge as a lien on the property by the Commissioner of the Department of Neighborhood Services for the cost of any police services and enforcement rendered in relation to nuisance activities that occur at the premises for a period of one year from the date of the Notice of Nuisance Premises, beginning 13 days after you received the notice.

Once you have been billed for the costs of police services and enforcement for three or more separate nuisance activities within one year, the premises may be designated a chronic nuisance, pursuant to MCO § 80-10-6, and each and every subsequent incident of nuisance activity at the premises may be deemed a separate violation and result in a citation being issued to you for failure to abate the nuisance activity. Each citation would subject you to a forfeiture of not less than \$1,000.00 or more than \$5,000.00. Upon default of payment of a chronic nuisance citation you would be subject to imprisonment in the county jail or house of correction for a period of not less than 40 days or more than 90 days for each violation.

This nuisance activity is contrary to MCO's 80-10-2-c-1-k.

As a consequence, the premises may be subject to a special charge for the cost of future enforcement for any of the nuisance activities listed in MCO § 80-10-2-c that occur at the premises. Residential rental properties may be subject to an inspection by the Department of Neighborhood Services for compliance with the building maintenance and zoning code pursuant to MCO § 200-53.

You are directed to respond to my office within 10 days of receipt of this notice with an acceptable, written course of action that you will undertake to abate the nuisance activities occurring at the premises, or file an appeal. You may appeal this nuisance determination to the Administrative Review Appeals Board. Any appeal must be in writing and a processing fee will be charged. Please contact the Office of the City Clerk at (414) 286-2231 for additional information.

If you elect to provide a written course of action, I shall evaluate it to determine if it is a reasonable attempt at abating the nuisance activity.

Prior to responding with a written course of action, it is highly recommended that you obtain records relating to police responses regarding the premises. You may obtain these records from the Computer Aided Dispatch System (CADS) at the Open Records Section of the Milwaukee Police Department (District Three Station, 2333 North 49<sup>th</sup> Street, Second Floor) Monday, Wednesday and Friday between 8:00 AM and 3:30 PM. There is a cost of 25 cents per page for these records.

Please review the following examples of nuisance abatement measures that you may include in your written course of action to abate the nuisance activity. These suggestions are not exclusive, may not apply to the issues at your particular premises, and you may propose other nuisance abatement measures that would be appropriate under your particular circumstances.

- Participate in the Department of Neighborhood Services' Landlord Training Program and make a good faith effort to apply the knowledge from the course and attend refresher classes. Information on this training program may be obtained by calling (414) 286-2954.
- Exchange names and telephone numbers with the owners and operators of neighboring premises.
- Participate in a local block watch, neighborhood association, landlord compact and property management association.
- Attend the monthly crime prevention meetings conducted by the local Milwaukee Police District Community Liaison Officer who can be contacted at (414) 935-7228.
- Institute the use of written screening criteria that are provided to each applicant at the time each proposed adult resident receives a written application; and, conduct background checks of all prospective adult tenants and residents.
- Institute the use of a written lease for each adult tenant that include provisions relating to disorderly behavior, noise, garbage disposal, use of common areas, illegal activity, tenant

responsibility for guest conduct, and the prohibition of sub-leasing and long-term guests. Timely enforce any lease violations.

- Review the tenancies of all the current residents in the property. This may include the termination of tenancies and reapplication by existing tenants for new tenancy.
- Regularly inspect the interior of the property to confirm that the residents are your tenants, confirm that the premises are actually used as a residence, and to determine if the doors and windows have been fortified or the premises outfitted with surveillance or delivery mechanisms.
- Monitor the property for evidence of drug activity. This may include observation of clear corner cuts of baggies strewn about, excessive quantities of plastic sandwich baggies found in odd places, presence of numerous weight scales or communication devices and drug paraphernalia such as unusual pipes, empty cigar wrappers, burned hollow tubes, etc.
- Install "No Loitering" signs in the front and rear of the exterior of the property. This signage permits police to cite loitering individuals in the yard and sidewalk area.
- Install "No Trespassing" signs in the front and rear of the exterior of the property. This signage permits police to cite trespassers in commercial properties.
- Install a sign with your name and contact information in a common area requesting law
  enforcement contact you if they are responding to a call for service at the premises.
- Record all rental properties owned by you with the Department of Neighborhood Services as required by local ordinance.
- Participate in the E-Notify system for email updates regarding the premises.
- Regularly file open records requests for Milwaukee Police Department Computer Aided Dispatch System (CADS) reports regarding the property.
- Institute a standing complaint with the local Milwaukee Police district station that will allow the police department to remove any individuals loitering on the property.
- Draft and serve a no trespassing order against identified nuisance persons and provide the local police district station a copy of the served order.
- Provide the local police district station with an updated current tenant list.

If you propose a course of action which is rejected by me or fail to timely respond to this request, and a subsequent nuisance activity occurs on or after 13 days after receipt of this notice, the premises will be subject to placement of a special charge as a lien on the property by the Commissioner of the Department of Neighborhood Services for the cost of any police services and enforcement.

Once you have been billed for the costs of police services and enforcement for three or more separate nuisance activities within one year of the date of this notice of nuisance premises, the premises may be designated a chronic nuisance, pursuant to MCO § 80-10-6, and each and every subsequent incident of nuisance activity at the premises may be deemed a separate violation and result in a citation being issued to you for failure to abate the nuisance activity. Each citation would subject you to a forfeiture of not less than \$1,000.00 or more than \$5,000.00. Upon default of payment of a chronic nuisance citation you would be subject to imprisonment in the county jail or house of correction for a period of not less than 40 days or more than 90 days for each violation.

RE: Notice of Chronic After Set Premises Designation

Dear Inderjeet DHILLON/PGI Properties LLC:

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has designated the premises located at 551 W Becher St, Milwaukee, WI 53207 ("the premises") as a chronic after set premises pursuant to Milwaukee Code of Ordinances 80-11-5, After Sets.

This designation is based upon you having been billed for the costs of police services and enforcement relating to after set activities occurring at the premises for three or more separate occurrences of after set activities within a one-year time period. The following is a concise description of after set activities that have occurred at the premises, the dates on which they occurred, the amount billed for the cost of enforcement, and the relevant sections of the code:

1. On Sunday, March 16, 2025, at or about 2:34 am, Milwaukee police officers were assigned to monitor the premises after receiving complaints from the alderperson of an "after set" at the location. Officers observed that there was a "doorman" and later observed approximately 30-50 exit the premises. Officers were later dispatched to the premises for a complaint of "shots fired" where a subject discharged a firearm into the premises. Officers spoke with the tenant of the premises who stated that an unknown subject had attended the party, became upset with an incident during the party, and later returned and discharged a firearm into the premises. This activity is in violation of c. 108-5 of the code.

Each subsequent occurrence of after set activity at the premises for a period of two years from the date of this notice may be deemed a separate violation and shall be subject to a forfeiture of not less than \$1,000 nor more than \$5,000 for failure to abate the after set activity. Upon default

of payment of a chronic after set citation you would be subject to imprisonment as provided by law.

Dear Inderjeet DHILLON/PGI Properties LLC:

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has determined that a person associated with the premises located at 551 W Becher St ("the premises") has engaged in after set activity pursuant to Milwaukee Code of Ordinances 80-11, After Sets.

The Milwaukee Police Department has responded to the following described after set activity at the premises:

1. On Sunday, March 16, 2025, at or about 2:34 am, Milwaukee police officers were assigned to monitor the premises after receiving complaints from the alderperson of an "after set" at the location. Officers observed that there was a "doorman" and later observed approximately 30-50 exit the premises. Officers were later dispatched to the premises for a complaint of "shots fired" where a subject discharged a firearm into the premises. Officers spoke with the tenant of the premises who stated that an unknown subject had attended the party, became upset with an incident during the party, and later returned and discharged a firearm into the premises. This activity is in violation of c. 108-5 of the code.

The City of Milwaukee has determined that the unlicensed sale or distribution of alcohol beverages and the operation of public entertainment by individuals or entities that have not applied for or received, or are not eligible for, the appropriate licenses or permits as required by code, particularly when these activities take place on premises not zoned for commercial activities, constitute a public nuisance.

This letter is notice to you that the cost of future enforcement of any subsequent after set activity engaged in by a person associated with the premises, as defined by s. 80-11 of the code, at least fourteen days after the issuance of this notice may be assessed and collected as a special charge against the premises.

If you are billed for the costs of enforcement relating to 3 or more separate occurrences of after set activities within one year, you may be issued a citation of not less than \$1,000 nor more than \$5,000 after notification by the chief of police that the premises is a chronic after set premises due to your failure to abate the after set activities.

Dear Mr. DHILLON & PGI Properties LLC:

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has determined that the premises located at 551 W Becher St ("the premises") is a nuisance pursuant to Milwaukee Code of Ordinances ("MCO") § 80-10, Chronic Nuisance Premises.

The Milwaukee Police Department has responded to the following described nuisance activities at the premises on the corresponding dates, which qualify the premises as a nuisance:

- 1. On Sunday, March 16, 2025, at or about 2:34 am, Milwaukee police officers were dispatched to the premises for a complaint of "Shots Fired" where a subject discharged a firearm into the premises. Officers spoke with the tenant of the premises who stated that an unknown subject had attended a party at the premise, became upset with an incident during the party, and later returned and discharged a firearm into the premises. Officers located several gunshots into the premise as well as recovered spent shell casings. This nuisance activity is contrary to MCO's 80-10-2-c-1-L.
- 2. On Sunday, April 6, 2025, at 2:31am, Milwaukee police officers were dispatched to the premises to investigate a report of a "Fight" complaint, where the complainant stated that a group of people attending an after party at the premise were engaged in a large fight and someone almost got hit by a car. Officer arrived on scene and did observe a large group of people fleeing the premise upon observing the marked police squad car. Later in the afternoon that same day, at about 1:44pm, a subject walked into the District 2 front office to report that he attended the after party at the premise, and he was physically assaulted and robbed by several subjects at the after party. This nuisance activity is contrary to MCO's 80-10-2-c-1-k.

As a consequence, the premises may be subject to a special charge for the cost of future enforcement for any of the nuisance activities listed in MCO § 80-10-2-c that occur at the premises. Residential rental properties may be subject to an inspection by the Department of Neighborhood Services for compliance with the building maintenance and zoning code pursuant to MCO § 200-53.

You are directed to respond to my office within 10 days of receipt of this notice with an acceptable, written course of action that you will undertake to abate the nuisance activities occurring at the premises, or file an appeal. You may appeal this nuisance determination to the Administrative Review Appeals Board. Any appeal must be in writing and a processing fee will be charged. Please contact the Office of the City Clerk at (414) 286-2231 for additional information.

If you elect to provide a written course of action, I shall evaluate it to determine if it is a reasonable attempt at abating the nuisance activity.

Prior to responding with a written course of action, it is highly recommended that you obtain records relating to police responses regarding the premises. You may obtain these records from the Computer Aided Dispatch System (CADS) at the Open Records Section of the Milwaukee Police Department (District Three Station, 2333 North 49<sup>th</sup> Street, Second Floor) Monday, Wednesday and Friday between 8:00 AM and 3:30 PM. There is a cost of 25 cents per page for these records.

Please review the following examples of nuisance abatement measures that you may include in your written course of action to abate the nuisance activity. These suggestions are not exclusive, may not apply to the issues at your particular premises, and you may propose other nuisance abatement measures that would be appropriate under your particular circumstances.

- Participate in the Department of Neighborhood Services' Landlord Training Program and make a good faith effort to apply the knowledge from the course and attend refresher classes. Information on this training program may be obtained by calling (414) 286-2954.
- Exchange names and telephone numbers with the owners and operators of neighboring premises.
- Participate in a local block watch, neighborhood association, landlord compact and property management association.
- Attend the monthly crime prevention meetings conducted by the local Milwaukee Police District Community Liaison Officer who can be contacted at (414) 935-7228.
- Institute the use of written screening criteria that are provided to each applicant at the time each proposed adult resident receives a written application; and, conduct background checks of all prospective adult tenants and residents.
- Institute the use of a written lease for each adult tenant that include provisions relating to disorderly behavior, noise, garbage disposal, use of common areas, illegal activity, tenant

responsibility for guest conduct, and the prohibition of sub-leasing and long-term guests. Timely enforce any lease violations.

- Review the tenancies of all the current residents in the property. This may include the termination of tenancies and reapplication by existing tenants for new tenancy.
- Regularly inspect the interior of the property to confirm that the residents are your tenants, confirm that the premises are actually used as a residence, and to determine if the doors and windows have been fortified or the premises outfitted with surveillance or delivery mechanisms.
- Monitor the property for evidence of drug activity. This may include observation of clear corner cuts of baggies strewn about, excessive quantities of plastic sandwich baggies found in odd places, presence of numerous weight scales or communication devices and drug paraphernalia such as unusual pipes, empty cigar wrappers, burned hollow tubes, etc.
- Install "No Loitering" signs in the front and rear of the exterior of the property. This signage permits police to cite loitering individuals in the yard and sidewalk area.
- Install "No Trespassing" signs in the front and rear of the exterior of the property. This signage permits police to cite trespassers in commercial properties.
- Install a sign with your name and contact information in a common area requesting law
  enforcement contact you if they are responding to a call for service at the premises.
- Record all rental properties owned by you with the Department of Neighborhood Services as required by local ordinance.
- Participate in the E-Notify system for email updates regarding the premises.
- Regularly file open records requests for Milwaukee Police Department Computer Aided Dispatch System (CADS) reports regarding the property.
- Institute a standing complaint with the local Milwaukee Police district station that will allow the police department to remove any individuals loitering on the property.
- Draft and serve a no trespassing order against identified nuisance persons and provide the local police district station a copy of the served order.
- Provide the local police district station with an updated current tenant list.

If you propose a course of action which is rejected by me or fail to timely respond to this request, and a subsequent nuisance activity occurs on or after 13 days after receipt of this notice, the premises will be subject to placement of a special charge as a lien on the property by the Commissioner of the Department of Neighborhood Services for the cost of any police services and enforcement.

Once you have been billed for the costs of police services and enforcement for three or more separate nuisance activities within one year of the date of this notice of nuisance premises, the premises may be designated a chronic nuisance, pursuant to MCO § 80-10-6, and each and every subsequent incident of nuisance activity at the premises may be deemed a separate violation and result in a citation being issued to you for failure to abate the nuisance activity. Each citation would subject you to a forfeiture of not less than \$1,000.00 or more than \$5,000.00. Upon default of payment of a chronic nuisance citation you would be subject to imprisonment in the county jail or house of correction for a period of not less than 40 days or more than 90 days for each violation.







This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/16/25 at 8:30a.m., Milwaukee Police were dispatched to a Shots Fired at 555 W. Becher St. Investigation revealed this was a DV situation, that escalated when the victim ran into the business at 551 W. Becher, at which time the suspect fired rounds into the business. One of the victims was identified as the applicant who stated they are currently renting both the laundromat and adjoining bar/restaurant. The officers did find alcohol behind the bar, however, there was no license for the establishment. The victim/applicant stated they were in the process of obtaining permits, however, a check of License Information Reporting Administration revealed no licenses were approved.
- 2. On 04/27/25 at 3:00a.m., a Police Officer responded to monitor the area of 551 W. Becher due to chronic after-set activity. The officer observed subjects exiting the laundromat and subjects attempting to gain entry. The officer noted in prior encounters the exterior lights were illuminated, however, they had now been turned off. The officer noted on a prior occasion, they were granted access by the key holder, identified as the applicant.
- 3. On 09/07/25 at 2:33a.m., Milwaukee Police were dispatched to a Shooting at 551 W. Becher St. On arrival officers observed approximately 100 people attempting to flee out windows and a side door. Upon entrance officers observed employees behind the bar, alcoholic beverages that were being sold as well as buckets of beer on the majority of tables in the business. The applicant was on scene and stated they were in charge of the

gathering and was under the assumption as long as they weren't charging money for entry or drinks they could have people at the location. Two officers obtained capacity numbers of 128 and 129. The applicant was issued a citation for Illegal Alcohol Distribution Unlicensed Premise **Case #25024679** Arraignment is scheduled for 11/10/25 8:30a.m.

- 4. On 09/13/25 at 3:35a.m., Milwaukee Police were dispatched to a Shots Fired at 551 W. Becher St. Prior to arrival the CAD stated there was a shooting and a woman was being held in the basement and they were refusing to let her leave. On arrival all the windows were blocked with thick black sheets. Due to exigent circumstances officers made entry into the adjacent laundry mat and advised to subjects that were hiding to leave. The officers then made entry into the attached bar, at which time approximately 50 patrons were observed who yelled "Happy Birthday". Patrons were observed with alcoholic beverages, as well as a fully stocked bar. The applicant was on scene and argumentative, stating there was no one trapped in the basement and the people were there for a birthday party. As officers were escorting patrons out, one patron asked if they could finish their alcoholic beverage as they were "charged way too much for it". The applicant was issued Citation #25027351 for Distribute Alcohol at Unlicensed Premise with a future court date of 11/24/25 at 1:30p.m. (2 reports)
- 5. On 09/21/25 at 2:23a.m., Milwaukee Police were dispatched to a Trouble with Subject at 551 W. Becher St. Shortly after knocking on the door, the applicant came outside and stated they were not serving alcohol and were hosting a private party. The applicant was advised they were not allowed to host private parties, and all subjects had to leave. The officers remained outside and counted 82 subjects leave the premise.
- 6. On 09/30/25 at 2:00p.m., Milwaukee Police held a meeting with the applicant regarding the after-set activity. Items discussed were after-set activities, nuisance designation letters and billings to the building owner related to chronic nuisance activity. The applicant stated they ceased all activities at the location and are only conducting repairs and renovations. The applicant and building owner were both reminded any future unlicensed activity will result in further citation and/or arrests.
- 7. On 10/12/25 at 2:54a.m., Milwaukee Police were dispatched to an Overdose, later determined to be a Trouble with Subject. On arrival officers observed the parking lot filled with patrons leaving the laundromat side of the business. As more people exited the door to the bar side opened while approximately 50 people fled out of the business. Officers made entrance and observed the applicant, holding a black hand-held radio, walking around the bar area. Officers observed numerous beer and liquor bottles on the tables, behind the counter and in the basement, as well as plastic single use straws. Officers also located green plant like material, suspected of marijuana on the floor, and a ledger containing sales data. #### Initial Observation:

Upon arrival we did not observe any active fighting or commotion outside of the building. We did not observe any individuals through the windows into 555 W Becher St. We were unable to view the interior of 551 W Becher due to multiple thick black sheets attached to the windows to obscure any activities occurring within. While on scene we received updates from an anonymous caller stating she was in the building's basement and was not being allowed to leave. Police on scene announced their presence multiple times and stated that if the doors were not opened voluntarily, we would have to force entry. These further details provided an exigent circumstance and prompted police on scene to force entry through the previously entered glass double doors at 555 W Becher St.

#### Entry:

Upon entry to 555 W Becher St, we did not observe any individuals within the laundromat. We opened the men's restroom door and escorted two individuals out from within. Once 555 W Becher had been cleared we made entry to 551 W Becher St which was connected to the laundromat via an interior door. Upon entering 551 W Becher St we observed approximately 50 individuals gathered within who exclaimed, "Happy Birthday!" upon sight of law enforcement officers. Once inside 551 W Becher St Jose MALDONADO (W/M, 03/19/1980) immediately identified himself as the operator of the establishment and began arguing officer's legal standing to be within the building. MALDONADO stated that all the people at this location were here for a birthday party and that there was no one trapped within the building. Police Officers made their way through the entirety of the establishment to confirm no subjects were injured or trapped within and then directed all party goers out of the building.

While within the establishment officers observed a large amount of alcohol and a fully stocked bar within

Upon arrival I observed the parking lot of the aforementioned address to be fill with people leaving the establishment on the laundry side entrance door (further to the south side). It should be noted this business establishment is known to have multiple violations by not having a license to operate after hour and having after hour parties with alcohol being served. There have been numerous incidents and calls for service at the aforementioned address regarding the same issue. Multiple Officer arrived on scene attempting to close the party down by entering through the laundromat side. I then observed the 551 entrance door to be swung open with over 50 or more people, running out of this building. 


# City Concentration Map for 551 W Becher St
