Dear Mr. and Mrs. Contardi:

We are in receipt of your claim for damages sustained to your 2007 Ford F150, on December 7, 2023, allegedly caused by a city sweeper while you were parked at or near 2748 S. Linebarger Terrace.

Our investigation reveals that on December 7, 2023, a Fleet Accident Report was completed as part of this investigation that indicated that the driver of the city vehicle did not strike any vehicles. Photos of dents and scratches to the right side of the vehicle appeared to be pre-existing. Photos and measurements of the left side of the vehicle where the alleged damage occurred was not consistent with damages caused by a city sweeper.

Since there is no evidence that a city vehicle caused damages to your vehicle, we cannot accept liability. As such, we are denying your claim.


