There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Groups of men and women patronizing the bar exited the bar and were fighting in the street on Saturday, 3/1/2025 in the immediate vicinity of the bar. Have had issues with patrons getting drunk and urinating on neighboring properties shortly after leaving the bar, also having issues with patrons illegally parking either in or around neighboring driveways. An incident with a patron occurred when the patron knocked on a door asking if they can pay to park in their driveway. refused the offer, the patron parked there anyways and showed little regard or care for property.

This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/06/22, Milwaukee Police were dispatched to a Shots Fired complaint at 4707 W. Mill Rd. Officers were advised by security they heard multiple shots coming from the area. Officers recovered casings near they parking lot and along the sidewalk area between 47-49th St. The owner advised officers they would be able to view video surveillance on 04/08/22.
2. On 05/02/22, Milwaukee Police conducted a meeting with the agent for Coconut Bowling Alley, located at 4707 W. Mill Rd. This was due to the Shots Fired incident on 04/06/22. The agent was cooperative and has complied with changes that were suggested at the meeting, and has hired additional security.
3. On 12/26/22 at 9:56p.m., Milwaukee Police were dispatched to a Trouble with Subject at 4707 W. Mill Rd. Investigation revealed patrons entered the business and were observed taking a bottle of alcohol out of a jacket. Security approached the subjects and advised them they cannot bring alcohol into the establishment and they were too young to consume alcohol. The individuals were advised they had to leave the premise at which time a patron began to physically struggle with security. The patrons were eventually all escorted out with no further incident.

4. On 03/04/23 at 9:41p.m., Milwaukee Police were dispatched to a Subject with Gun at 4707 W. Mill Rd. The officers were advised by security and the agent a patron was leaving the establishment and pulled a gun out, aiming it at the ceiling and made a statement to shoot up the business. The officers interviewed several patrons in an attempt to identify the individual, however, everyone denied knowing the subject's name. The agent was cooperative with the investigation and stated they would upload video surveillance of the incident for officers to view.
5. On 03/29/23 at 7:45p.m, Milwaukee Police conducted a License Premise Check at 4707 W. Mill Rd. On arrival officers were met by the manager who advised officers of additional security measures they added to ensure safety of the employees and patrons. The business added exterior LED lights, 5 exterior security cameras and hired an additional two security officers to assist on the weekends.

The following items pertain to the Coconut Bowl located at 4707 W. Mill Rd.

6. On 06/17/24, at 8:38 p.m., officers conducted a Tavern Check. A security guard was monitoring the entrance, and no business violations were observed.
7. On 01/20/25, at 9:48 p.m., officers were dispatched to a Shots Fired Complaint. An intoxicated customer became belligerent and made threats to fight staff. Security removed the customer without incident. The shots fired was found to be baseless.
8. On 04/29/25, at 12:27 a.m., officers were dispatched to a Noise complaint. A security guard informed officers that a group of motorcycles in the parking lot were playing load music but left prior to officers' arrival. While on scene a physical altercation between subjects broke out. The manager and a security guard were struck by a suspect who was detained and cited per the manager's request.

On Monday, June 17, 2024 at approximately 8:38 pm, PO Khalid MAJEED and I (Squad 4467) conducted a TAVERN CHECK of Coconut Bowling alley located at 4707 W Mill Rd. This address is located in both the City and County of Milwaukee, WI.

INVESTIGATION

Upon our arrival, I observed that the mentioned business was open and operating at a business capacity. I observed an "A" rating placard from the health department displayed at the main entrance of the building. As I entered the building, I walked up the main staircase where I observed the on-duty security guard, Gentle DILLS Jr. (B/M 04/22/1984) stationed at the top of the stairs. DILLS wore a blue and yellow security vest and was actively checking patrons prior to entry into the bowling alley. I observed a handheld metal detector on top of a table next to DILLS in which he used to check patrons for weapons after physically searching them prior to letting them proceed inside the bowling alley. I observed that DILLS was checking identification of those who proceeded into the bar area of the bowling alley.

I then proceeded to the main counter where I observed the manager Delroy A. PERRIN (B/M 08/08/1973) sitting at a table close by the main counter. PERRIN stated that he was preparing for the Industry Night event which occurs on every Monday evening. PERRIN stated that he was expecting a smaller than usual crowd

this evening due to the extreme heat outside. I also observed approximately 15 patrons in the bar area who all appeared to be over/at the legal drinking age. I then conducted a walkthrough behind the bar area and did not observe any funnels nor empty bottles of liquor being stored behind the bar.

While in the bar area, I observed that the business licenses were displayed on a wall behind the bar and were up to date and active. ***SEE BELOW*** I observed that the business had clearly marked EXIT signs that was working properly near the exit doors.

Prior to completing a full walkthrough of the building, PO MAJEED and I were pulled for a higher priority assignment. (SHOTS FIRED)

On Monday, January 20th, 2025 at approximately 9:48 pm, Squad 4420 PO Kevin CATHEY and I PO Donald M. BURRIS II (In Full Duty Uniform Marked Squad and Activated AXON Body-Worn Cameras were dispatched to 4704 W. Mill Rd. (Coconut Bowl) for a Shots Fired Complaint. This incident occurred in the City and County of Milwaukee.

upon arrival officers were met by the owner who was physically identified as **Delroy A. PERRIN (B/M, 08-08-1973)**, who stated that there was a patron who was asked to leave the premises due to being intoxicated and unruly towards staff members. PERRIN stated that the unknown B/F was began to become belligerent because she was dissatisfied with service. PERRIN stated that he was willing to accommodate her dissatisfaction, but the unknown patron started cussing him out. PERRIN stated that he asked her to leave and she was escorted out by himself and the security staff.

PERRIN stated that the unknown subject made threats to fight the staff and that she was going to come back up to the business with family members. PERRIN stated that the unknown subject got into her vehicle and fled without incident. PERRIN allowed officers to view video surveillance of the unknown subject being escorted out of the establishment. Officers did not observe any security staff members draw or point any firearms towards the unknown subject. The security staff is licensed to carry firearms as security. Officers could not locate the alleged caller/victim who was no longer on scene.

PERRIN stated that no security staff at anytime pointed or fired any shots. Officers found this call to be

On Tuesday, April 29, 2025, at approximately 12:27 am, PO Donald BURRIS and I (Squad 4467) were dispatched to a Noise complaint at Coconut Bowling alley located at 4707 W Mill Rd. This address is located in both the City and County of Milwaukee, WI.

INVESTIGATION

Upon our arrival, I observed that the mentioned business was open and operating at a business capacity. I observed that the business was hosting an event known as INDUSTRY NIGHT. PO BURRIS and I entered the parking lot of the business and did not hear any music or noise coming from the business. I did not observe any vehicles in the area that was playing loud music. I walked up the main staircase where I observed the on-duty security guard, Gentle DILLS Jr. (B/M 04/22/1984), who stated that there was a group of motorcycles who were in the parking lot that was equipped with loud music speakers. DILLS informed me that the security staff asked the group to turn down their music, but they all left the

premise prior to officers' arrival.

While on scene, PO BURRIS and I were alerted to an altercation near the exterior of the main entrance door. I observed a large crowd surrounding one male and two female subjects. I observed that one of the females were throwing glass bottles at the crowd and the other female was laying on the ground with the male standing over her. I observed that the male, Marty I YOUNG (B/M 06/20/1998) was grabbing the female, Anna A YOUNG (B/F 01/29/2000), by the arms and shoulders while she remained on the ground. I observed that MARTY was yelling at the crowd and also ANNA at that time. MARTY was detained by officers as he appeared to be attacking ANNA as she was on the ground.

It was later determined that MARTY, ANNA and the third female was inside of the business sitting near the restroom area. At that time the three subjects caused a disturbance inside of the building and was told by security that they had to leave. At that time, MARTY struck the security guard with a closed fist and the two females also began to strike the security guard. As security was escorting MARTY down the stairs towards the main entrance door, Delroy A. PERRIN (08/08/1973), who is the manager of the business was walking into the main entrance doors. PERRIN observed what was happening and attempted to resolve that situation with MARTY. At that time, MARTY grabbed PERRIN by the shirt and intentionally struck him in the face with a closed fist and yelled out profanities towards him. After observing MARTY strike PERRIN, multiple patrons of the business began to rush towards MARTY, ANNA and the third female until they all ended up on the exterior of the building where the three of them continued to fight with the crowd.

Officers called for medical attention for ANNA as she had trouble standing up from the ground. Upon arrival of the medical personnel, ANNA began yelling profanities towards them and also towards officers. ANNA refused medical attention on scene multiple times and refused to provide any statements to officers. ANNA remained on scene for an extended period of time due to MARTY, her brother, was still detained inside of a squad car. ANNA continued to belittle and yell out profanities towards officer and declined any police services, despite multiple attempts from officers. The three subjects eventually departed the scene after a family member arrived in a personal vehicle and convinced them to leave the area.

PERRIN nor any security guard wanted to report any battery complaint on the three individuals, but PERRIN did want a disorderly conduct citation to be issued to MARTY for creating and causing the altercation.

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
