On May 13, 2020 at approximately 1:02 P.M. myself in full duty Milwaukee Police Uniform wearing a fixed body worn camera while operating marked MPD squad 578 was dispatched to a theft complaint located at 5801 W Center St. at Big Bills Auto. This is located in the city and county of Milwaukee, WI.

I spoke to the owner of Big Bills Auto LINDSAY, Craig W (M/W 09/12/1974) stated last night between the hours of 12:00 A.M. - 4:00 A.M. a unknown subject(s) intentionally and without consent permanently deprived him of 4 catalytic converters estimating at \$2600. LINDSAY stated that he has cameras on his property but has not reviewed the camera footage yet and will call the District 3 to advise me of any updates of the suspects. LINDSAY stated that he does not know who had done this. LINDSAY informed me that Big Bills is open Monday-Friday 10:00 P.M. - 6:00 P.M. LINDSAY informed that his business has been burglarized 50 times in 2020. LINDSAY stated he has Auto House for insurance. LINDSAY stated he will not be making an insurance claim but informed me that he would like extra patrols between the hours of 12:00 A.M. - 4:00 A.M. to help deter the crime occurring at his business.

LINDSAY provided me the vehicle information regarding the catalytic converters that were taken.

Initial Investigation:

Upon arrival, we spoke with an employee who was identified as Dayshun P. KIMKNIGHPON (B/M, 4/9/02). Dayshun stated that at approximately 1 PM, a recent customer who had purchased a vehicle had returned to the business and was upset over some issues with the vehicle. Dayshun showed me the information they had for the subject that was obtained when they originally sold the car to the subject. The subject was identified as Breione T. WALKER (B/M, 6/28/99) and was described by Dayshun as a B/M approximately 6'3" with a heavy build. WALKER was LSW a black winter jacket and gray jeans with a green stripe down the side. Dayshun stated that WALKER became increasingly upset that they could not immediately fix his vehicle and then exited the building and went into his vehicle. When WALKER returned inside the building he was holding a purple/black firearm in his right hand and began making threats to come back to the location and shoot it up along with any employees inside. Dayshun tried to calm WALKER down but he then left the location in his vehicle in an unknown direction. Dayshun was visibly upset over the incident.

P.O. NUTER spoke with another employee and witness of the incident who was identified as Carmen RUIZ (H/M, 12/30/67). RUIZ stated that WALKER came to the business around 1 PM and was upset over recent issues with his vehicle. RUIZ observed WALKER go to his vehicle and grab a purple/black firearm and then return inside the business. WALKER then stated to employees on scene, "...bring your guy uo here or I'll shoot..." referring to the owner of the business. RUIZ stated he then stepped outside to call the owner and left the scene to be away from WALKER. When RUIZ returned, WALKER and his vehicle were gone.

WALKER was driving a 2009 Nissan Murano, black, 4dr that had a Temp. plate of U2018G.

Dayshun stated there is surveillance of the incident but he was unfamiliar with how to properly work the system. Dayshun was notified an officer would be out at a later time to recover the video of the incident.

Dayshun was issued a PV-17.

The hearing before the Licenses Committee will take place virtually on 3/30/2021 at 9:25 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
