This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/17/22 at 12:32am, Milwaukee Police were dispatched to 4600 S. 27th St, for a subject with a gun complaint. Upon arrival officers observed a subject in pain in the parking lot. Officers spoke with the subject who stated that he was sprayed in the face with pepper spray. Milwaukee Fire Department arrived and treated the subject. Officers spoke with hotel personal, who stated that the subject was attempting to enter the garage and a vehicle. The subject would not leave the area when told by security and then re attempted to enter the vehicle. The subject was pepper sprayed by on site security to stop his actions. Officers had the subject medical treated and then placed him in to custody.
- 2. On 08/19/22 at 10:25am, Milwaukee Police were dispatched to 4600 S. 27th St, for a trouble with subject complaint. The agent called the police regarding a hotel patron that was causing a disturbance, at the location. The agent stated that the subject made threats to harm staff members and attempted to gain entry to the office. The agent provided video to officers, of the subject's actions. The subject was detained and cited for disorderly conduct, and his stay was terminated at the hotel.
- 3. On 12/15/22 at 12:00pm, Milwaukee Police were dispatched to 4600 S. 27th St, for an injured/sick complaint. Officers spoke with the employee who stated the subject was supposed to check out at 11:00am, but did not. The employee found the subject laying on the floor

snoring and could not wake him. Milwaukee Fire Department was on scene and stated that they administered narcan to the subject. Officers on scene noted that there is only one point of entry and exit into the hotel rooms. The employee was cooperative with the investigation.

- 4. On 03/09/23 at 1:43am, Milwaukee Police were dispatched to 4600 S. 27<sup>th</sup> St, for a property damage complaint. Officers spoke with the business agent, who stated that past patron was kicking a door at one of the hotel rooms. The subject stated that she wanted items left in the room from her previous stay. The employee checked the room and no items were in the room. Officers advised the subject to leave the location or the subject would be arrested.
- 5. On 05/06/23 at 12:52pm, Milwaukee Police were dispatched to 4600 S. 27<sup>th</sup> St, for a trouble with subject complaint. Officers spoke with the business agent who stated that a guest refused to leave, and a knife was on the bed. The subject agreed to leave without incident and the knife was not used in a threating, dangerous manner.
- 6. On 05/08/23, Milwaukee Police were dispatched to 4600 S. 27<sup>th</sup> St, for a welfare check. Officers received information form a third party caller to check the hotel room for a subject. The hotel was cooperative with officers regarding the investigation.
- 7. On 05/14/23, at 11:28am, Milwaukee Police were dispatched to 4600 S. 27<sup>th</sup> St, for a subject with gun complaint. Officers spoke with the business agent who stated that a guest demanded a refund and implied that he had a gun. Per the business agent the guest got into an altercation with an unknown female. Officers did not locate either subject regarding the assignment. The business was advised, and no police action was taken.
- 8. On 06/27/23, Milwaukee Police were dispatched to 4600 S. 27<sup>th</sup> St, for a shots fired complaint. Officers spoke with an employee who stated that they were at the rear of the property cleaning out junk. A white vehicle pulled up and a female exited, and yelled stay away from my stuff and discharged one gun shot in the air. The vehicle then went to the front lobby of the business. The possible suspect was in the front the lobby and detained by police. The incident was not caught on video, and some cameras were not functioning properly. The agent mentioned to officers that they are upgrading the camera system. The business was cooperative with the investigation.
- 9. On 08/01/23, Milwaukee Police were dispatched to 4600 S. 27<sup>th</sup> St, for a welfare check complaint. Officers spoke with employee, who was the caller. The employee stated that a guest seemed confused and was walking in front of the lobby. The guest only spoke Spanish and an interpreter had to be use. The employee stated that Milwaukee Fire Department arrived and he believes that the subject was conveyed for medical treatment. Officers did not observe the current business licenses displayed and contacted the business agent who was cooperative.
- 10. On 08/31/23, at 1:00pm Milwaukee Police conducted a license premise check at 4600 S. 27<sup>th</sup> St. Officers spoke with the agent via telephone regarding the current license. The agent was advised by officers that there was an aldermanic complaint that hotel licenses was expired and had to be renewed. The agent stated that she was actually at the License Division filing the application as speaking with officers. The agent states that she was made aware of the license issue and would contact officers if she had additional questions. Officers made the agent aware that the business could be cited each day that the business is operating without the proper license. The agent stated that application will be filed with the License Division shortly after getting paper work regarding a shareholder issue. The agent was cooperative with officers.

This report is written by P.O. Mark SHEREMETA, assigned to District 6, Late Shift.

On Thursday, March 17, 2022, at 12:32AM, Squad 6330 (myself and P.O. Ana ROMERO-PEREZ, both in full duty uniforms, equipped with BWCs, and operating a marked MPD squad #627) was dispatched to 4600.

S. 27th Street for a Subject With Gun complaint.

Upon arrival, squads observed a male subject hunched over and walking up the driveway from the rear lower parking area. The subject, later identified as, Lugene A. MITCHELL (B/M, 09-11-82), stopped and knelt down in the driveway. It should be noted that MITCHELL was holding a plastic soda bottle with a red label and no cap. MITCHELL appeared to be in pain and was covering his face. Squad 6350 (P.O. David CONNER and P.O. Nash DATHE) arrived on scene first and observed a vehicle drive up from the rear lower parking area. Squad 6350 went to investigate the car, while P.O. ROMERO-PEREZ and I investigated MITCHELL. MITCHELL was complaining that he was sprayed by some kind of substance, and his face and eyes were burning. MFD Engine 14 arrived and assessed MITCHELL on scene.

P.O. DATHE and P.O. CONNER relayed to me that the car (a 2008 black Acura RL 4-door, WI-621NXT) belongs to the motel owner, Alpa N. PATEL (A/F, 01-14-81), and was being driven up to this upper parking lot by the on -site clerk/security, Juan GONZALEZ (W/M, 04-07-92). GONZALEZ reported that he had pepper-sprayed MITCHELL when MITCHELL tried to get into the car with him.

I went to speak with GONZALEZ who had PATEL on the phone. PATEL was monitoring the video surveillance from her location at 3001 W. Wisconsin Avenue. PATEL stated that she was alerted to motion by her security camera system, and then she observed MITCHELL on live video attempting to open the service door to gain entry to the garage located in the rear northeast corner of the property. PATEL stated that she alerted the clerk/security on site, GONZALEZ. GONZALEZ stated that he then went to the rear of the property, and when he got there, he observed MITCHELL pulling on the driver door handle and attempting to pull the driver side window down on PATEL's locked Acura, which was parked in the rear lower parking lot. GONZALEZ stated that he confronted MITCHELL (who is not a motel guest), asking who he was, and telling him to get out of here. GONZALEZ stated he told MITCHELL that he was trespassing and needed to leave. GONZALEZ stated that MITCHELL seemed "like he was on something." GONZALEZ stated that MITCHELL did not leave, but remained in the rear lower parking area. GONZALEZ stated that he got into the Acura to move it to the upper parking lot, and when he did this, MITCHELL attempted to enter the Acura a second time (while yelling and screaming at GONZALEZ). GONZALEZ stated that he did not know what MITCHELL was trying to do, but MITCHELL's actions caused GONZALEZ to fear for his safety. GONZALEZ stated that he sprayed MITCHELL with pepper spray in order to protect

himself.

I confirmed that MITCHELL is not a guest at the Motel, and has no reason or consent to be on the property or to be trying to get into the garage or PATEL's vehicle.

I determined that MITCHELL would be arrested. P.O. ROMERO-PEREZ arrested MITCHELL, and we placed him in the back of our squad after searching him incident to arrest.

On Friday, August 19, 2022, at approximately 10:25 am, squad 6130, I was dispatched to 4600 S. 27th St. (Suburban Motel), located in the City and County of Milwaukee, regarding a trouble with subject complaint. At this time I was wearing my department issued uniform with last name affixed to my outer most garment(s), this also included my department issued Axon digital body camera. On this date I was driving marked police patrol car #605, which is also equipped with the Axon digital recording system.

Squad 6120, P.O. Joshua DUMMANN and P.O. Phillip LEWIS also responded to the location.

On scene, P.O. DUMMAN and P.O. LEWIS were detaining a subject who was later identified as Jamar J. BUCKNER (b/m 04-30-86), who was the person involved in the reported incident.

I then contacted the caller and owner of the property identified as Alpha N. PATEL (w/f 01-14-81), who was not on scene. PATEL stated the police were called because BUCKNER was at the location creating a disturbance. PATEL stated that BUCKNER had made threats to one of the employee(s) working at the front desk stating to the employee that he had a weapon, he was going to kill someone, and that he was in possession of lighter fluid and he was going to burn the motel office down to the ground.

PATEL fearing for her safety, the safety of the employee(s) working at the location, and motel guest(s) she called the police. PATEL was able to send me surveillance video on scene, of BUCKNER attempting to gain entry into the office building, and damaging a drawer attached to the office. The person working inside the office was identified as Jose L. BERRERA (w/m 06-21-91). BERRERA is the employee that reported the incident to PATEL prior to the police being called.

Upon watching the video sent to me by PATEL, it was determined a citation would be issued to BUCKNER for disorderly conduct. (J881N2G28M Milwaukee Police Department Citation).

BUCKNER was issued the citation on scene. It was also determined no additional damage to the room where BUCKER was staying occurred. BUCKNER'S stay at the motel was terminated. End of Report.

On Thursday, December 15th, 2022, My partner PO MCINNES and I were dispatched to an injured sick call at 12:00 PM located at 4600 S 27th St #21, which is located in the City and County of Milwaukee.

Upon arrival, I observed that MFD MED 17 and ENG 12 blue shift were both on scene. I spoke with LT Matthew THUNDERCLOUD, who stated that a subject was found unconscious but breathing on the floor. MFD gave the subject 2mg of Narcan and d10 for his low blood sugar. the subject was transported to ST LUKES Hospital by MED 17 for treatment.

I spoke with Oscar BARRERA (W/M 2-3-83), BARRERA works at the motel that the subject was found in. BARRERA stated that the subject was supposed to check out at 11:00 AM and when he did not BARRERA went to his room(#21) to check on him. BARRERA found the subject lying on the floor "snoring". BARRERA then called 911.

BARRERA was cooperative with the investigation and there were no business licenses or of the license of the person working there.

The rooms at the motel do not have working heaters in the rooms and windows are covered with insulation making it so that there is only one point of entry and exit to the rooms. The back door to the rooms leads to a shared hallway but that is locked and only staff has access.

On Thursday, March 09, 2023, at 1:43AM, Squad 6330 (myself and P.O. Ana ROMERO-PEREZ, both in full duty uniforms, equipped with BWCs, and operating a marked MPD squad #574) was dispatched to 4600 S. 27th Street (Red Lotus Inn), in the City and County of Milwaukee, Wisconsin for a Property Damage complaint.

The caller was the owner and agent for the business, Alpa N. PATEL (A/F, 01-14-81), and she was calling about, Anne M. MCDEVITT (W/F, 02-18-57), who had been a guest, and was now trying to kick the door to Room #27 in, due to her belief that her property was still inside. During the investigation, it was learned that MCDEVITT had stayed at the hotel on the 4th, 5th, and 6th and paid for those nights. MCDEVITT also stayed there on the 7th and 8th but was not charged for those nights. MCDEVITT was arguing about wanting a deposit refunded and complaining that she was missing property. I offered a report online form and contact card to MCDEVITT, but she refused it. PATEL gave us the key and we checked Room #27 for the alleged missing property and found nothing.

It should be noted that MCDEVITT appeared highly agitated and M.O.

Upon arrival PO BOUZEK and I made contact with the female suspect who was in the lobby of the motel arguing with an employee behind the counter glass window. The female was identified as WHEELER, Nina Elaine (F/B 10/20/82). A check of WHEELER revealed that she was a convicted felon case# (20017CF004844). WHEELER stated that she was just arguing with hotel staff about receiving a refund for her room because she was checking out of the hotel earlier than she was staying. Per the CAD the caller was in the rear of the hotel hiding. Squad 6340 PO PARKS and PO PEDROZA-BELTRAN stood by with WHEELER while PO BOUZEK, and I interviewed the caller and witnesses who hid in the back of the motel during the incident. Per WHEELER a shot was fired but it was by a male friend of hers who fled the scene. WHEELER denied firing a gun and stated that her male friend took the gun with him when he fled the scene.

The caller identified as, PATEL, Alpha N (A/F 01/14/81) stated that her and family members of hers were cleaning the garage in the back part of the motel when they observed a white suv with a trailer on it near the garage entrance. PATEL stated that they believed the suv was going to be used to get rid of the junk in the garage. PATEL and her relatives walked near the suv and a black female stepped out yelling at them to get away from her stuff. The female then fired a single gunshot into the air and drove her suv to the front of the motel. The female never pointed her firearm at any one or made threats to anyone with the firearm.

I then interviewed PATEL, Dhirajbhai T (A/M 01/06/56) who is visiting from India and was helping clean the garage. PATEL did not speak English and PATEL, Alpha had to translate for him. Per the translation, PATEL D stated that he was helping clean up the garage when he observed a white suv with a trailer on it in the parking lot parked near the garage. A female began yelling from the suv and PATEL D was told to move away from the suv by PATEL A. PATEL D stated that he observed the black female fire a single gunshot into the air and then drive away in the white suv PATEL D had no further information.

I lastly interviewed GALLA, Raghavamsi (A/M 06/30/94) GALLA stated that he was also helping clean the garage when he heard arguing by a female inside the white suv. GALLA stated that he
