redevelopment. The proposed plaza, to be named in honor of noted Milwaukee politician, attorney, jurist and civil rights activist, Vel R. Phillips, will be situated south of Wisconsin Avenue between North Fifth Street and North Vel R. Phillips Avenue, bringing new life to a parcel of land in the heart of Westown that has been underutilized for nearly 30 years.

In closing, I ask that you support the plan for extension of the streetcar. The Hop streetcar is a catalyst to invigorate transit use in the city and a catalyst to increased economic activity, job creation, and growth.

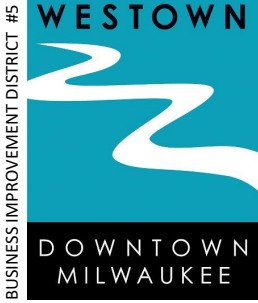
