Due to extenuating circumstance I was not aware of the damage until mid-summer.

I am disabled and since 2010 I was instructed by my doctor to stay off uneven ground which includes grassy areas. In the last 6 years I have had 5 orthopedic surgeries plus a broken leg and broken toe. Starting Jan 2 until March (when I had another surgery) through May until June I was in a cast.

Mid summer my neighbor explained what happened and told me she had complained and it would be repaired.

When they removed the stump and didn't repair it, I called and was told how to go about filing a claim.

I'm guessing they might have noticed damage last fall if there was snow cover. I have lived here 41 years. I am a widowed, single woman.

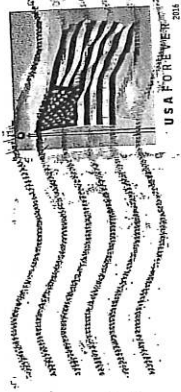

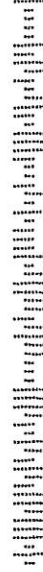
