File #060298 is a resolution authorizing an expenditure from the Development Fund for public transit improvements along Canal Street in the Menomonee Valley, in the 8th and 12th Aldermanic Districts.

Background

1. Public transportation is essential for quality of life and equal access to jobs, health care, and community involvement. No local bus service runs along Canal Street.

Discussion

- 1. Rider fares and property taxes support the Milwaukee County Transit Authority.
- Local businesses and agencies envision creating a new bus route for the Menomonee Valley (Canal Street Bus Route) that loops from the Downtown Transit Terminal, west along W. Wisconsin Avenue, south along N. 6th Street, west along Canal Street to Miller Park Way and back commencing August 21, 2006.
- 3. The route stops at Miller Park, the Harley Davidson Museum, and Summerfest.
- 4. Commencing August 21, 2006, the proposed Canal Street Bus Route will operate:
 - Weekdays from approximately 5:00 AM until 8:00 AM, 2:00 PM until 5:00 PM, and 10:00 PM until 1:00 AM
 - Saturday morning service, or
 - Sunday late-night service to accommodate third work shifts
- 5. The Milwaukee County Transit System (MCTS) will apply for a Federal Job Access Reverse Commute (JARC) program grant to begin a new bus route along Canal Street (versus extending an existing route). The grant requires a local match.
- 6. The 3-year grant term expires in 2008. The estimated total project cost is \$878,300.
 - \$150,300 Fare box revenue (MCTS)
 - \$364,000 JARC grantor (50% of total grant)
 - \$364,000 Local Match (50% of total grant)
 - \$114,000 City of Milwaukee (33% of local over 3 years)
 - \$30,000 MVP BID No. 26* (> 9% of local over 3 years)
 - \$220,000 State of Wisconsin* (58% of local over 3 years)

- 7. Funds to support the new route beyond 2008 are not provided for by this grant.
- 8. No draft agreements or commitment letters from the State of Wisconsin or the Milwaukee County were on file at the time of this writing.

^{*}Contingent upon adoption of 2007 Operating Plan by the Common Council in Oct-Nov 2006 as offset to State of Wisconsin original \$250,000 commitment per Corey Zettes, MVP BID No. 26

- 9. File 060298 authorizes the following:
 - \$114,000 in total from the Development Fund capital account UR03390000
 - DCD to enter into a "Canal Street Bus Route" project agreement with MCTS

Fiscal Impact

Adopting File #060298 authorizes a \$114,000 transfer but not expenditure from the Capital Improvements Development Fund UR03390000 to a sub account. From the \$114,000, annual payments up to \$38,000 will be paid to the MVP BID No. 26 or MCTS.

Other Information

- 1. Milwaukee County Executive Scott Walker, in recent news articles, reported plans to reduce public bus service by eliminating and modifying many existing routes in 2007.
- 2. The Milwaukee County Board of Supervisors may consider adopting a resolution authorizing the filing of this grant application. The County Transportation, Public Works & Transit Committee meets July 12, 2006 and the Board of Supervisors meets July 27, 2006. These agendas are not yet available.
- 3. Daily ridership is estimated at 200.
