This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

 On 08/25/2018 a 17-year-old working in conjunction with the Milwaukee Police and the WI WINS Tobacco Initiative was able to purchase a Grape Swisher Sweet cigar from the clerk at A&R Foods, 400 E. Burleigh St. The clerk did not ask for ID. The clerk admitted the sale stating he was sorry. The applicant was mailed a MARTS enrollment package. As of 12/10/2018 the applicant did not enroll in MARTS and was issued a citation for the original violation.

2. On 02/17/20 Milwaukee Police conducted a license premise check at the location of 400 E. Burleigh St. Upon entering the store immediately officers smelled a strong odor of cigarette smoke. Officers entered the enclosed cash register/officer area and observed a customer smoking, with the agent present. The customer put the cigarette out and left the store. Officers spoke with the agent and a PS-13 notice (Smoking Prohibited Ordnance Warning Notice) was issued to the agent.

- 3. On 11/24/23 at 3:12p.m., Milwaukee Police conducted a License Premise Check at 400 E. Burleigh. This was in regards to complaints received regarding subjects loitering. The manager communicated their frustrations regarding armed subjects loitering and fear of damage to the store if police do not come. The manager expressed interest in working with the police and installing a camera monitoring system.
- 4. On 12/21/23 at 7:39p.m., Milwaukee Police conducted a License Premise Check at 400 E. Burleigh. Officers observed a subject that was not making purchases and assumed the subject to be an employee, however, the subject was uncooperative and agitated and refused to give the officers any information. The clerk stated the subject only "helps" out and was not an employee. Another subject entered the business and was frustrated with officer's presence stating police never come when called and didn't understand why officers were first now conducting a License Premise Check. The officers noted expired meat and the clerk stated they can continue to sell it after expiration, due to it being frozen.
- 5. On 03/06/24 at 2:35p.m., Milwaukee Police were dispatched to a Shooting at 400 E. Burleigh. On arrival officers located the victim, who had a gunshot wound to their shin. The victim stated they were in front of the store meeting someone to purchase a scooter, when a vehicle drove past and a subject fired shots. The officers recovered 5 casings and a parked vehicle with a bullet hole. The clerk was interviewed and stated they didn't see anything. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

This report is being written by PO Stephen COLWELL, assigned to District Five, Early Power Shift, Squad 5266.

On Friday, November 24th, 2023, at approximately 3:12 PM, I conducted a business check of A&R Foods (400 E Burleigh St), located within the City and County of Milwaukee.

I conducted this business check after receiving citizen complaints about multiple subjects loitering outside the location. Upon arriving at the location, I spoke to the manager of the business, who was identified as Alaa R MOSTAFA (W/M, 11/30/1967).

I informed MOSTAFA of the purpose of my visit and he initially appeared to become agitated. MOSTAFA complained that there are numerous subjects who loiter around his store while armed but stated if he contacts police for assistance, the police do not come and subjects will damage his store and threaten him. MOSTAFA reported that after the closing of the corner store located at 200 E Chambers St, more subject had been loitering around his store and he has been unsuccessful when asking them to leave. MOSTAFA stated on more than one occasion, he has had to physically force loiterers out the door when they would not leave.

I advised MOSTAFA of the Fusus camera monitoring system and the benefits of it. MOSTAFA stated he would need to contact the property owner prior to consenting to a Fusus Core being installed.

I advised MOSTAFA I would discuss his complaints with the other members of the Community Partnership Unit and I would be following up with him on a plan to address his complaints. MOSTAFA stated he would do whatever officers advised him to do to correct the issues around the property so long as officers continued to assist him afterwards. MOSTAFA thanked me for allowing him to "vent" about his complaints. I did provide a MOSTAFA my contact information.

This report was written by PO Nora BURLO, assigned to District Five, Late Power Shift. On 12/21/23, I was assigned to Squad 5468 along with my partner PO James TERRELL. On the listed date, at approximately 7:39PM, PO TERRELL and I conducted a Business Check at address 400 E Burleigh St- Burleigh Market, a licensed premise in the City and County of Milwaukee.

Upon entering the listed location, I observed the store to be clean and organized, overall. I observed a B/M subject who appeared to work at the location as he was standing inside of the store, not making a purchase. I attempted to identify him, as an employee at the location. The male subject, was initially uncooperative with me. He was agitated throughout our interaction but ultimately verbally identified himself as **Anthony E REED (B/M, 9/2/79)**. REED repeatedly stated he did not want to talk to me and did not want to answer my questions regarding his employment at the location. He continued to escalate his behavior and began telling me to get his lawyer.

As I attempted to speak with REED, PO TERRELL made contact with the cashier/ clerk at the location, identified as *Mohammad NAZER (W/M, 10/15/80)*. NAZER stated REED does not formally work at the location and only "helps out".

NAZER provided PO TERRELL with the license information for the business:

Food Dealer Retail License #0013868 and Cigarette And Tobacco (#1031787) which will expire on 4/15/2024.

NAZER made statements regarding the frozen meat PO TERRELL observed at the location. NAZER stated frozen meat can continue to be sold even after it's expiration date, due to the meat being frozen.

While inside the store, officers spoke with another subject who entered the business and appeared frustrated with officers' presence. He made several statements that the Milwaukee Police Department does not come around the area when called. He stated officers have never conducted a business check

at the location in the past and does not understand why PO TERRELL and I were there. I repeatedly informed him that PO TERRELL and I have never made contact with the store and wanted to, as we were driving by and realized we hadn't made contact. The unidentified male subject was visibly upset with officers presence and continued making statements that Milwaukee Police officers do not come when needed. He stated that PO TERRELL and I arriving at 7:39 PM was "odd".

PO TERRELL and I ended our contact after providing NAZER with a contact card.

On Wednesday, March 6, 2024, at approximately 2:35 PM P.O. Matthew ROSEN and I responded to 400 E Burleigh St for a Shooting Complaint.

Upon arrival we located the shooting victim identified as Walter L WILLIAMS (M/B 01/04/1984) who had one gunshot wound to his right shin. WILLIAMS stated he was out in front of the store meeting with a person about buying a scooter when he heard gun shots and observed a light blue Hyundai driving north on N Buffum St from E Burleigh St. WILLIAMS stated that he observed a light skin black male with braids in the front passenger seat of the light blue Hyundai.

A gray in color Chevrolet Volt which was parked in front of 400 E Burleigh St. bearing WI Auto of ASJ9692 has one bullet strike to the front passenger door pillar. The owner of the gray Chevrolet Volt identified as Barakat SALAHALDIN (M/W 12/05/1992) was in the store and did not see anything.

There are 5 gold in color fired casings in the street in the 3100 block of N Buffum St. and one bullet fragment in the street in front of 406 E Burleigh St.

Squads on scene included 877, 897, 5141, 5261, 1112, 5215, 5146, 5290, 5195, 9141, 9149, 9147 and 9114. Squad 9146 responded to Froedtert Hospital.

P.O. Kevin ZIMMERMAN spoke with Alaa R MOSTAFA (M/W 11/30/1967) (414)-553-4728 the store owner of A & R Foods who provided him with the video footage of the Victim walking in the store at approximately 2:23 PM. MOSTAFA was cooperative with the investigation.

The hearing before the Licenses Committee will take place on 5/29/2024 at 10:10 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.
