Hello Ald. Jackson,

My name is _____ and I am a resident of the Sherman Park community and I am writing you to express my concerns over the idea of allowing the gas station on the corner of burleigh and Sherman to extend hours, making it a 24 hour establishment.

I am unfortunately highly against the idea of this establishment being 24 hours. Every day, if you drive past the gas station, there is at least someone loitering outside the door. If they are not standing next to the door of the gas station, they are on the side of building facing the Sherman Park. I can only assume, in an unfortunate sense that they are up to ill intentions and have some relation to the drug problem we have in the city. I view the extension of hours at this

establishment only as an opportunity to create more issue less than increasing the revenue that the establishment makes. Not only this, but I fear that the "loitering" would increase throughout the night and increase gun violence as well. With this location right across from the park that not only many children actively use, the boys and girls club is there. The children that attend the boys and girls club are sent there to not be in the streets and to not be influenced by things that can be detrimental to their lives and I fear that they would be a witness to such things that could be life altering. With the park in mind, also driving past often, many children are at the park late hours into the night in the summer and I doubt any adults are present. What happens when something goes wrong at the gas station late night and potential gun fire is exchanged? Do we risk children being injured or even dying from this because they are at the park? Yes, the parents need to be responsible and not have them there so late but what about the ones that do not care? This is a huge risk not only for the community but for the children of our community and I hope you consider my thoughts on this to decline the opportunity.

While we are submitting our thoughts, can the city please do something about the street area of Sherman blvd between Capitol and Roosevelt!? Especially into the summer, people use the road (mainly heading south) as a three lane road and it is not. Some benefit from having a driveway but many do not and they result to parking on the street which is their right, however on multiple occasions, my neighbors vehicles have been damaged because of reckless drivers. It is upsetting that many have to dig into their pockets when they may have none to spare to replace something that was ruined by people who do not respect the roadway. What happened to the road project to cut the road down to two lanes permanently? Inserting the bike path and extra grass?

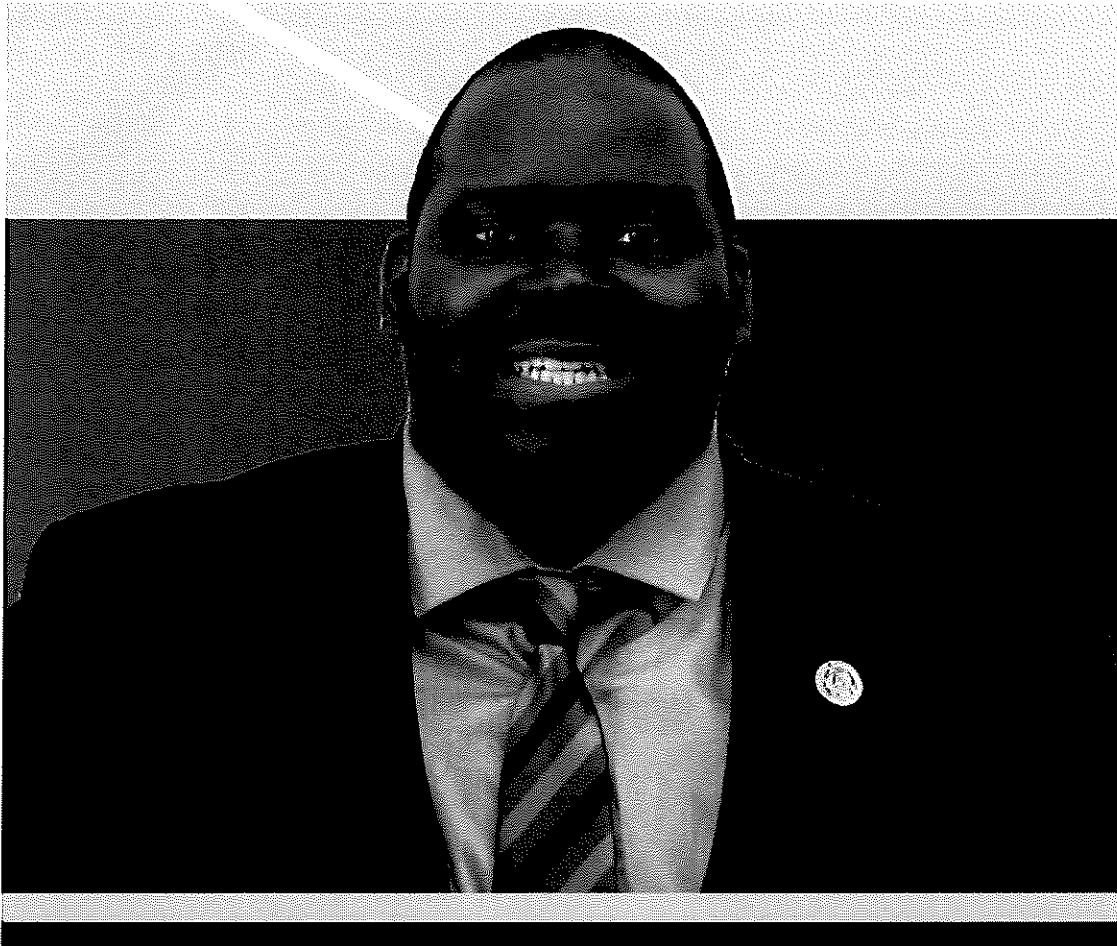

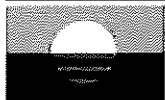
