The Milwaukee Police Department's investigation regarding this application revealed the following:

3. On 06/21/2020 at 9:35pm officers were dispatched to a Trouble with Subject at The Backyard, 2155 s Kinnickinnic Av. The officers observed a male subject on the ground being held down by security. The officer interviewed security who stated the subject slammed down his beer and the bartender wanted him to leave. The subject refused to leave and security escorted him out. A minor physical altercation occurred outside. The subject threw up several times outside and was taken to the hospital for medical treatment.

4. On 07/26/2020 at 10:10pm officers were dispatched to a Noise Nuisance at The Backyard, 2155 S Kinnickinnic Av. The officer spoke with the manager and advised him of the complaint of loud music on the patio. The manager was cooperative and turned down the music.
5. On 08/21/2020 at 12:40am officers were dispatched to a Noise Nuisance at The Backyard, 2155 S Kinnickinnic Av. The officer parked several buildings away and could hear music coming from the patio. The manager stated this volume was the normal level they played the music at. The manager was cooperative and turned down the music.
6. On 09/05/2020 at 1:11am officers were dispatched to a Noise Nuisance at The Backyard, 2155 S Kinnickinnic Av. The officers interviewed a bartender who asked for the name of the caller so she could make amends. The officer advised her to call open records to get that information. The bartender provided the license information and her Class D Operator's license. She then became uncooperative with the officers. She stated she has been working in the bar business for 10 years and knows the noise ordinances. The officers told her the ordinances stated the music could not be heard from over 50 feet away and she stated that information was false.
7. On 09/05/2020 at 8:48pm officers were dispatched to a Noise Nuisance at The Backyard, 2155 S Kinnickinnic Av. The officers did hear loud music coming from The Backyard. The officers spoke with the manager, Douglas GUEHRER, who stated he has done nothing wrong because he has a permit to play music until 11:00pm.
8. On 09/19/2020 at 6:17 officers were dispatched to a Noise Nuisance at The Backyard, 2155 s Kinnickinnic Av. There were three callers that stated they could hear loud music from two blocks away. When the officers arrived they could faintly hear music from 1 block away. The volume at the door was determined to be unreasonable. The officers spoke with the manager, Douglas GUEHRER, who stated he just arrived and agreed the music was too loud. The manager stated he had a meeting with police and was told he had a permit to play music until 12am on weekends. He stated he has changed the hours of the outside patio to conclude at 8pm in order to curb the noise complaints. The officers could not reach the callers to be complainants.

This report was written by P.O. Justin MARZELLO, assigned to District 6, Early Shift.

On Saturday, September 19, 2020 my partner (P.O. JOHNSON) and I were dispatched to 2155 S Kinnickinnic Ave. for a noise complaint. The CAD had three different callers complaining that the "The Backyard Bar" was playing music outside so loud it could be heard from two blocks away and the bass was rattling one of the caller's walls.

When we arrived on scene at approximately 7:30 p.m. we could hear the from approximately one block away and it was pretty faint. We observed the volume level from two different locations, both from approximately one block away. As we approached the bar, the volume increased and as we were outside the front door, the volume was unreasonable in our opinion.

We spoke with the bar's manager, Douglas GUEHRER, who stated that he had just arrived to the location at 7:00 p.m. and agreed that the volume was too loud. GUEHRER stated that he did just have a meeting with CLO officer's (P.O. WARD and P.O. GARCIA) and was told that as long as he had his outdoor event permit that he was allowed to play music on the weekends until 12 a.m. I verified that he had his permit and I spoke with P.O. WARD regarding the meeting. GUEHRER did agree to turn the volume down and he stated that he has adjusted his hours of operation for the outdoor patio to conclude at 8:00 p.m. in order to curb the noise complaints he has been receiving.

Upon callback to each of the callers, I was unable to reach two of them. Voicemail messages were left of these callers. I was able to speak with Tim GOKHMAN (ph#414-349-2248) who is a property owner for a property across the street to The Backyard Bar. GOKHMAN was calling a behalf of his tenants, one of which was one of the other callers. GOKHMAN was advised the the premise does have the proper permits to be playing music and was actively taking steps to work with its neighbors. GOKHMAN insisted that the premise be issued a citation. I advised GOKHMAN that his tenants would have to return my call and be willing to be a complainant, since he was not affected by the noise he could not be a complainant.

P.O. WARD agreed to follow up with this matter.

This report was written by **Police Officer Emily MARKERT**, assigned to District Six, Late Power Shift.

On this day, I was assigned to **Squad 6450**. I was dressed in full Milwaukee Police uniform and AXON body camera, and operating in a fully marked, black and white, Milwaukee Police Department squad, vehicle 537, which is equipped with a MDVR system. This system records audio and video evidence which do not pertain to this incident.

On **Sunday, June 21, 2020** at approximately **9:35PM**, Squad 6450 and Squad 6250 (PO SIDA) were dispatched to the address **2155 S Kinnickinnic Av (The Backyard)** which is in the City and County of Milwaukee, in the State of Wisconsin, to investigate a **Trouble with Subject complaint**.

On scene, I was flagged down by a citizen in front of The Backyard. When I approached, I observed a black male wearing a black t-shirt straddling a Hispanic male who was laying on the ground on his back. The black male immediately identified himself as a Bouncer at The Backyard (**Maurice D GROSS B/M, 03-17-1991**). I also observed he had the Hispanic male's arms pinned down to the ground. The Hispanic male was later identified by California DL as **Luis E BALDERAS (M/W, 12-05-1995)**.

I then told GROSS he could get off of BALDERAS as I waited for Squad 6250 to arrive. GROSS stated to me BALDERAS had been inside the bar drinking when he slammed his beer down at the counter. GROSS stated that the bartender wanted the subject removed so GROSS approached him and asked him nicely to leave, pointing him towards the door. BALDERAS stated he didn't have to leave and began walking the opposite direction in which GROSS stepped in his way and began to direct him outside. GROSS stated that BALDERAS resisted his request for him to leave and a minor physical altercation occurred right in front of The Backyard.

GROSS was very cooperative with police and very respectful towards BALDERAS even after the altercation had ended, offering him water many times.

Upon Squad 6250's arrival, it was determined medical attention was needed for BALDERAS as he puked several times while sitting at the picnic table. Bell Ambulance 421 arrived on scene and conveyed BALDERAS to St Lukes Hospital regarding his incapacitation from alcohol.

Matthew PAGELSDORF) in full duty uniform, equipped with Axon Flex 2 body worn cameras and operating a marked MPD squad car equipped with squad cameras, responded to a noise nuisance complaint that occurred at 2155 S. Kinnickinnic Ave located in the City and County of Milwaukee, Wisconsin. This location is a licensed premise operating under the name of "The Backyard Bar."

During the investigation I interviewed Jaclyn M. O'BRIEN (w/f, 05-12-90).

I informed O'BRIEN that I was dispatched to a noise complaint at this location regarding the music at the establishment. Initially, O'BRIEN was cooperative and at her request was told to contact open records as O'BRIEN wanted to make amends with the caller of the noise complaints and discuss ways to remedy the noise issues. O'BRIEN provided license information for the bar, her class D bartender license and the class D bartender license for Luke A. KOLANCHECK (w/m, 04-03-79). O'BRIEN refused to provide any information for the third person bartending at the establishment who I later identified as Jennie M. MERRIFIELD (w/f, 11-17-88) after speaking directly to her and requesting her information. Initially, O'BRIEN stated that MERRIFIELD had a class D bartender license and when O'BRIEN could not locate a license she then refused to identify MERRIFIELD and also stated that she did not possess a license. O'BRIEN not only refused to identify an individual serving alcohol, but also used profanity frequently throughout the investigation. O'BRIEN stated she has worked at bars for 10 years and is fully aware of the noise ordinances and the decibel limitations. When O'BRIEN was informed that the ordinance also has a subsection regarding noise that can be heard more than 50 feet from the premise, she claimed that information was false. O'BRIEN also stated that she knows from her 10 years of experience that there has never been any type of manager license for a bar and stated that a class B manager license is "made up and fake."

I interviewed MERRIFEILD who willingly provided her information and stated that she does not have a class D bartender license and was working under O'BRIEN and KOLANCHECK.



### **10 Point Plan to Mitigate Sound at The Backyard Neighborhood Pub**

After meeting with Chris Lehmann, Audio Engineer/Sound Specialist, and discussing the current issue we are having, these are some solutions we have come up with to address our noise issue. We have decided to hire Lehmann Audio Productions to come up with and execute the mitigation plan. Following points are concepts that will be used in our plan.

1. Relocate bands to not face the street and project noise out toward the back of the patio.
2. Build roof structure over performance area to dampen sound and redirect it downward to keep sound in patio area.
3. Redirect all patio speakers to face downward and away from the street to keep noise contained in the patio. (Our goal is to eliminate the low-end noise aka bass.)
4. Eliminate Monitor speaker system for bands and move to an ear bud monitor system.
5. Add additional smaller speakers through out the patio. This will spread out the sound, ultimately reducing the overall volume on the main band speakers and resulting in overall decibel output.
6. Soundproof structure walls to eliminate bounce back noise and dampen sound waves.
7. All DJ will perform inside.
8. Monitor/Sound Checks during all shows – Perform music starts we assess the noise across the street and will make sure that the noise level is not at a level that would cause nuisance to the neighbors.
9. Outside Bands will be book as daytime events
10. Notify neighborhood in advance of any live outdoor event.

We take these noise complaints very seriously. We have always considered us apart of the fabric of the neighborhood and genuinely want to be good neighbors to everyone. I am confident we can solve/address any issue we have had in the past. We want to show our commitment to our neighborhood and be given the opportunity to execute this plan to perfection. Thank you.
