This report is written by Police Service Specialist Ronald Kaye, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

Frank Dobert is the Class B Tavern Licensee at Chaser's Pub, 2155 S Kinnickinnic Ave.

1. On Wednesday, 4-19-97, at about 10:25PM, Officers were sent to check for an unlicensed bartender at Chaser's Pub, located at 2155 So Kinnickinnic Avenue. Upon their arrival officers found Eugene F Timm tending bar without a Class D Bartender license, and he was not supervised by a licensed person.
