Attached you will find the financial summary for Brew City dating back to 2019. One report is for Kohn and the other is DPW. The collection rate for Kohn is 12%. I spoke with Kohn and they said they did not discount or negotiate any fees. Kohn also just informed me that Brew City's attorney just reached out to coordinate payment on their remaining balance. It is allegedly being paid this afternoon. As I mentioned, the April bill for \$2,550, which is owed to the DPW is not due until Sept. 11. The reason is we have a 90 day reconciliation period with the tow companies.
