



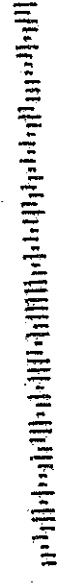

Dear Mr. McClain:

The City of Milwaukee is in receipt of your claim for vehicle damages, allegedly resulting from being struck by a City snowplow while it was parked at 3160 North 28th Street on January 16, 2024.

Our investigation into this matter revealed that the City of Milwaukee did not have snow plows in operation on the above-referenced time and date. There were City salt trucks working in the area, however, the City has no record or knowledge of one striking a vehicle at this location.

There is no evidence that the City of Milwaukee is liable for damages in this case. Therefore, we are denying your claim. If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
