On Tuesday, July 21, 2020, at approximately 11:46 PM, members of Milwaukee tactical Unit executed a search warrant at the address of 1226-1228 W National Ave, which is in the City and County of Milwaukee, WI.

Officers located Ruben C Coyolt-Albanil (H/M 6-8-85) in the upstairs living area, Ruben was the sole occupant of 1226-1228 W National Ave. Once the residence was cleared officer began to search. Officers located the following: 2 bags of suspected cocaine floating in the toilet, one bag of suspected cocaine located in the living room on the coffee table, a Taurus handgun 9mm (serial # TKM60849)located on the bed in the bedroom, box of clear plastic sandwich bags, digital scale bag of suspected marijuana and small spoon all located in kitchen cabinet, blender with white powder residue located inside location kitchen cabinet and multiple identifiers for Ruben C Coyolt-Albanil with the address of 1226 W National Ave.

Ruben was arrested and later conveyed to district 4 for processing.

The property which was recovered was conveyed to district 4 for processing. While at District 4 P.O. Krenzien tested the suspected cocaine and marijuana, using a NARK II pouch 7 and Pouch 5 field test kit. The Nark II pouch 7 field test kit revealed a positive result for the presence of cocaine total weight 1.21 grams. The Nark II pouch 5 field test revealed a positive result for the presence of THC with a weight of 3.52. The packaging, scales, weights and firearms were all indicative of street level distribution. The residence was used to package store and protect controlled substances.

The actual bar was searched and did not contain anything of evidentuary value

On Tuesday March 2nd, 2021 at approximately 1:40 AM my partner PO SPITZER and I assisted Squad 2323 (PO FREY & PO POWELL) investigate a sexual assault complaint at the location of 1226 W. National Ave (Exclusive Life Lounge). Upon arrival PO POWELL spoke to the caller who identified herself as Stephanie AM GARZA (W/F, 10/12/89), who stated she is a employee (bartender) of Exclusive Lifestyle but was off on the night of the incident and was at the tavern drinking with her boyfriend who was later identified as Angel SALDANA (W/F, 11/11/79).

GARZA stated she was walking to the back of the bar when a patron who was later identified as Guillermo CONSECO (W/M, 07/23/74) touched her breast. GARZA stated she told her boyfriend SALDANA of the incident. SALDANA confronted CONSECO. During the confrontation SALDANA punched CONSECO on the mouth and the owner of Exclusive Lifestyle who was identified as Ruben ALBANIL-COYOLT (W/M, 06/08/85), got in between CONSECO and SALDANA and asked them to stop fighting.

GARZA called police and waited on scene for police. The "owner" ALBANIL-COYOLT didn't call police but was cooperative with police and allowed Police to view surveillance footage of the incident.

Lobserved no other violations.

CONSECO was taken into custody and conveyed to District Two for processing.

The hearing before the Licenses Committee will take place virtually on 7/13/2021 at 2:20 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
