There is a possibility that your application may be denied for one to more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

2. On 01/15/23 at 1:03a.m., Milwaukee Police were dispatched to a Shots Fired at 3535 W. Villard Av. An anonymous caller stated there was fight at the location and shots were fired. Officers did not recover any casings.

was in the tavern with a firearm.

3. On 03/12/23 at 12:17a.m., Milwaukee Police were dispatched to a Subject with Gun at 3535 W. Villard Av. Prior to arrival officers were advised there were underage people drinking at the tavern, 20-30 people fighting, as well as subject's with guns. On arrival officers observed vehicles blocking the entrance to the parking lot, preventing anyone from leaving or coming. The officers interviewed the security guard, who stated no one was fighting and they are checking everyone's Id's prior to entrance. The officers also interviewed the manager on duty, who stated an artist "Big Frank" was performing, and that is why it was so crowded. The manager stated they had a total of 6 employees working. The officers attempted to contact the caller, however, did not receive an answer.

- 4. On 04/07/23 at 9:39a.m., Milwaukee Police were dispatched to a Battery at 3535 W. Villard Av. Prior to arrival officers were advised that a subject just choked the caller. On arrival officers did not observe anyone outside the location and attempted to call the caller, however, received no answer. The front door to the business was locked and officers knocked on the door but did not receive an answer.
- 5. On 05/27/23 at 4:11a.m., Milwaukee Police were dispatched to a Shooting at N. 37th St., and W. Villard Av. Investigation revealed there was an after-set in the upper unit of 3535 W. Villard, shots were fired outside and one subject was struck. The bar was closed during the time of the investigation.
- 6. On 06/25/23 at 1:09a.m., Milwaukee Police were dispatched to a Shots Fired at 3535 W. Villard. On arrival officers checked the area and did not observe any casings or evidence of any buildings or vehicles that may have been damaged by gunfire. The officer did not contact anyone at the business.
- 7. On 07/09/23 at 12:49a.m., Milwaukee Police were dispatched to a Shots Fired at 3535 W. Villard Av. The caller stated they heard multiple shots fired; people screaming and vehicles screeching away. Responding officers in the area also heard shots fired and recovered multiple casings in the parking lot. The officers were unable to locate the owner or employees to interview or view video surveillance.
- 8. On 07/18/23 at 11:11p.m., Milwaukee Police were dispatched to a Shots Fired at 3535 W. Villard Av. Prior to arrival officers were advised the caller heard 5-6 gunshots and heard a vehicle pull off fast near the bar. On arrival officers did not locate any casings, nor did they observe any structures or vehicles that were damaged by gunfire. The caller was anonymous and there was no phone number associated with the complaint.
- 9. On 08/21/23 at 12:28a.m., Milwaukee Police were dispatched to an Underage Tavern Violation at 3535 W. Villard. The caller provided a description of the minor and stated they were drinking alcoholic beverages inside. The officers interviewed the manager, who allowed officers entry to check for any violations. The officers did not observe anyone matching the description, nor did they observe anyone that appeared to be underage.
- 10. On 08/27/23 at 12:37a.m., Milwaukee Police were dispatched to a Shots Fired at 3535 W. Villard Av. Prior to arrival officers were advised numerous callers were calling regarding hearing shots being fired; a lot of juveniles outside, people screaming and vehicle's speeding off. On arrival officers interviewed a security guard who stated the business was closed at the time of the incident, however, did state they observed occupants from two different vehicle's firing shots into the air. The responding officer's body camera was later viewed and several people were observed on the steps to the bar, as well as citizens enter and exit the "closed" bar. The body cam further revealed an officer on scene make the statement "there's a bunch of kids out here, they do not ID them". No one from the bar contacted the police regarding the incident.
- 11. On 09/17/23 at 3:42a.m., Milwaukee Police were dispatched to a Battery at 3535 W. Villard Av. The caller stated they were assaulted by another subject outside of the bar, after confronting them inside the bar. The caller stated they did not know the subject's name and the battery call was pended. The caller later called and provided the subject's name and stated they lived upstairs from the bar and the bar frequently serves alcohol to minors.

- 12.On 11/11/23 at 11:26p.m., Milwaukee Police were dispatched to a Shots Fired at 3535 W. Villard Av., that was related to an Armed Robbery/Carjacking at 3424 W. Villard. On arrival officers interviewed the armed security guard from the bar, who stated they observed a vehicle in the parking lot, near another vehicle. As the security officer approached the vehicle, subject's in the occupied vehicle fired shots at him. The security officer stated they then returned fire, causing the driver to crash into the security guard's vehicle. The subjects then fled the scene. The officers were unable to view video surveillance of the incident as the doors to the business were locked by an unknown person, while officers were investigating and the security guard did not have access to the surveillance system.
- 13. On 11/12/23 at 3:08p.m., Milwaukee Police were dispatched to a Shooting at 3535 W. Villard Ave. On arrival officers interviewed the caller who stated she and a friend went to the bar to confront an ex-boyfriend about a new girlfriend. An argument began to escalate outside the bar, when two subjects exited the bar with guns and multiple shots were fired. The caller stated their friend stated they were shot; however, the caller did not see any blood and their friend left in a vehicle, assumingly to a hospital. At the time of the investigation no one reported being shot to the police, nor was anyone admitted to the hospital for a gun shot wound. The officers obtained video surveillance from a nearby business and observed the argument and a patron exit the bar with a long gun, however, it was difficult to ascertain from the video if anyone fired shots. One casing was recovered on scene.

On Sunday, January 15, 2023, at approximately 1:03 A.M, Squad 4474 Officer Peter JERVING and James NOWAK responded to 3535 W Villard Ave which is located in the City and County of Milwaukee for a shots fired complaint.

The caller who was anonymous, stated she heard several shots fired. The caller then stated there was a fight at the location and the shots were fired, however the caller did not see who fired the shots and did not hear anything else. The number the caller used is 414-759-5013. Two additional squads responded to assist.

Based on the CAD report there were no casings recovered on scene. It is unknown if any video surveillance footage was viewed by the responding officers. There was no citation issued on the night this incident was reported. It is unknown if the operators of the establishment were cooperative with responding officers. A check was done but no body camera footage was located at the time of the check. It is unknown if the establishment had armed or unarmed security present.

(Squad 7352) and PO Charles WORTHINGTON and PO Blake LAUFENBERG (7369) were dispatched to
3535 W Villard Ave for a "Subject with Gun" call for service.

Cad Information

Prior to arrival PO LAUFENBERG read the cad, which stated the following....

Caller who was named Takiesha JONES stated at approximately 12:03am on March 12, 2023 " both of her listed daughters are at the bar drinking alcohol. JONES stated, " she warned the bar about letting her minor daughter in the bar. JONES stated, " she is currently outside the bar in listed vehicle.

vehicle #1 is described as a blue, 2010, Toyota Camry

Suspect #1 Black, Female, 20 of age 01/03/2003, Jalaya JONES

Suspect #2 Black, Female, 15 years of age 01/03/2008, Javeah JONES

Caller TAKEISHA stated, "there are underage children in the bar and that included the caller TAKIESHA". TAKIESHA stated, "there were four black males who entered the location with guns in their hands".

Another unknown caller#2 stated, "subject with guns got out of the listed vehicle". Unknown caller #2 stated, "there are 20-30 people fighting in the street right now. The unknown caller #2 gave vehicle description of white jeep bearing plate of AAJ-1011.

Unknown caller #3 stated the street is blocked off on Villard by listed vehicle. The unknown caller #3 stated they moved further way and can't see anything".

Upon arrival, I observed by body camera that PO WORTHINGTON and PO LAUFENBERG traveled westbound in the alley from North 35th Street. The alley that is south of W Villard Street. They walked through the parking lot that was to the east of Uptown Bar and Grill. I observed several vehicles parked in the parking lot. I also observed more vehicles blocking the entry preventing anyone from coming or leaving from the parking lot. PO WORTHINGTON and PO LAUFENBERG walked west on Villard past the Uptown Bar and GRILL. I observed several vehicles parked on the north and southside of Villard. I observed several people coming and leaving the Uptown bar and Grill Tavern.

Interview of the unknown Security Guard of Uptown Bar and Grill

PO WORTHINGTON spoke with a security guard of Uptown Bar and Grill who stated she has not seen anyone fighting outside of the Uptown Bar and GRILL Tavern. The unknown security guard stated that she has been "carding" anyone who wants to come inside of the Bar and Grill. PO WORTHINGTON let the unknown security know that reason why they were on scene was because a caller stated that Uptown bar and Grill had underage customers inside of their Tavern on March 12, 2023. PO WORTHINGTON ask if the unknown security guard could bring out the manager on duty.

Interview of manager Jeanice TYLER-BELL B/F (07/02/1991) of Uptown Bar and Grill

While PO WORTHINGON, PO LAUFENBERG, PO BENNETT and HARRIS were waiting on the manager they observed approximately thirteen people exit out of the bar. Shortly after manager Jeanice TYLER-BELL B/F (07/02/1991) exited the building and let the officers on scene know that everyone who comes inside of the Bar and Grill is required to show their state identification. The manager TYLER-BELL stated that they had a local artist "Big Frank" performing that is why the Uptown Bar and Grill was so crowded. TYLER-BELL stated that she currently had a total of six employees working at the Tavern.

None of the officers that were on scene went inside the Uptown Bar and Grill.

PO WORTHINGTON tried calling all of the caller's back, but none of the callers answered when PO WORTHINGTON called them via the telephone.

Upon arrival, PO AVILES and PO BLANCO stated they observed several people standing outside who were on the north and south side of the 3500 block of West Villard. PO AVILES and PO BLANCO observed some of the people leaving the area. PO BLANCO spoke with an unknown citizen who stated that there were several gun shots coming from the intersection of North 35th Street and W Villard Ave and the intersection of North 36 Street and West Villard Ave. The unknown citizen stated that he did not see who was shooting, but only observed several people fleeing on foot from the area.

The security guard stated that he observed an unknown passenger who was standing outside of the vehicle, fire two gunshots in the air. The security guard stated that he also observed a new model sporty sedan car that was black or possibly

Based on the callers' information obtained from the telecommunicator, the tavern did not contact the police to report the incident.

None of the Officers on scene went inside of the Upton Bar and Grill Tavern. When looking at the squad cameras, I observed two cameras located on the northside of the building.

It should also be mentioned that that PO D'Andrea JOHNSON (squad 7340) stated while she was on scene "there's a bunch of kids out here, they do not ID them," but officers did not verify any ages.

Multiple casings were found on the sidewalk in front of Versace Nightclub, in the parking lot, and in the alley south of the parking lot. Multiple vehicles were struck by gunfire. No other witnesses on scene.

The security guard was cooperative with the investigation. The business had 1 security officer (SINGLETON) on scene. They were armed. Officers were unable to review video surveillance footage. The doors to the business were then locked by an unknown person while officers were still on scene and no one was able to enter the premise anymore. The security guard stated he does not have access to nor knows how to retrieve video footage.

INTERVIEW OF TEAISHA ROSS (CALLER)

Upon arrival we met the caller/victim identified verbally as Teaisha ROSS (B/F 01/05/99) BOFI# 549028, who stated she and another female not on scene at the time of our arrival identified to us by ROSS as Latresa JOYNER (B/F 40 YOA) was at the BOSTON TAVERN located at 3535 W VILLARD AVE to confront their ex-boyfriend identified as Lucas L BROWN (B/M 04/07/86) about his current girlfriend identified as Breshonna WARE (B/F UNKNOWN AGE).

ROSS stated BROWN came out of the BAR to talk with her and JOYNER, ROSS stated the discussion went from talking to arguing and she observed a female (WARE) and unknown male come out of the BAR with guns and soon after heard multiple shots fired.

ROSS stated once the shooting stopped, she observed JOYNER holding her stomach and heard JOYNER say she was shot. ROSS stated she observed JOYNER holding her stomach but didn't see any blood. ROSS stated JOYNER then got into a Black vehicle appeared to be an ACURA and fled the scene which she believed JOYNER was going straight to the hospital.

ROSS stated she observed a small black handgun in WARE's hands before the shots were fired.

ROSS stated everyone on scene got into multiple vehicles and fled the scene in unknown directions, then shortly after police arrived on scene.

At the time of this incident no one has reported being shot and no one has been admitted to the hospital for a GSW. The incident was filed as a shots fired incident since a victim was never found.

On scene I located one casing on the side of the building next to the bar, 3535 w Villard Ave. a 9MM LUGER casing, which was placed on inventory as evidence. 23035839.

INTERVIEW OF LUCAS BROWN

I interviewed BROWN, Lucas L (B/M·04/07/86) who stated ROSS and JOYNER came to the BAR to argue with WARE, BROWN stated he attempted to break it up, but he is handicap. BROWN stated while everyone was arguing he went to the side of the building trying to leave and he then heard shots fired he didn't see anyone shooting a firearm but stated WARE is known to have a gun. BROWN stated since the incident he has not spoken with WARE and JOYNER but he called her phone, and he stated her son picked up and stated his mom went to the hospital. BROWN stated no one answered her phone for him again.

SCENE OBSERVATION AND SURVEILLANCE FOOTAGE

P.M. I observed on surveillance video at the Liquor next to the bar SUNSHINE LIQUOR at approximately 3:00

P.M. I observed ROSS arguing with multiple people and then a scuffle occurs, and multiple people run from the bar (UPTOWN BAR AND GRILL). I observed one black male with a long gun holding it to the side of his waist. Then everyone leaves the scene. From the video it is hard to see anyone shooting a gun and I didn't see any that appeared to be shot from a gun.
