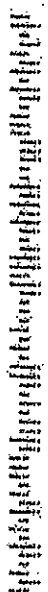

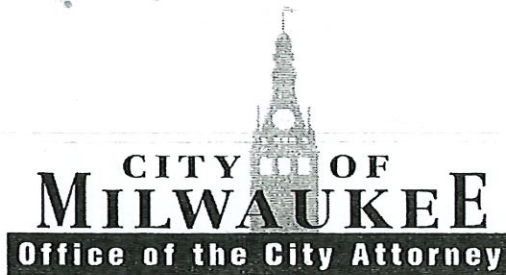


Dear Mr. Kawczynski:


We are in receipt of your claim for \$150.00, regarding damages to your garage you claim were sustained when a garbage truck hit your garage at 5836 South Madeline Avenue.

Our investigation reveals that the Fleet Services Division completed a search of their records and found no calls regarding any complaints for this address, and no damage reports filed by the sanitation crews.

The City is unable to substantiate damages in this case, and therefore cannot accept liability. As such, we are denying your claim. 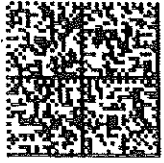
